# IMPORTANT POINTS FOR ADMISSION

(As Per DU Admission Bulletin 2019-20)

Undergraduate courses are offered by the University through its affiliated colleges in various streams of studies under different faculties namely Arts, Commerce and Business Studies, Mathematical Sciences, Sciences, Applied Sciences etc. **The merit-based admission is based on marks scored in Class XII Board/qualifying examinations.**

- Marks of **Best Four** subjects are to be calculated for admission in courses under the **Faculties of Arts, Commerce, Mathematical Sciences, and Humanities**. A maximum of two language subjects may be allowed for the calculation of marks for “**Best Four**” Combination for admission in courses under the **Faculty of Arts/Social Sciences**.
- Marks of **Best Three** subjects are to be calculated for admission in courses under the **Faculties of Sciences and Applied Sciences**.
- The applicant must be a citizen of India. (Applicants seeking **admission under Foreign Students’ category need to apply separately** on Foreign Students’ Registry website, <http://fsr.du.ac.in>.)
- The applicant should have passed the Class XII examination of any Board/ University examination in India or in any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- As per Ordinance-I of the University, **there is no minimum age bar for admission to the under-graduate** and postgraduate courses in the University and its colleges except in the courses where the respective regulatory bodies, such as MCI, AICTE, BCI, NCTE, DCI etc. have prescribed the minimum age requirement in their regulations.
- The applicant should have passed individually in each subject required (including practical, if any) for calculating merit and eligibility to the course they seek admission in. **Applicants with “compartment” results are not eligible to apply.**
- **Applicants with gap year(s) will not be at any disadvantage for the purpose of admission to undergraduate courses.**
- Applicants under the UR/SC/ST/OBC/EWS categories are eligible to seek admission based on merit to courses in all Colleges (except Minority Colleges, wherein some categories may not be applicable).
- The following categories are designated “**supernumerary**”:
  - i. PwD (Persons with Disabilities);
  - ii. CW (Children/Widows of Personnel of the Armed Forces including Para-Military);
  - iii. KM (Kashmiri Migrants);
  - iv. ECA (Extra-Curricular Activities);
  - v. Sports Categories;
  - vi. Prime Minister's special scholarship for Jammu and Kashmir;
  - vii. SS (Nominated Sikkimese Students);
  - viii. WQ (Ward Quota)

Above categories are applicable to courses where admission is based on merit.



# IMPORTANT POINTS FOR ADMISSION

(As Per DU Admission Bulletin 2019-20)

- To determine their eligibility and merit, applicants from the SC/ST categories shall be given a relaxation to the extent of 5% in the respective eligibility criteria and merit for admission prescribed for applicants from the UR category. If, after giving 5% relaxation, these reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill all the reserved seats in the course concerned. Eligibility in such cases is pass percentage.
- To determine the eligibility and merit, applicants from the OBC category shall be given a relaxation in the respective eligibility in the qualifying examination to the extent of 10% of the eligibility marks prescribed for applicants from the UR Category. For example, if the minimum eligibility for admission to a course is 50% for the UR Category applicants, the minimum eligibility for the OBC category will be 45% (i.e. 50% minus 10% of 50%).
- Applicants from the PwD category shall be given a relaxation in the respective eligibility for the course concerned in the qualifying examination to the extent of 5%.
- Applicants from the CW category shall be given a relaxation of 5% in the respective eligibility for the course concerned in the qualifying examination.
- Eligibility Criteria for merit-based admissions under the EWS category shall be identical to that of UR category.

## Special Instructions for Boards other than CBSE

- If a paper's title does not match with what is specified in List A and List B (given below), it is mandatory for the applicant to provide a content equivalence certificate from the Principal/Head of the Institution last attended, certifying that the paper's content is equivalent to NCERT Class XII syllabus for that paper. This equivalence certificate must be accompanied by a copy of the syllabus of the paper attested by the Principal/Head of the Institution. However, the University of Delhi's decision on the matter will be final and binding.
- Applicants should have passed theory and practical separately. Any paper with both theory and practical component will be considered only in the ratio **70 (theory): 30 (practical)**. If the theory component of the paper is less than 70%, the applicant should separately fill into the online Admission Form the marks obtained and maximum marks for theory and practical each, and the total, as per their mark-sheet. In case the **theory/practical breakup is not specified**, the applicant will be required to enter 0 (zero) in the concerned theory/practical fields, and enter only the total in the online Admission Form.
- Internal Assessment marks mentioned in the mark-sheet will not be used for any calculations.
- Any discrepancy in the entry of marks pertaining to theory, practical or total will be the sole responsibility of the applicant. Your application form may be summarily rejected.

- The University may define any other relevant subjects as academic/elective for a particular course.
- In case an applicant has studied elective and core languages, the core/elective language subject will be treated as language, while elective language can be considered as academic/elective subject.
- For the calculation of Best Four subjects percentage for Arts/Humanities honours courses, if the applicant includes subjects other than those given in Lists A and B, then a deduction of 2.5% of maximum marks will be levied for each such subject for the purpose of calculating 'Best Four'.
- #Out of three academic/elective subjects chosen above, one must be the concerned subject in which the admission is sought, failing which a deduction of 2.5% will be imposed on the calculated 'Best Four' percentage.

# ADMISSION PROCEDURE

## Merit-based Admission Procedure for Undergraduate Courses

**Step 1:** The applicant proceeds to the respective college for admission with a **print out of the form** from the admissions portal, and the required **supporting original documents along with their photocopies, and 3 recent passport size photographs**

### List of Documents required at the time of Admission

The applicants shall be required to produce the **following documents in original with two sets of self-attested photocopies at the time of admission:**

- **Class X Certificate (Mark-sheet or certificate) indicating date of birth and Parents' names** (The names of applicants claiming reservation under SC/ST/OBC/EWS/CW/KM must match with the names that appear on the corresponding reservation certificates; similarly their parents' names must match in both sets of certificates).
- **Class XII Mark-Sheet.**
- **SC/ST/OBC/EWS/CW/KM Certificate (in the name of the Applicant) issued by the competent authority.** (The names of applicants claiming reservation under SC/ST/OBC/EWS/CW/KM must match with the names that appear on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates).
- **OBC (Non-Creamy Layer) Certificate (in the name of the Applicant) issued by the competent authority, and wherein the caste is in the OBC central list issued by <http://ncbc.nic.in>.** (The name of the applicant claiming reservation under OBC (Non-Creamy Layer) must match with the applicant's name as it appears on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates).
- **EWS Certificate from competent authority certifying the applicant can claim reservation under this category.** (The names of applicants claiming reservation under this category must match with the names that appear on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates).

**Step 2:** The applicant presents the documents in the college and produces their originals for verification, after which the Principal of the college approves the admission. In case all documents cannot be verified online, the College will give provisional admission. Admitted provisional students have to produce the originals of the required mandatory documents to the College within a week after the last day of UG Admissions for forensic verification, failing which the admission of the said provisional student may be cancelled by the College.

**Step 3:** On Verification and acceptance of the documents in the college, the applicant will receive a link on their online portal to pay the fee, which **can only be paid online through the portal**. The applicant is advised to **pay the fee without delay within 24 hrs** after the approval of admission by the Head of Institution and **save the acknowledgement slip** bearing transaction ID, Credit Card/ Debit card/ Net banking details and date of transaction as a proof for future reference. On successful payment of fees, the applicant is granted provisional admission to the said college.

## Cancellation and Re-Admission (for more details, please see page 40)

1. A cancellation fee of Rs. 1,000/- is deducted from the applicant's Wallet for every cancellation before the last day of Admissions, and reflects in their Admissions Dashboard each time the applicant cancels their admission.
2. The fees to be paid to colleges in subsequent upgradations/ readmissions will be adjusted against the amount in the Wallet. The applicant will need to pay fees hereon only if subsequent college fees are higher than the fees paid at the first college. If the fee in the latter college is less, the balance will be refunded to the applicant's account or to an account declared by the applicant as per the College/University rules after the admissions are Closed.
3. All adjustments will be reflected in the Wallet feature.
4. Refund of fees due to cancellation or any other reasons WILL NOT BE DONE AFTER THE LAST DAY OF UNDERGRADUATE ADMISSIONS, 2019-20.
5. Only one cancellation is allowed per Cut-off List. The number of cancellations will be restricted to **(n-1)**, where n is the total number of Cut-off Lists.

### IMPORTANT

**(a) There will not be any —first come first serve policy. Late arrivals outside of the prescribed duration of each cut-off will not be entertained. Eligible Applicants of the (n-1)<sup>th</sup> Cut-Off List, if any, shall be entertained for admissions only in the last hour of the third day of current n<sup>th</sup> Cut-Off subject to the availability of vacant seats.**

**(b) The University will accept self-attested copies of documents / papers provided by the applicants. The uploaded documents will need to be presented in the colleges at the time of admission, for online and/or forensic verification. If any false attestation / falsified records are detected, the applicant will be debarred from attending any course in the University / or its colleges for next five years and in addition, a criminal case under relevant sections of IPC (viz. 470, 471, 474 etc.) may be initiated.**

#### **Note:**

- As per the decision of the University of Delhi, the College shall charge an additional amount of Rs. 14,200/- per year from every foreign student (except Tibetan students) seeking admission in all courses except B.Sc.(H) Computer Science for which the charge from all countries (other than SAARC nationals & Tibetan Students) will be Rs. 1,60,000/-.
- Students of all Honours Courses including BMS opting Generic Paper having practical for Semester-I and/or Semester-II will have to deposit an additional amount of Rs. 200/- as and when demanded by the college.

**Candidates, whose admission is approved by the college on the online portal of the University, will be required to deposit fees online on the Portal itself.**

# RESERVATION OF SEATS

(As Per DU Admission Bulletin 2019-20)

The merit list for the unreserved category (UR) seats will comprise all the applicants in order of merit. No one will be excluded from the same. **In other words, the merit list will also include SC / ST / OBC / EWS applicants, irrespective of category, if they meet the criterion of merit for UR category.**

**No applicant can be excluded from the UR category merit list just because the applicant belongs to or has applied under SC/ST/OBC/EWS category.** Such an applicant is entitled to be considered under the UR category, as well as under the reserved category. Admission to UR category seats will be strictly in order of merit without excluding SC/ST/OBC/EWS applicants.

**Discrimination on the basis of category/ caste is completely unlawful.** The University of Delhi does not tolerate discrimination against any applicant/student on this basis. Strict action will be taken against any violations.

Applicants seeking admission under SC/ST/OBC/EWS category will have to produce for verification certificates in their own names.

## Reservation of Seats for Scheduled Caste (SC) and Scheduled Tribe (ST) applicants

- 22½ % of the total numbers of seats is reserved for applicants belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7½% for Scheduled Tribes, interchangeable if necessary).
- It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe applicants.
- Colleges shall not refuse admission to any SC/ST applicant on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.
- Relaxation to the extent of 5% in the minimum marks shall be given to the applicants belonging to SC and ST to determine their eligibility and merit for admission to the course concerned.
- In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill all the reserved seats. (AC Resolution A88, 14.6.1983) (EC Resolution 157, 24.12.2001). It is obligatory for all Colleges to fill all the seats reserved for SC/ST applicants. Eligibility in these cases is pass percentage.

The following are empowered to issue the requisite SC/ST certificate:

(a) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Addl. Deputy Commissioner/ Deputy Collector/ 1st class Stipendiary Magistrate/ City Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner.

- (b) Chief Presidency Magistrate/ Addl. Chief Presidency Magistrate/ Presidency Magistrate.
- (c) Revenue Officer not below the rank of Tehsildar.
- (d) Sub- Divisional Officer of the area where the Applicant and/ or his family normally resides.
- (e) Administrator / Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

The applicant must note that the SC/ST Certificate **from any other person/ authority shall not be accepted in any case. If the applicant happens to belong to SC or ST, applicant's caste/ tribe must be listed in the appropriate Govt. of India Schedule.**

The Caste Certificate should clearly state: (a) Name of his/ her caste/ tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence, and (d) the appropriate Govt. of India Schedule under which his/ her caste/ tribe is approved as SC or ST. If the applicant does not have their SC or ST caste/tribe certificate at the time of registration/applying, they may upload the acknowledgement slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the applicant will have to produce the valid original SC or ST caste/tribe certificate. However, if an SC/ST Applicant seeks admission under some other category (for example: PwD/Employee Ward, etc.) the applicant should satisfy the minimum eligibility requirement for that particular category.

**Note: SC/ST applicants who get admission under open merit (unreserved) shall not be included in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST).**

**It is obligatory for the College to fill all the seats reserved for SC/ST applicants.  
Minimum Eligibility in these cases is pass percentage.**

## Reservation of Seats for Other Backward Classes (OBC, Non-Creamy Layer, Central List)

1. 27% seats will be reserved for the applicants belonging to Other Backward Classes (OBC) (non-creamy layer, central list).
2. At the time of giving admission to an OBC applicant, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website [http://ncbc.nic.in/backward\\_classes/index.html](http://ncbc.nic.in/backward_classes/index.html).)
3. The certificate must mention non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).
4. The OBC applicants who belong to the Non-Creamy Layer and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the applicants as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate shall be for the financial year 2018-2019, issued after 31st March, 2019.

5. If the applicant does not have the OBC non-creamy layer certificate of the latest financial year 2018-2019 at the time of registration, the applicant may upload the previously issued (older) OBC non-creamy layer certificate or the acknowledgement slip of OBC non-creamy layer certificate application. However, at the time of admission, the applicant must produce the recent financial year's (2018-19) OBC non-creamy layer certificate, issued by the same competent authority. This additional certificate must have reference of the applicant's already issued original caste certificate.
6. The OBC applicants shall be given a relaxation of 10% in the minimum eligibility marks of the said course and for the admission entrance test a relaxation of 10% of the minimum eligibility marks prescribed for General/UR Category applicants.
7. It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC applicants.

## Reservation policy for Economically Weaker Sections (EWS)

As per the University of Delhi notifications, Reference No. Aca. I / Reservation of EWSs / 2019 / 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019, for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission for the same from this Academic Year, 2019-20. The eligibility of such applicants will be decided on the basis of fulfilling criteria prescribed in the above notifications, and subject to submission of documents, issued by the competent authority, in the format provided in Annexure IV of the University Admission Bulletin.

## Reservation of Seats for Persons with Disabilities (PwD)

As per the provisions of Rights of Persons with Disabilities Act, 2016, not less than five percent (5%) seats are reserved for Persons with Benchmark Disabilities. Person with benchmark disability means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. It may be noted that the erstwhile Persons with Disability Act, 1995, under which reservation for Persons with Disabilities in admissions was provided earlier has now been repealed. PwD applicants shall be given a relaxation in the course-specific eligibility in the qualifying examination and in the admission entrance test to the extent of 5%, till seats are filled. **(Detailed information regarding specified categories of disabilities along with the concessional/waiver of fees are mentioned in the University Bulletin of Admission, page 28-31.)**

## Reservation for Children/Widows of Personnel of the Armed Forces (CW)

1. Five percent (5%) of seats are reserved for applicants under this category, course-wise in all colleges.
2. All such applicants have to upload the Educational Concession certificate in the enclosed format sample to be issued by **any of the following authorities** on the proper letterhead:
  - a) Secretary, Kendriya Sainik Board, Delhi.
  - b) Secretary, Rajya Zila Sainik Board.
  - c) Officer-in-Charge, Record Office.
  - d) 1st Class Stipendiary Magistrate.
  - e) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

Admission may be offered to the Children/Widows of Personnel of the Armed Forces (**Priority I to IX**) including Para-Military Personnel (**only Priority I to V**). (**For details see the University Bulletin for UG admission 2019-20, page 31-33**)

## Reservation of Kashmiri Migrants (KM) (Supernumerary Seats)

1. All the wards (sons/daughters) of Kashmiri Migrants who wish to be considered for admission to various undergraduate courses of the University have to register online as per the schedule notified by the University.
2. Up to 5% seats are reserved course-wise in all colleges for the wards of Kashmiri Migrants.
3. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/ Relief Commissioner.
4. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the Colleges. A concession of maximum 10% in the last cut-off marks fixed for unreserved category applicants shall be extended to the Kashmiri Migrants.
5. Reservation under this category is not available in courses where admission is based on entrance tests.

## Prime Minister's Special Scholarship Scheme for J&K students

The applicants selected under Prime Minister's special scholarship scheme for J&K students will be admitted directly to the Colleges. Reservation under this category is not available in courses where admission is based on entrance tests.



# RESERVATION OF SEATS

(As Per DU Admission Bulletin 2019-20)

## Nomination of Seats for Sikkimese Students

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion. Reservation under this category is not available in courses where admission is based on entrance tests.

## Seats for Ward Quota

Admission to the wards of University and College permanent in-service employees, both teaching and non-teaching, to the various undergraduate courses, excluding professional courses and other courses where admission is made on the basis of entrance test, is made according to the following criteria:

1. Admission to wards (children) of the permanent in-service employees at the college where employees are working be given on the basis of merit among such applicants subject to ordinarily one seat for every unit of up to sixty students in a course and subject to fulfillment of course-specific eligibility conditions.
2. For admission of the wards (sons/daughters) of the permanent in-service employees of the University/other colleges (teaching/non-teaching) the total number of seats for admission will not exceed six (three for the teaching and three for the non-teaching employees) on the basis of merit among such applicants subject to a maximum of ordinarily one seat for every unit of up to sixty students in a course and subject to fulfillment of course-specific eligibility conditions.
3. The admissions on the above norms will be against seats over and above the normal strength.
4. Applicants who wish to apply for admission under ward quota must fill the online registration form. They need to choose the colleges from the list for which they wish to apply at the time of registration. The schedule and process for admission under Ward Quota will be notified on the University website.

## Reservation of Seats for Foreign Applicants

All foreign applicants including those who have completed their schooling from an Indian Board may be treated as Foreign Students for the purpose of their registration/ admission in various Departments and Colleges of the University and they may be considered for admission under 5% quota prescribed for foreign students. The foreign applicants seeking admission to Undergraduate course should apply online through the Foreign Students' Registry portal <http://fsr.du.ac.in> and can contact the Deputy Dean (Foreign Students' Registry), Conference Centre, University of Delhi-110007.

# SPORTS & ECA ADMISSIONS

(As Per DU Admission Bulletin 2019-20)

## Guidelines for Admissions under Extra Curricular Activities (ECA)

The admission of ECA applicants shall be administered through centralized trials based on the preferences of courses and colleges as indicated by the applicants. Information about available ECAs may be found in Annexures V.A. and V.B. of the University Bulletin.

1. Applicants seeking admission under ECA category will register online on the DU Admissions portal.
2. Applicants may register for a **maximum of three ECA categories**.
3. Not more than 15% concession in academic merit vis-à-vis Unreserved Category applicants for the last relevant cut-off may be given for admission to a specific course subject to course-specific eligibility criteria. Admissions under ECA category will only be allowed to applicants satisfying the course-specific minimum eligibility criteria.
4. Applicants are required to upload only one certificate (preferably that with the highest achievement) issued for the period May 1, 2016 up to April 30, 2019, in each Category they wish to apply for as a proof of their involvement in the relevant Category. They should carry all the relevant certificates for evaluation in case they are selected for final trials.
5. ECA trials will be held at two levels: (i) Preliminary trials; (ii) Final trials. The trials for admission under the ECA category shall be conducted by an **ECA Committee (Admissions) appointed by the University Admission Committee and approved by the competent authority**.
6. Dates and venues for the preliminary and final trials shall be notified and displayed on the University Website.
7. The applicant shall be allowed to appear in the preliminary trials only once in an event. **Any request for a second chance at trials will not be permitted.**
8. Based on the preliminary trials, applicants short-listed for the final trials will be notified on the University Website.
9. Evaluation of Certificates by the ECA Admission Committee will be done only for those applicants who qualify for the final trials. The applicants must carry all the relevant certificates in original (and with self-attested photocopies) for evaluation at the time of the final trial.
10. The Final Merit lists shall be based on ECA performance (in the Final Trials) and certificate evaluation with a weightage of 75:25 respectively.
11. The applicant must secure at least 50% marks in the final trials (38 out of 75) to be eligible for inclusion in the Final Merit lists of selected candidates. Subcategory-wise Final Merit lists will be prepared for all eligible applicants only.
12. In case of a tie in the final marks (out of 100), the candidate with higher marks in the trials (out of 75) will be placed higher in the Final Merit list. In case a tie still persists, all such candidates will have the same rank.
13. The preliminary and final trials will be video-graphed and recordings would be preserved till the last date of admission.

14. Subcategory-wise Final Merit Lists of the applicants, showing marks awarded for the ECA certificates and for performances in the Final Trials, shall be notified on the University Website.
15. Selection in a final Merit list does not guarantee admission to an applicant. Admission is subject to the availability of seats in a course/college for the relevant ECA sub-category.
16. The existing provision of not more than 5% Sports and ECA quota (subject-wise) is continued as per circular No. Aca.I/ Sports / 2010-11 / 178 dated May 29, 2010. However, in case of a greater demand in a particular course, upto a maximum of double the number of sanctioned seats in the said course under the ECA category may be admitted by the college subject to overall ceiling of 5% sports and ECA Quota.
17. Applicants will have to register in the colleges of their choice according to the schedule that will be notified on College/University websites.
18. The allotment of the course/subject to the qualified applicants shall conform to the University regulations. The admission of applicants thereafter will be completed on the University Admission Portal.
19. The selected candidates shall submit an Undertaking at the time of admission stating that the candidate will perform for the College and University for the entire period of the candidate's undergraduate course of study. The college has a right to cancel their admissions if they violate the undertaking during their stay in college.
- 20. Any candidate submitting false/fake certificates will be debarred from admission to any course in any college for three years. If a candidate seeks admission on the basis of false/fake certificates, not only will the admissions be cancelled, an FIR may also be registered.**
21. The college shall maintain a proper record of candidates admitted on the basis of ECA.

## Guidelines for Admission on the Basis of Sports

1. The applicant is required to fill the online application form available on the DU UG Admissions Portal.
2. The applicant can apply in **a maximum of three Games/Sports**.

Admission herein will be based on:

- I. Super Category: Direct admission without Sports Trial
- II. Admission on the basis of Sports Trial: Maximum 60 marks for sports trial and maximum 40 marks for merit/participation sports certificate

  - e. The applicant, as per their age must be eligible to participate in Inter-University Competitions for the next three years and should not be employed on Part-time / Full-time basis anywhere.

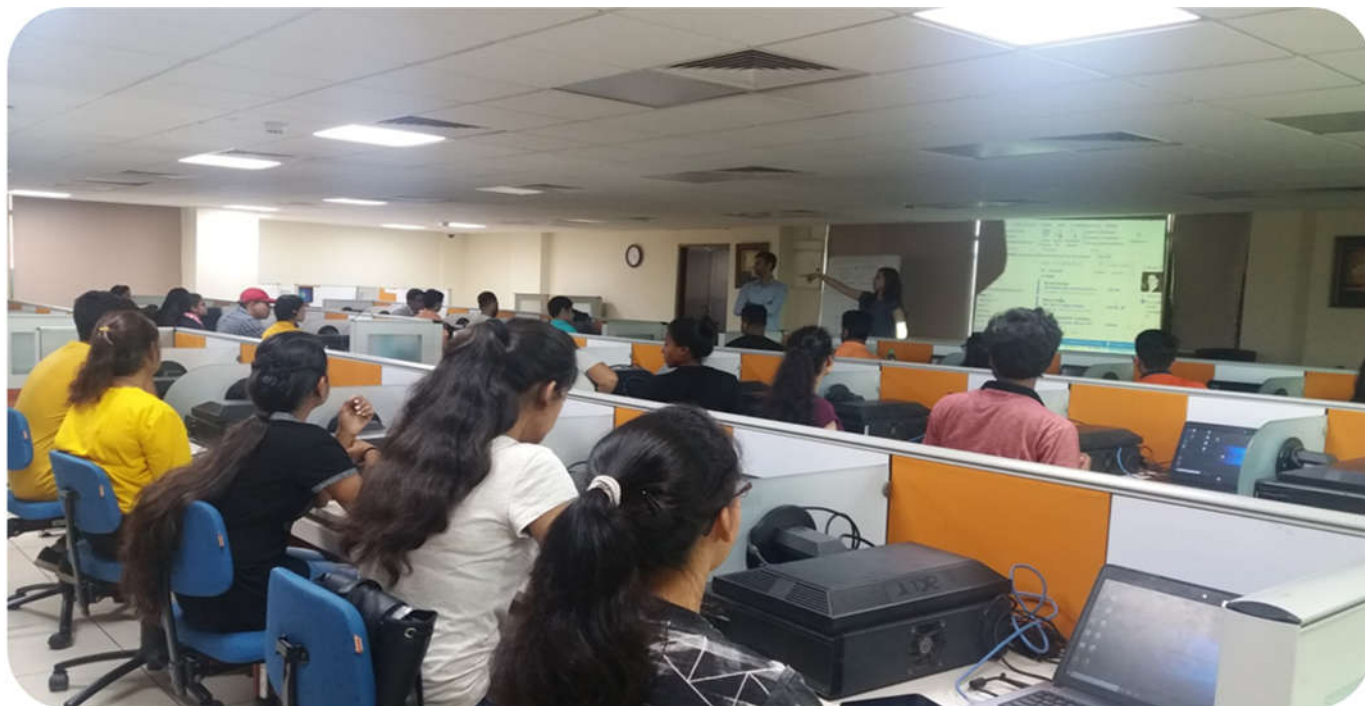


## Certificate Course in Cyber Security (CCCS)

# Non-Collegiate Women's Education Board (NCWEB)

In 1943, by a Delhi University Act, Non-Collegiate Women's Education Board was established, wherein women students were enabled to take some of the examination of the University with special coaching but without attending regular classes. This gave shape to the Non-Collegiate Women's Education Board (NCWEB). The Board began functioning in September'1944 with 3 students. At present, the enrolment is more than 32,000. Only women students residing in the National Capital Territory of Delhi can enrol themselves.\* NCWEB has emerged as an important academic option for female students.

The classes are held on Saturdays/Sundays and during academic breaks to obtain Undergraduate (UG) and Postgraduate (PG) Degrees from the University of Delhi. The NCWEB is now established in 26 UG centres and one PG centre. The 26 UG centres run in various colleges of University of Delhi (For the list of colleges, refer the link: [http://ncweb.du.ac.in/teaching centres](http://ncweb.du.ac.in/teaching%20centres)).

Women applicants who satisfy the minimum eligibility requirements must register online through the centralized UG admission portal. They will be admitted by the teaching centres of Non-Collegiate Women's Education Board for admission to B.A. (Prog.) / B.Com (Three Year). The admission is done on the basis of merit by declaring cut-offs as per schedule.

## Admission Procedure to B.A. (Prog.) / B.Com.

- Total number of seats in B.A. (Prog.) in each of teaching centres: 312
- Total number of seats in B.Com. in each of teaching centres: 202 (Number of seats in B.A.(Prog.) subject combinations are fixed. Reservation for SC/ST/OBC/EWS/PwD/CW will apply as per University rules.)
- The percentage for cut-off will be decided on the basis of marks obtained in the best four subjects in 10+2 (as per criteria in Chapter 2 of Bulletin).
- Any student who takes admission in any one centre of NCWEB will not be allowed to change the centre at any later stage during the admission process.

## General Information for admission

- The applicants will have to produce their original certificates at the time of admission.
- The annual fee would be approximately around Rs. 3,500 (Rupees Three Thousand Five Hundred).
- A fee of Rs. 100 (Rupees One hundred only) will be charged from PwD category students.
- Non-Collegiate students are not allowed to pursue any other full-time/degree course.
- It is suggested that the students may take admission in a centre near their residence if possible.
- \*Residence proof of NCT Delhi (i.e. Aadhaar card/ Passport/ voter ID card/ Driving license in the name of the applicant and/ Ration card with the name of applicant) in original will have to be produced.
- For further information and schedule for admission, the applicants are advised to contact the Director, Non-Collegiate Women's Education Board, Tutorial Building, University of Delhi, Delhi-110007. For further information, refer to the website <http://www.ncweb.du.ac.in>.
- After approval of admission, the applicant has to log on to the undergraduate admission portal to make online admission fee payment. Fee payment must be done within 24 hours of the generation of the approval for the admission process to be completed.



# Non-Collegiate Women's Education Board (NCWEB)

## General information after admission

- The Board provides library facility to all under graduate students in the respective Teaching Centres and a Post-Graduate Library is located in the Arts Faculty Building, North Campus. The Board gives financial aid and book loan facility for the academic year to the needy and deserving students.
- There are 50 teaching days in an academic session year, held either on Saturdays or Sundays and during the academic breaks of the University of Delhi.
- At the Under-graduate centres, classes are held from 9.00 a.m. to 2.00 p.m, as a set of 5 periods of 60 minutes each.
- Since there is class-room teaching, no written material is given.
- Students are expected to attend classes regularly as the minimum 66.67% attendance has been made mandatory to appear in the University Examinations, which are held annually in the month of May.
- The NCWEB UG students are permitted to finish their B.A./B.Com 3-Year UG degree courses in 6 years

**Our college** started its NCWEB chapter, in July'2017 by admitting 450 students in two courses, B.A. and B.Com. The classes are held on Saturdays and during academic breaks which leaves students with ample time to work or pursue other goals. The students are not only given exposure of academic life but also co-curricular activities. Learning and thinking beyond the curriculum is also promoted by conducting workshops, seminars and lectures in the college throughout the session. The spectrum of topics from the Gender Sensitization to the Confidence Building and Memory Techniques are covered under these practices and programmes. Generally the session concludes with an annual festival, which is arranged by the students only.

In the session 2018-19, a one-day program- On the Bridge to Livelihood Project- funded by UNDP was organised, which is a skill training program for the students. The team provides apprenticeship wherein students get opportunity to be engaged by a company as an apprentice and gain practical learning. It is a platform where one learns while earning as most companies provide good stipend too. The students organized and participated in their annual cultural fest RUNG'2019 and showcased their skills in cultural as well as sports activities. The session concluded with the celebration and prize distribution on the First Annual Day of the DDUC NCWEB Center held in April'2019.

# AWARDS & SCHOLARSHIPS

## FROM THE UNIVERSITY

- i. Delhi University holds a competitive examination in the month of October each year for the award of All India Entrance Scholarships of Rs. 250 per month. Any student with at least 55% marks in the aggregate may apply latest by August 2019 or as notified by University in the prescribed forms available from the College Office.
- ii. Financial Assistance out of Vice Chancellors' student fund is given to poor deserving students, who have passed Annual Examination of Current year from University of Delhi and belong to BPL/APL families (Rs. 3000/-).
- iii. Under Graduate Science Meritorious Award is given to students who secure highest marks in B. Sc. (Hons) Physics, Chemistry, Botany and Zoology.
- iv. Various other Delhi University Scholarships are uploaded on the website of the University. [Guidelines](#) and [Application Form](#) are given under the link: [www.du.ac.in/Home/useful-links/opportunities-scholarships](http://www.du.ac.in/Home/useful-links/opportunities-scholarships).
- v. Vice-Chancellor's Gold Medal is awarded each year to physically challenged student from the Arts, Science and Commerce streams who secure the highest marks amongst students studying in these streams, with not less than 60% marks, at the undergraduate (Final Year Passed) examination.

## STATE GOVERNMENT AWARD

The Govt. of Delhi gives three awards of Rs.10,000/- each in Science, Commerce and Humanities to students securing highest marks in their respective discipline among colleges of Govt. of NCT of Delhi.

## PT. VIDYADHAR TRIPATHI MEMORIAL AWARD

Student who scores highest marks in B. Com (Hons) every year will be awarded a cash prize of Rs. 1000/-, a shield and a certificate out of the interest income on the endowment fund instituted by his niece Dr. Vanita Tripathi.

## SHRI GHASI RAM MITTAL MEMORIAL AWARD

Out of the interest derived from Shri Ghasi Ram Mittal Memorial Scholarship Endowment fund (sponsored by his son Sh. Ram Kumar Gupta), scholarships of Rs. 4000/- each are given to the students who secure the highest marks but not less than 70% marks in the combined result (I & II Sem. University Examination) in the first attempt in the following courses:

B. Sc. (Hons) in Computer Science, Electronics, Mathematics, Physics, Chemistry, Botany, Zoology, B. A. (Hons) English, B. A. & BMS.

## SHRI SULTAN CHAND MEMORIAL SCHOLARSHIP

Out of the interest derived from Shri Sultan Chand endowment fund (instituted by Shri Sultan Chand Trust), a scholarship of Rs 3,500/- is awarded every year to a student of B. Com (Hons) who secures the second highest percentage of marks, being above 70% as aggregate in II year University examination in the College.

## SHRI SULTAN CHAND DROPADI DEVI MEMORIAL SCHOLARSHIP

Out of the interest earned from endowment funds in the name of Shri Sultan Chand Dropadi Devi (instituted by Shri Sultan Chand Dropadi Devi Education Foundation), six scholarships of Rs 4000/- each to the students securing highest marks in each semester of the three year B. Com (Hons) will be awarded.

## FROM STATE GOVERNMENTS TO SC/ ST/OBC /MINORITIES STUDENTS

- a) SC/ST/OBC/Minorities students are awarded scholarships by the States to which they belong;
- b) SC/ST/OBC/Minorities students of Delhi applying for
  - (i) post matric and/or
  - (ii) meritorious scholarship provided by Department for Welfare of SC/ST/OBC/Minorities, Govt. of NCT Delhi,are advised to contact the office immediately after the admission. The continuance of any freeship, scholarship or grants of other privileges depends on satisfactory academic progress, regular attendance, discipline and good conduct;
- c) SC/ST/OBC/Minorities students are advised to contact Department for Welfare of SC/ST/OBC/Minorities, Govt. of NCT Delhi for hostel facilities provided by the Department.

## FEE CONCESSION

The College awards fee concession to needy, deserving and meritorious students. Application on prescribed forms is to be submitted to the Accounts Section. The dates will be notified on college website. The College also provides exemption of Tuition Fee and Admission Fee to all SC/ST students, whose parents are not liable to pay income tax on their income on submission of a certificate from employer/competent authority for the same.

## STUDENTS AID FUND (SAF)

The College operates this fund with the objective of rendering financial assistance to needy and deserving students of the College. Assistance is usually given in the form of textbooks etc. Students in need of financial aid can apply when invited through circulars on the notice board.



# AWARDS & SCHOLARSHIPS

## COLLEGE SCHOLARSHIP

A scholarship of Rs. 10,000/- per annum is instituted by the college and is given to students on following considerations:

- a) Merit-cum-Means: The students whose parent's family income is below the taxable limit, subject to no ER in any paper.
- b) Students who are high achievers in academics, having secured position within first three in the University Examination of the previous year (by combining marks of odd and even semesters).
- c) Outstanding sports persons, who have participated in International Events.

## NATIONAL SCHOLARSHIPS\*

### 1. Central Sector Scheme of Scholarship for College and University Students (Department of Higher Education)

Students who are above 80 percentile of the successful candidates in the relevant stream of respective Board of Examination in class XII or equivalent and passing regular courses (not correspondence or distance mode) in colleges.

### 2. Post Matric Scholarship for students belonging to the Minority Communities (Ministry of Minority Affairs)

Students belonging to Muslims, Sikhs, Christian, Buddhist, Jain & Zorastrians (Parsis) Communities who have secured not less than 50% marks or equivalent grade in the previous final examination & the annual income of whose parents/guardian from all sources does not exceed Rs. 2.00 lakh.

### 3. Post Matric Scholarship for students with disabilities (Department of Empowerment of Person with disabilities)

Students with disabilities with more than 40% disability and having a valid certificate of disability as prescribed under rules issued by the competent authority and whose parent/income from all sources does not exceed Rs. 2.5 lakhs.

# RULES AND REGULATIONS

## Cancellation / Withdrawal of Admission

Any student interested in getting his/her admission cancelled on or before the last date of admission is required to fill a performa available from the College Office and submit it to the Coordinator Admission Committee.

## Compulsory Test in Hindi

Students enroll for degree courses, who have not studied and passed Hindi upto 8th Class are required to pass the Compulsory Test in Hindi (CTH) conducted by University of Delhi in order to be eligible for award of degree. Such students are required to contact the college office immediately after the commencement of classes.

# RULES AND REGULATIONS

## Attendance

1. Every student admitted to the College is required to attend lectures, tutorials, presentations and practical as per the college time table. No student will be permitted to appear in the University examinations unless he/she has attended at least two thirds of the lectures/ tutorials/ practicals/ presentations held in all subjects taken together in each semester. For further details, please refer Ordinance VII (2), University of Delhi (See the Annexure).
2. Attendance will be taken from day one of the new session. Students are expected to check the status of their attendance record which will be displayed on the students' notice board/ college website from time to time.
3. If a student is unable to attend classes because of medical reasons, he/ she must submit a medical certificate as well as fitness certificate to the College Office not later than a week of rejoining College after illness. Medical certificates submitted late will not be accepted by the College.
4. A student, whose name is struck off from the College rolls on account of non-payment of fees or disciplinary action and later re-admitted, will not be given the benefit of attendance during that period.

**Migration:** The college does not permit any outward migration from the college. The Principal may at his discretion, permit inward migration in second year only.

**Removal from the College:** The Principal is empowered to remove the name of a student from the college rolls if, in the opinion of the Principal, he/she (i) is grossly irregular in attendance or (ii) is not amenable to the college discipline or (iii) is guilty of gross negligence in studies or (iv) is not found fit for the course chosen by him/ her or (v) has not paid College dues in time.

**Re-Admission:** A student, whose name is removed from the college rolls for non-payment of fees or for any other reason, may be permitted re-admission at the discretion of the Principal on written request by the student. Such readmission shall be on payment of re-admission fees, arrears of tuition fees and fines, after the permission is granted.

**Notice Board / Website:** Students should make it a habit to read the notice board/website regularly to check notices for schedule of classes, examinations, holidays, activities and other information of relevance. Ignorance of any notice will not be accepted as a plea or an excuse for any delay in any matter.

**Identity Card:** After admission to the college, every student will be issued an Identity Card, which he/she should always carry and present it as and when asked for. Failure to do so will render a student liable to disciplinary action. The card must be returned when a student leaves the college. Loss of Identity Card should be reported to the office immediately. Duplicate Identity Card will be issued on payment of Rs 50/-.

# RULES AND REGULATIONS

**Library Card:** Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable.

**Visitors:** Students are not permitted to receive or entertain visitors in the college. In case of extreme urgency they must seek prior permission from the Principal or in his absence from the Vice Principal / Administrative Officer.

**Residential Address:** In case of change in residential address, the same must be intimated in writing under the signature of parents/guardians to the college Office without delay.

**Internal Assessment:** Internal Assessment is governed by the Ordinance VIII E of the University of Delhi (see Annexures), as amended and notified by University of Delhi from time to time.

**Passing and Promotion Criteria:** Passing and Promotion Criteria is governed by Ordinance IX of University of Delhi, as amended and notified by the University from time to time. The relevant provisions of the amended Ordinance IX as on date are given in Annexures.

**Internal Complaints Committee (ICC):** In accordance with Section 4(1) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, an Internal Complaints Committee (ICC) has been constituted comprising of following members

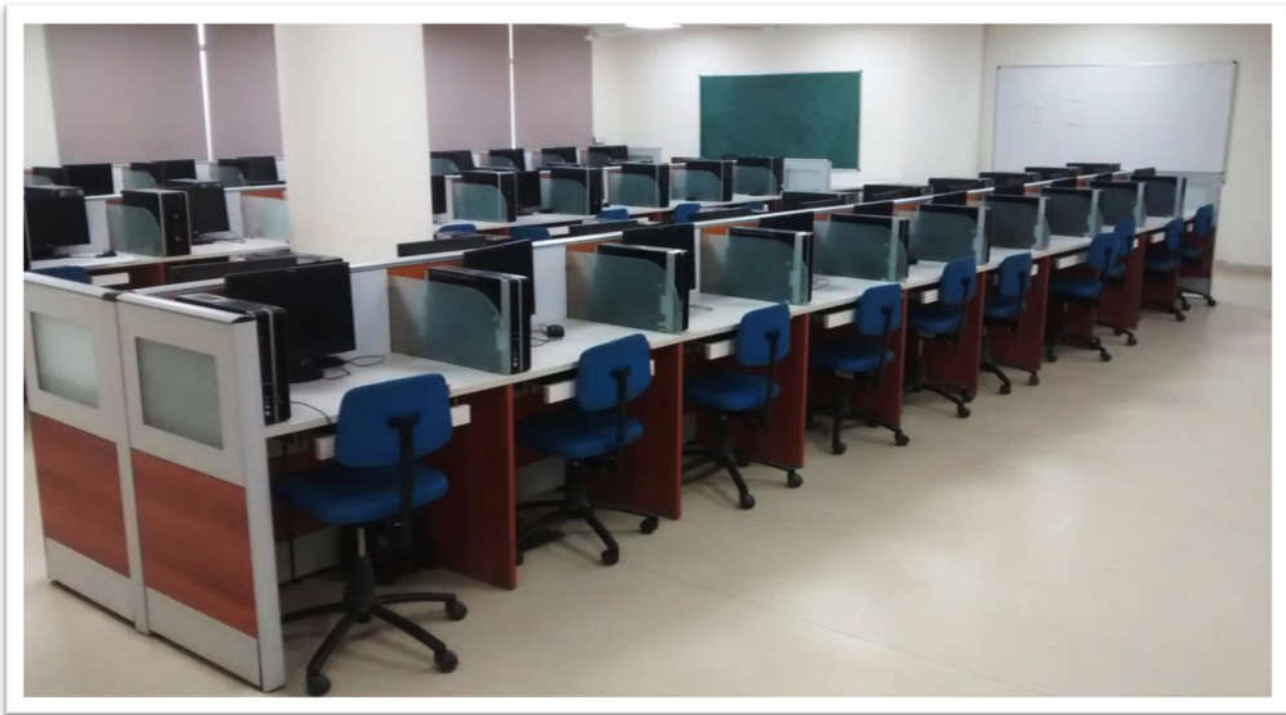

The desks are well spaced out and the halls are airy, well-lit and have fine acoustics. Each hall also has the latest audio visual teaching aids.

## Laboratories: Enhancing Skills

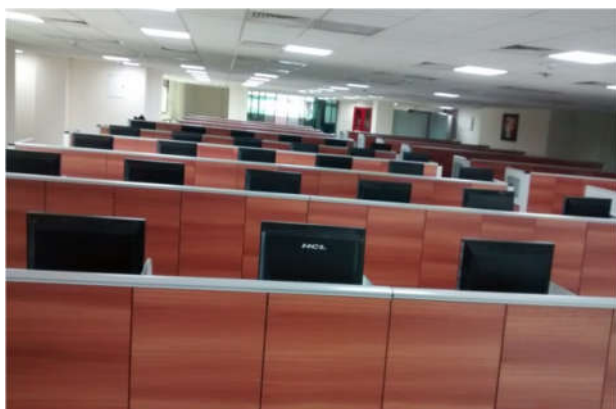
The College has three computer laboratories with over 140 computers of the latest configuration and internet facility through the Delhi University optical fiber connection. The laboratories are being fully equipped with the latest multimedia equipment including LCD projectors and will also have facilities for Video Editing, Image Editing, Animation, Audio-Editing and Authoring Tools. There are four Physics laboratories and two Electronic laboratories which have state-of-the-art equipment to conduct experiments. These laboratories are equipped with 35 CRO's, 55 Function Generators, 37 Micro-processor Kits, 48 Digital Storage Oscilloscopes (Tektronix), 3 Arbitrary Function Generators (Tektronix), 57 Computers, 22 Spectrometers, besides other equipment including: Hall effect set-up, Michelson Interferometer, Laser Kits, Optical fiber kits etc. To conduct experiments in Life Sciences,

there are two Museums containing various specimens and models and two laboratories each of Botany and Zoology, well equipped with latest instruments that include Microscopes having 15000 x magnifications. For Chemistry there are three laboratories of which, one is an Analytical Technique Laboratory equipped with instruments like Flame Photometer, UV-Visible Spectrophotometer, Scanning Visible Spectrophotometer.



## Computer Centre: Simplifying Technology

The Campus has a centrally Air Conditioned Computer Centre on the second floor of the C block, with a capacity of about 200 users to promote network based knowledge and learning. The ICT infrastructure consists of a server, desktops and a gigabit fiber backbone which provides 24x7 dedicated Internet connectivity through WLAN (Wi-Fi) and LAN.



## Research Room: Promoting Innovation

The College has various Research Laboratories that provides facilities to the faculty to work on research projects. Besides, there is a DBT star college program lab too. The college has also created an endowment fund of Rs. 3 Cr. out of its interest, research grant from Rs. One Lakh to Rs. Three Lakhs is provided to the faculty to promote research culture in the college.



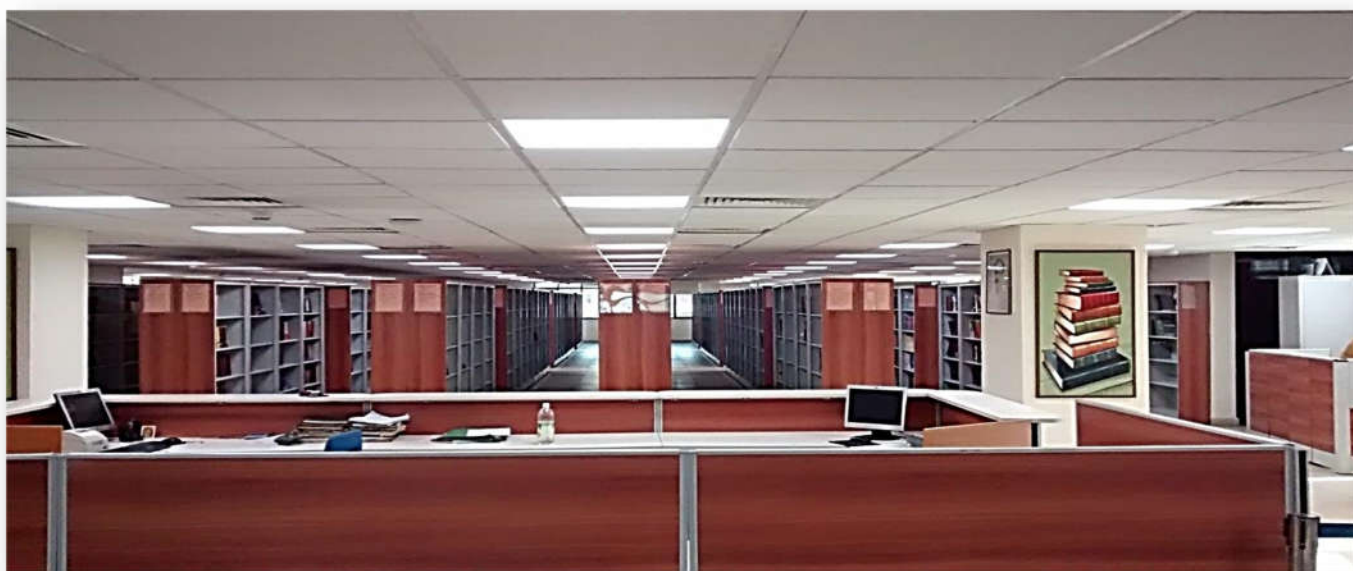
## COLLEGE INFRASTRUCTURE

### Library: Resource and Information Centre

The college has excellent central library facility sprawling across three floors with centralized air conditioning facility. It has a total floor area of 2,550 sq. meters, with a provision for a separate reading section for the faculty and spacious reading hall to accommodate over 200 students. The library is fully computerized with all its function and operations being performed through a dedicated network of 21 computer systems using library software. The library organizes separate User Orientation Program every year for the new batch in its reading hall on the day of Orientation day of the college. Students are given detail information and instructions on the use of library resources.

**Collection:** The library has a rich and active collection of text-books and reference books which is extensively utilized by the students. It has up-to-date bibliographic database of books and journals. The library has total collection of 45590 volumes of text-books and reference books. It subscribes to 72 journals & magazines of national and international repute in all the relevant subject areas. Besides this, the library subscribes to 15 national newspapers. It has 613 bound volumes of journals and 850 CDs in its collection.

**Services and Facilities:** The library provides book-bank facility to students belonging to SC/ST/OBC categories and other economically poor and meritorious students of the college. Through the University dedicated fiber-optic link and other resource sharing network, the library has access to many important databases, thousands of e-journals and lakhs of e-books. The entire college campus including the library are Wi-Fi enabled to provide 24X7 seamless access to information remotely from anywhere in the campus. The library provides internet browsing, database search and print out facility. To promote use of books and e-resources, the library also conducts workshop and seminars. Every registered member of the library is provided with User ID and Password for remote access to e-books and journals. The Library provides specialized reading services to visually impaired students using camera scanner and assistive software.





## COLLEGE INFRASTRUCTURE

**Library Privileges:** Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable. Every student is entitled to borrow four library books for a period of 10 days. Books retained beyond the prescribed due date is charged a late fine of Re. 1/- per day for the first five days of delay and subsequently Rs. 3/- per day for remaining period of delay.

**Working Hours:** The working hour of the library is from 9:00 am to 5:00 pm on all working days. It also remains open till 8:00 pm on all regular working days towards the end of every semester from one month prior to till last day of examination. During this period the library also remains open on Saturdays.

### Hostels: Home Away from Home

The institute has separate hostels for Boys and Girls, and provides excellent accommodation to 180 students. The hostels have twin sharing rooms which are well furnished, and have attached bathrooms with hot water supply during winters. All rooms are furnished with a bed, mattress, study table, book rack, chair, cupboard/shelf for each student. The hostel rooms are well ventilated. Round the clock security is provided. There are separate Students' Messes (intended to be air-conditioned) for boys and girls along with the cafeteria facility. Recreation Rooms with TV in boys and girls hostels and sports facilities is available.

### Guest House

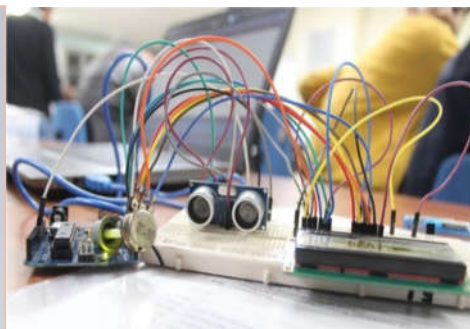

# ANNEXURE

## DIRECTIVES OF THE HON'BLE SUPREME COURT OF INDIA ON ANTI-RAGGING

Ref. : Directives of the Supreme Court of India dated May 16, 2007 in SLP No(s) 24295 of 2006 University of Kerala Vs Council, Principal's, Colleges, Kerala & Ors (with SLP(C) No. 24296-99/2004 & WP. (Crl) No.173/2006 and SLP(C) No. 14356/2005) and Civil Appeal No. 887 of 2009 dated May 8, 2009.

The Hon'ble Supreme Court of India admitted and heard the above referred SLPs in relation to the menace of ragging in Technical Institutions/Universities/ Colleges in the Country.

In this connection a committee headed by Dr. R.K. Raghavan, Former Director of CBI, for giving specific recommendations on effective prevention of ragging in educational institutions was constituted by the apex court.

Accordingly, the Committee had carried out a very detailed study on the various factors contributing for ragging and collected the public opinion. Further, the committee had submitted a detailed report with suitable recommendations and measures required to effectively curb the menace. The recommendations of the Committee were duly accepted and the following directives have been issued to all the educational institutes for necessary implementation by the Hon'ble Court. The Hon'ble Court issued further orders on the 2nd and 3rd report of the Raghavan Committee also.

The salient features of the report / order are summarized below:

### I. Factors listed by the Committee

- a) Primary responsibility for curbing ragging rests with academic institutions themselves.
- b) Ragging adversely impacts the standards of higher education.
- c) Incentives should be available to institutions for curbing the menace and there should be disincentives for failure to do so.
- d) Enrolment in academic pursuits or a campus life should not immunize any adult citizen from penal provisions of the laws of the land.
- e) Ragging needs to be perceived as failure to inculcate human values from the schooling stage.
- f) Behavioral patterns among students, particularly potential 'raggers', need to be identified.
- g) Measures against ragging must deter its recurrence.
- h) Concerted action is required at the level of the school, higher educational institution, district administration, university, State and Central Governments to make any curb effective.
- i) Media and Civil Society should be involved in this exercise.

### II. Recommendations approved by the Supreme Court

1. The punishment to be meted out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
2. Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied with the institutional arrangement for action, a First Information Report must be filed without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority or negligence or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the institutional authority.  
If any victim or his parent/guardian of ragging intends to file FIR directly with the police, that will not absolve the institutional authority from the requirement of filing the FIR.

# ANNEXURE

3. In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he /she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
4. It shall be the collective responsibility of the authorities and functionaries of the concerned institution and their role shall also be open to scrutiny for the purpose of finding out whether they have taken effective steps for preventing ragging and in case of their failure, action can be taken; for example, denial of any grant-in-aid or assistance from the State Governments.
5. Anti-ragging committees and squads shall be forthwith formed by the institutions and it shall be the job of the committee or the squad, as the case may be, to see that the Committee's recommendations, more particularly those noted above, are observed without exception and if it is noticed that there is any deviation, the same shall be forthwith brought to the notice of this Court.
6. The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the anti-ragging committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.
7. It is necessary that parents/guardians of fresher's assume responsibility for promptly bringing to the notice of the Principal any instance of ragging.

# ANNEXURE

## ORDINANCE XV-B

### Maintenance of Discipline among Students of the University

1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
  - a. Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/Department and against any student within the University of Delhi
  - b. Carrying of, use of or threat to use of any weapons
  - c. Any violation of the provisions of the Civil Rights Protection Act, 1976.
  - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes.
  - e. Any practice-whether verbal or otherwise derogatory of women.
  - f. Any attempt at bribing or corruption in any manner.
  - g. Willful destruction of institutional property.
  - h. Creating ill-will or intolerance on religious or communal grounds.
  - i. Causing disruption in any manner of the academic functioning of the University system.
  - j. Ragging as per Ordinance XV-C
4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice- Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students –
  - a. be expelled; or
  - b. be, for a stated period rusticated ; or
  - c. be not, for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or
  - d. be fined with a sum of rupees that may be specified; or
5. Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads of Teaching Departments in the University, the Principal, School of Open Learning and Librarians shall have the authority to exercise all such disciplinary powers over students in their respective colleges, institutions, faculties and teaching departments in the University as may be necessary for the proper conduct of the Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
6. Without prejudice to the powers of the Vice Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.
7. At the time of admission, every student shall be required to sign a declaration that on admission he/ she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University.



# ANNEXURE

## ORDINANCE - XV-C

### Prohibition and Punishment for Ragging

1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance
3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which.
  - a) Involve physical assault or threat to use of physical force.
  - b) Violate the status, dignity and honour of women students.
  - c) Violate the status, dignity and honour of students belonging to the scheduled castes and tribe.
  - d) Expose students to ridicule and contempt and affect their self-esteem.
  - e) Entail verbal abuse and aggression, indecent gestures and obscene behavior.
4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging,
5. Notwithstanding anything in Clause (4) above, the Proctor may also suo moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrences of ragging incidents described in Clause 3(a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a College, departmental examination for one or more year or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
11. In case any students who have obtained degrees or diplomas of Delhi University are found guilty; under this Ordinance, appropriate action under Statute 15 for withdrawal of degrees or diploma conferred by the University will be taken.

## ANNEXURE

12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice incitement of ragging will also amount to ragging.
13. All Institutions within the Delhi University system shall be obligated to carry out instructions/directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

**Note:** Order of the Vice-Chancellor in pursuance of Ordinance XV-C : Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order, Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi, Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

**Amendments to Ordinance VII of the Ordinances of the University and to all other relevant Ordinances of the University regarding attendance rules for the 3-year semester based undergraduate programmes. (Page No. 328 & 349 of the University Calendar Volume I (2004)(E.C.28.05.2015).**

*Replace the existing attendance rules for the 3-year semester based undergraduate programmes with the following:*

### **ORDINANCE-VII (2)**

a) A candidate for the Semester I/III/V Examination shall not be deemed to have satisfied the required conditions of attendance unless s/he has attended, in all the subjects taken together, not less than two thirds of the lectures/practical/presentations/tutorials required to be attended. Provided that a student of the Semester I/III/V who does not fulfill the required conditions of attendance, as above, but has attended, in all the subjects taken together, not less than 40 per cent of lectures/practical/presentations during the respective semester, may at the discretion of the Principal of the College concerned, appear for the ensuing semester examination; but such a candidate shall be required to make up the deficiency at lectures and practical's, in the next semester of the same academic year.

Provided that a student of the II/IV/VI semester who does not fulfill the required conditions of attendance as above, but has attended in all the subjects taken together, not less than 40 per cent of the lectures/practical/ presentation/tutorials, held during the respective semester, may at the discretion of the Principal of the College concerned, be allowed to appear at the ensuing examination provided that she/he makes up the deficiency of the said attendance by combining the attendance of the previous semester in the ensuing semester.

## ANNEXURE

Provided further that the Principal of the College concerned may permit a student to appear in an examination notwithstanding that the student has not fulfilled the attendance requirement, if in the opinion of the Principal, such student shall make up the deficiency in the succeeding academic year. Provided further that a student of the VI semester shall be allowed to appear at the VI Semester Examination, if by combining the attendance of the three academic years, the candidate has put in two-thirds of attendance, in all the subjects taken together, held during the respective years.

b) In the case of a student who:

1. is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defense work and allied duties; or
2. is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Principal/ Head of the institution concerned; or
3. is selected to participate in sports or other curricular activities; or
4. represents the college in inter-college tournaments organized by the Delhi University Sports Council (DUSC); or a student who represents Delhi State in National Tournaments organized by Nation Sports Federation; or a student who represent the University in Tournaments organized by Association of Indian Universities; or a student who represents India in International Tournaments organized by International Federation/Associations and FISU, (selection through AIU); or a student who represents India in Olympics/Common Wealth Games/Youth Games/World Championship organized by International Olympic Committee; or in national or international fixtures in games and sports approved by the Competent Authority; or
5. is required to represent the University at the Inter- University Youth Festival; or
6. is required to participate in periodical training in the Territorial Army or a student who is deputed by the College to take part in Inter-College sports or fixtures, debates, seminars, symposia or social work projects or a student who is required curricular activities held in other Universities or such other activities approved by the Vice-Chancellor for this purpose.

In calculating the total number of lectures etc. delivered in the College, or in the University, as the case may be, for his/her course of study in each academic year, the number of lectures etc., in each subject delivered, during the period of absence, and as recommended/forwarded by the concerned teacher/DPE and approved by the Principal/Head for the above purposes shall deemed to have been attended by the student.

- c) The Principal of a College may consider, on the basis of the Medical Certificates produced, exceptionally hard cases of students who had fallen seriously ill or had met with an accident during the year disabling them from attending classes for a certain period, with a view to determining whether the lectures etc. delivered during the said period, or a part thereof, could be excluded for purposes of calculation of attendance of the year and decide each case on its own merits.
- d) Colleges shall be required to notify the attendance position of each of its students for each month on the notice board of the College, and clearly indicate the lectures/practical held subject wise and the numbers attended by each student



## ANNEXURE

- e) A College shall notify on the notice board the final attendance position of each of its students within five days of the dispersal of the classes in the last session of the academic year. Not later than five days, thereafter, a student may, by an application to the Principal of the college, claim benefit of exclusion of lectures under sub-clause (a) above on grounds to be specified and accompanied by the relevant documents. All such applications submitted within time shall be considered and disposed of by the Principal of the College at least 3 days prior to the commencement of the examination, in which the student is intending to appear.
- f) The benefit of exclusion of lectures contemplated in category (c) above, shall in no case exceed 1/3 of the total number of lectures / practicals / presentations/tutorials.
- g) In the case of a married woman student who is granted maternity leave, in calculating the total number of lectures delivered in the College or in the University, as the case may be, for her course of study in each semester, the number of lectures in each subject delivered during the period of her maternity leave shall not be taken into account.
- h) No person shall be deemed to have satisfied the required conditions in respect of his instructions, unless in addition to the requirements regarding attendance and other conditions, he has appeared and satisfied by his performance the Principal of his college in such tests, written and/or oral, as may be held by him in his discretion. The Principal of the College shall have, and shall be deemed always to have had, the power to detain a student in the same class in which he has been studying, or not to send him up for the University Examination, in case he did not appear at the tests aforesaid or his performance was not satisfactory. The Principal of a College/Head of the Institution shall have power to strike off the name of a student who is grossly irregular in attendance inspite of warning, or when the absence of the student is for such a long period that he cannot put in requisite percentage of attendance.

### ORDINANCE XV-D \*

#### **The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (MINISTRY OF LAW AND JUSTICE)**

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto. WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment; AND WHEREAS the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all forms of discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India. AND WHEREAS it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace. For details, please see the website

# ANNEXURE

## ORDINANCE VIII-E \*

### Internal Assessment

(1) (i) The scheme for Internal Assessment shall be followed in the regular stream only, with exclusions as per the Appendix to the Ordinance, and shall be applicable to the students admitted from the academic session 2003-04 onwards (i.e. to begin with for the first year students) in both undergraduate and postgraduate degree courses. This scheme of Internal Assessment shall not be applicable to the School of Correspondence Course and Continuing Education, Non-Collegiate Women's Education Board and Non-Formal Education Cell (formerly External Candidates Cell). The specific Ordinances pertaining to schemes of examinations of various courses shall stand amended, mutatis mutandis, to the extent of internal assessment as laid down in this Ordinance, subject to exclusions referred to above.

(ii) Internal Assessment marks shall be shown separately in the Marks Sheet issued by the University and these marks shall be added to the annual/ semester examination marks for determining the division of the student.

(2) 25% of the maximum marks in each paper in undergraduate courses shall be assigned for Internal Assessment and the remaining 75% marks for the annual/semester University Examination; the time duration and other modalities of the annual/semester Examination with respect to this 75% component shall remain as per existing schemes of examination for various undergraduate courses.

(i) (a) For the Semester Examination Scheme, there shall be 10% weightage assigned to Class Test (s) Quiz(s) to be conducted by each College, for all subjects in B.A., B.Com, and B.Sc. courses and all papers of the Main Subject in Honours courses.

(b) The University reserves the right to scrutinize some or all the scripts of any paper in any Course in a College during the period of retention of papers, which duration shall be till the declaration of results by the University, a copy of the question paper shall be sent to the Examination Branch of the University and the College shall maintain a proper record of the question papers of the House Examination.

(ii) (a) Each student shall be assessed on the basis of written assignments/tutorials as well as on the basis of project reports/term papers/seminars. There shall be 10% weightage for such written assignment; and project reports/presentations/term papers/seminars. Each student shall be given at least one written assignment per paper in each term, subject to a maximum of 12 written assignments per year for all the papers taken together.

(b) Where the maximum marks in a paper are less than 100, for example 50 marks, the nature of written assignments/tutorial work shall stand adjusted *pari passu* periods).

(iii) There shall be 5% weightage for regularity in attending lectures (including interactive and tutorials, and the credit for regularity in each paper, based on attendance, shall be as follows :

More than 67% but less than 70% - 1 mark,  
75% or more but less than 80% - 3 marks,  
85% and above - 5 marks

70% or more but less than 75% - 2 marks  
80% or but less than 85% - 4 marks

## ANNEXURE

[Medical certificates shall be excluded while calculating credit towards marks to be awarded for regularity, though such certificates shall continue to be taken into account for the purpose of calculating eligibility to appear for examinations as per the existing provisions of Ordinance VII.2.9. (a) (ii)]

- (iv) There shall be a Moderation Committee for Internal Assessment in each College, discipline-wise, which shall comprise of the senior most teacher in the department, the teacher-in-charge of the department and the previous teacher- in-charge of the department: provided that if, for any reason, the membership of the Committee falls below 3, the Principal of the College shall nominate suitable members from among the teachers of that department/ College to fill the vacancies.
- (3) With the introduction of Internal Assessment, the maximum marks for the University Examination in each paper shall stand reduced accordingly.
- (4) The promotion criteria shall be as per the existing Ordinances for University Examinations, as applicable to respective courses. In addition, the same criteria shall apply to the total of the University Examination and the Internal Assessment, taken together.
- (5) (i) There shall be a Monitoring Committee for Internal Assessment at the University level consisting of the Dean of Colleges as the Chairperson along with three other Deans one of whom shall be a member of the Executive Council, and the Controller of Examinations as Member-Secretary. The Committee shall monitor the receipt of Internal Assessment marks from various colleges and ensure timely compliance. If a College fails to submit the Internal Assessment marks in time, the University shall not declare the result for such a course in that College. The responsibility for non-declaration of the result of any course in the College in such circumstances will be solely that of the College.
- (ii) There shall be a Monitoring Committee for Internal Assessment in every College, which shall be chaired by the Principal of the College and will be made up of the Vice-Principal (and in case there is no Vice- Principal, the Bursar), Secretary Staff Council, and two senior faculty members to be nominated by the Principal. This Committee shall be responsible for the entire process of Internal Assessment in the College, including redressal of grievances, if any.
- (6) (i) In the case of students who repeat one or more paper(s), or all papers of any part or semester, the Internal Assessment marks shall be carried forward.
- (ii) In the following special cases, in lieu of Internal Assessment, students shall be awarded marks (for the previous years. papers) in the same proportion as the marks obtained in that paper in the University Examination:
  - a) Students who migrate from other Universities to the University of Delhi in the 2<sup>nd</sup> Year/Third Semester.
  - b) Students who fail in the Part I Examination of Honours Courses and join Pass/General Courses in the 2<sup>nd</sup> year; and
  - c) Students who transfer from 1st year Pass/General Courses to Honours Courses in the second year.

## ANNEXURE

- (iii) Students who migrate from non-formal streams in the University of Delhi (i.e. School of Correspondence Courses and Continuing Education, Non Collegiate Women's Education Board and Non-Formal Education Cell, formerly External Candidates Cell) to the Regular stream and vice versa, shall carry as such the Marks obtained in the preceding year(s).
- (7) Tutorials shall be held regularly for the post-graduate courses of the University by the concerned Department in cooperation with Colleges; and atleast 25% marks shall be assigned for Internal Assessment in each paper of the post-graduate courses. The Internal Assessment in the post graduate courses may be based on regularity and attendance; class tests and house examination; and written assignments, projects/term papers/seminars/fieldwork. Post-graduate courses where the weightage of Internal Assessment is 25 per cent or more, Departments may continue with the existing Schemes
- (8) In the case of a student who is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defence work and allied duties, or in the case of a student who is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Head of the institution concerned, or a student who is selected to participate in sports or other activities organized by the Inter-University Board or in national or international fixtures in games and sports approved by the Vice-Chancellor, or a student who is required to represent the University at the Inter-University Youth Festival, or a student who is required to participate in periodical training in the Territorial Army, or a student who is deputed by the College to take part in Inter-College sports, fixtures, debates, seminars, symposia or social work projects, or a student who is required to represent the College concerned in debates and other extracurricular activities held in other Universities or such other activities approved by the Vice-Chancellor, the following provision will apply:
  - i. A student in the categories listed above, will have to fulfill the requirement of written assignments and projects/ term papers / seminars / field-work with the flexibility, however, that he/she may, if necessary, be allowed additional time for submission of written assignments.
  - ii. A student in the categories listed above, who is unable to write the House Examination/Class Test (s) / Quiz(s) on account of his/her participation in such aforesaid activities, may be assessed by the College through an alternative mode. This may be done only in exceptional circumstances.
  - iii. A student in the categories listed above, will get the benefit of attendance for Internal Assessment for the classes missed as per the existing provisions of Ordinance VII.2.(9)(a) (i)
- (9) (i) The University reserves the right to review, and if necessary moderate the marks in Internal assessment in any paper/ papers in any College/ Department.
  - (ii) The respective University Moderation Committees in each subject shall moderate, if necessary, the Internal Assessment marks across Colleges.

**THE RELEVANT PROVISIONS OF ORDINANCE IX OF UNIVERSITY OF DELHI VIDE NOTIFICATION NO. CNC II/093/2017-18/49 DATED 8TH MAY, 2017 REGARDING CLASSIFICATION OF RESULTS ARE AS FOLLOWS:**

**Passing and Promotion Rules for all the Under-Graduate Courses under Choice Based Credit System (CBCS) shall be as under:**

- (i) A student who appears in an odd semester examinations or who was eligible to appear in the odd semester examinations but remains absent in any or all the papers of the said semester, shall move on to the next even semester irrespective of his/her result in the said examinations.
- (ii) **Passing Rules:** The results shall be prepared on the basis of the formula prescribed at Table 'A' with the computation of grade cut off.
- (iii) **Promotion Rules:** A student shall be eligible for promotion from 1<sup>st</sup> year to 2<sup>nd</sup> year/III semester provided he/she has passed 50% papers of I and II semester taken together and similarly for promotion from 2<sup>nd</sup> year to 3<sup>rd</sup> year/V semester.
- (iv) The students shall be declared fail as per the formula prescribed at **Table 'A'**. However, they shall have the option to retain the marks in the paper in which they want to retain.
- (v) **Eligibility for award of degree:** A student shall be declared eligible for degree provided he/she passed all the papers of 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year of a course.
- (vi) A student who wants to reappear for improvement of marks in a paper prescribed for Sem I/III/V may do so only in the semester examinations to be held in November-December. A student who wants to re-appear for improvement in a paper prescribed in semester II/IV/VI may do so only in the examinations to be held in May/June.



# ANNEXURE

## Reappearance for Improvement

- i. A student may re-appear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (e.g., a student re-appearing in paper prescribed for Semester examination may do so along with subsequent semester III examination and not along with papers for semester V).
- ii. A student who has cleared examinations of third academic year (V and VI semester) may reappear in any paper of V or VI semester only once, at the immediate subsequent examinations on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period.  
  
(**Note:** the candidate of this category will not be allowed to join any post graduate courses)
- iii. In the case of reappearance in paper, the result will be prepared on the basis of candidate's current performance in the examinations.
- iv. In the case of a candidate, who opts to reappear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to reappear shall be taken into account while determining her/his result of the examinations held currently.
- v. Re-appearance in practical/internal assessment shall not be allowed.
- vi. All papers of Core, Elective, AECC and SEC shall be for 100 marks each and 25 marks shall be for internal assessment.
- vii. Examination for practical wherever applicable shall be based on continuous evaluation.
- viii. Duration of end semester theory examinations of core and elective subjects shall be three hours.
- ix. There shall be no internal assessment in practical papers.
- x. There shall be no supplementary examinations.

## Letter grades and grade points

The results for the all the Undergraduate courses under the CBCS shall be based on a 10 point grading system with Letter Grades as per the formula as at Table 'A' below:

**Table 'A'**

**Issue of Transcripts:** Based on the grades earned, a Grade Certificate shall be issued to all the registered students by the University after every semester and a consolidated transcript indicating the performance in all semesters. The Grade Certificate will display the course details (code, title of the paper, number of credits, grade secured) along with SGPA of each semester and CGPA earned based on overall six semesters.
