# Ranked amongst top colleges of India

Our college has been ranked as 21st best college in India out of 2270 participating colleges in The National Institutional Ranking Framework (NIRF) 2022 ranking released by Ministry of Education, Government of India.

## India Today Survey

The college achieved the distinction of being ranked 11<sup>th</sup>, 17<sup>th</sup> and 37<sup>th</sup> amongst Science, Commerce & Arts colleges in India by the India Today-MDRA Best Colleges Ranking 2022.

#### Award Winning Campus Building

The present campus of the college was awarded Vishwakarma Award 2017, for its state of art building. All the classrooms, lecture theatres, library, computer center, cafeteria and most of the laboratories are fully air- conditioned. The campus has Rain water harvesting, Solar power generation and Sewage treatment plant with water recycling plant facility.

# PBT Star College

In 2018, DBT sanctioned a sum of Rs. 1.04 cr. for three years under the Star College Scheme. In 2021, the college has been awarded Star College status by Govt. of India for another three years. # **Important Points**

- 1. Admission to all Undergraduate Programs at the University of Delhi is based only on the scores obtained in CUET 2022 (except for admissions to the School of Open Learning (SOL), Non-Collegiate Women Education Board NCWEB, and Foreign Nationals).
- 2. The applicant must be a citizen of India for CUET 22 based admission.
- 3. The candidate must have studied and passed Class XII Examination or its equivalent from a single recognized board in India or any foreign country recognized as equivalent to 10+2 system by the Association of Indian University.
- 4. The marks obtained by the candidate in CUET 2022 will be considered for computing the total marks according to the Program-Specific combinations of subjects for deciding merit and granting admissions in the undergraduate programs. Merit will be based only on the 'combination of subjects in which a candidate has appeared in CUET 2022' as mentioned in the respective Program-Specific Eligibility.
- 5. As per ordinance-I of University of Delhi, there is no minimum age bar for admission to the undergraduate programs in the University and its colleges except in the programs where the respective regulatory bodies, such as Medical Council of India (MCI), All India Council of Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.
- 6. Gap year will not be a bar for purpose of admission to undergraduate programs. However, such candidates must have appeared in CUET-2022 for admissions.

# Notes

- 1. Entry level eligibility: The general feeder category for entry into Level 5 is the Secondary School Leaving Certificate obtained after successfully completing Grade 12. A programme of study leading to entry into the first year of the Bachelor's degree is open to those students who have met the entrance requirements, including specified levels of attainment at the secondary level of education mentioned in the programme admission regulations. Admission to the Bachelor degree programme of study is based on the evaluation of documentary evidence (including the academic record) of the applicant's ability to undertake and complete a Bachelor's degree programme which is specified in the UGC Guidelines for Multiple Entry and Exit Scheme in Academic Programmes Offered in Higher Education.
- **2. Number of hours of a credit course:** It shall be defined by its component of lecture, tutorial and practical.
- 3. Every student has to study "Environmental Science and Sustainable Development" courses I and II of two credits each in the first year (I/II semester) and the second year (III/IV semester), respectively. The AEC pool will also consist of credit courses in languages listed in the Eighth Schedule of the Constitution of India, as updated from time to time. The University of Delhi shall extend necessary support to those Colleges (where faculty is not available) which may require it in course of teaching learning in these languages.
- **4. Design of degrees:** Students shall be able to design their own degrees according to their mission and aspiration for a future befitting to their ability and attainment, rather than following the conventional pathway.
- 5. A student who pursues three years undergraduate degree programme in a specific discipline as a Core course [for example, B. A. (Honours) English, B. Com (Honours), B. Sc. (Honours) Physics and such other Programmes] will earn at least 80 credits in that discipline (from 18 DSCs and at least 2 DSEs of that discipline) and shall be awarded Honours degree in that discipline, if he/she exits after completion of VI semester.
- 6. A student who pursues three years undergraduate degree programme in more than one discipline as core courses of study (for example B.A. in Social Sciences/ Humanities, B.Sc. in Life Sciences, B.Sc. in Physical Sciences, B.Sc. in Mathematical Sciences, Bachelor in Commerce Studies and such other programmes) he/she shall be awarded Bachelor's degree in that field of multidisciplinary course of study, if he/she exits after completion of VI semester.
- 7. If a student wishes to pursue four years Honours Degree with research, he/she shall compulsorily opt for a Research Methodology course in either VI Semester or VII Semester as GE.
- **8. Dissertation/Academic Project/Entrepreneurship** in the 4th year shall commence from VII semester and conclude in VIII semester. Detailed outcomes of each track chosen out of these three options shall be notified and assessment at the end of VII and VIII semesters shall be done accordingly.
- **9. Dissertation** may be written in the Major or Minor or Interdisciplinary (combination of Major and Minor) discipline.
- 10. If a student mentioned at (6) above continues or re-enters the fourth year for pursuing an Honours degree in that field of multidisciplinary study, he/she has to choose only one of the disciplines he/she had studied as core courses of study in the previous six semesters and earn credits from the 2DSCs and 6DSEs of that chosen discipline in the VII and VIII semesters and write dissertation or opt for Academic Project or Entrepreneurship.

- 11. If a student mentioned at (5) above, continues or re-enters to study the VII and VIII semesters in the same discipline, and writes dissertation mentioned at (9) above, but no Minor discipline is made out (i.e., credits earned in the GEs of any one discipline is less than 28 credits), then he/she shall be awarded 'Honours with Research' with Major in that discipline on successful completion of VIII Semester.
- 12. A student mentioned at (6) above, shall be awarded 'Honours' degree in that field of multidisciplinary study on successful completion of VIII semester. For example, B.A. (Honours) Social Sciences/ Humanities, B.Sc. (Honours) Life Sciences, B.Sc. (Honours) Physical Sciences, B.Sc. (Honours) Mathematical Sciences and Bachelor in Commerce Studies (Honours). Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2)(b) and III(3)(b), respectively. For instance, a student who pursues four years B.A. (Honours) in Social Sciences/ Humanities with History, Political Science and Hindi as core courses, shall get Major in History, on successful completion of VIII semester, if he/she earns minimum 80 credits in History from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History. Such a student shall get a Minor in Political Science/Hindi, if he/she earns minimum 28 credits from 6 DSCs and one DSE of Political Science/Hindi.
- 13. Only a student mentioned at (5) above who opts to write a dissertation in the Major/Minor subject in VII and VIII semesters in the fourth year, shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Research) in Discipline'. For instance, a student who pursues B.Sc. (Honours) in Physics and writes a dissertation on a topic relating to Physics or the Minor in VII and VIII semesters, shall be awarded 'Bachelor of Science (Honours with Research) Physics. Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2)(a) and III(3)(a), respectively.
- 14. A student who opts for 'Academic Project' or 'Entrepreneurship' in VII and VIII semesters, instead of writing dissertations, and has earned 28 credits in the relevant GEs, SECs, AECs & IAPC, shall be awarded Minor in Academic Project or Entrepreneurship, as the case may be. 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major) & Academic Project/ Entrepreneurship (Minor)'. If he/she is unable to earn the requisite 28 credits, he/she shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major).
- 15. A student who pursues four-year undergraduate degree programme shall be awarded after completion of the VIII semester an appropriate degree.
- 16. Exit Options: The minimum credit to be earned by a student per semester is 18 credits and the maximum is 26 credits. However, students are advised to earn 22 credits per semester. This provision is meant to provide students the comfort of the flexibility of semester- wise academic load and to learn at his/her own pace. However, the mandatory number of credits have to be secured for the purpose of award of Undergraduate Certificate/ Undergraduate Diploma/ Appropriate Bachelor's Degree in the field of Study/Discipline, to a student who chooses to exit at the end of even semesters.
- 17. The course code, number of credits, components of lecture, tutorial and practical, pre-requisites to be fulfilled for choosing that course and the department offering the course shall be spelt out for each course. A student should fulfil the pre-requisites of a course to be able to opt it for study.

\* In case a candidate has passed subjects/s from more than one board, s(he) can appear for CUET 2022 in the subjects in which (s)he has passed Class XII; however, for the purpose of ascertaining the Minimum Eligibility, the marksheet/ degree of only one board will be considered (For example, if a candidate has appeared in CBSE Board Examination with five subjects except for Mathematics and later appears and passes Mathematics from another board such as the National Institute of Open Schooling (NIOS), the minimum eligibility shall be ascertained from his/her mark sheet issued by CBSE only).

# RESERVATION OF SEATS FOR SCHEDULED CASTE (SC) AND SCHEDULED TRIBE (ST) CANDIDATES

22.5% of the total numbers of seats is reserved for Candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).

The Candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission. The Caste certificate should clearly state:

- (a) Name of his/her caste/tribe
- (b) Whether candidate belongs to SC or ST
- (c) District and the State or Union Territory of Candidate's usual place of residence, and
- (d) the appropriate Govt. of India Schedule under which his / her caste / tribe is approved as SC or ST.

Candidate will have to produce the valid original SC or ST caste/tribe certificate at the time of admission.

The following are empowered to issue the requisite SC / ST certificate:

- District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant
- 2. Chief Presidency Magistrate / Chief Presidency Magistrate / Presidency Magistrate.
- 3. Revenue Officer not below the rank of
- 4. Sub- Divisional Officer of the area where the Candidate and/ or his family normally
- 5. Administrator / Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

Candidates to note that the SC / ST Certificate from any other person / authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste / tribe must be listed in the appropriate Govt. of India Schedule.

It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe Candidates.

Colleges shall not refuse admission to any SC / ST Candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.

# RESERVATION POLICY FOR ECONOMICALLY WEAKER SECTIONS (EWS)

As per the University of Delhi notifications (Reference No. Aca. I / Reservation of EWSs / 2019/ 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission of candidates belonging to EWS category.

# RESERVATION OF SEATS FOR OTHER BACKWARD CLASSES (OBC, NON-CREAMY LAYER, CENTRAL LIST)

27% seats are reserved for the Candidates belonging to Other Backward Classes (OBC - Non-Creamy Layer, Central List).

At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website <a href="http://ncbc.nic.in/backward classes/index.html">http://ncbc.nic.in/backward classes/index.html</a>.)

The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993).

The OBC Candidates who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the Candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res- I) dated 31 March 2016). The Certificate should have been issued after 31st March, 2022.

It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC Candidates.

# RESERVATION OF SEATS FOR PERSONS WITH BENCHMARK DISABILITIES (PwBD)

#### A. Locomotor Disability

Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—

- 1. "leprosy cured person" means a person who has been cured of leprosy but is suffering from
  - i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifestation of deformity;

- ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
- iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- **2.** "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- **3.** "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimetres) or less;
- 4. "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue
- **5.** "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance
- B. Visual impairment
- **6.** "blindness" means a condition where a person has any of the following conditions, after best correction
  - i. total absence of sight; or
  - ii. visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
  - iii. limitation of the field of vision subtending an angle of less than 10
- 7. "low-vision" means a condition where a person has any of the following conditions, namely:
  - i. visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
  - ii. limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.
- C. Hearing Impairment
- 8. "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- **9.** "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears:
- **10.** "speech and language disability" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes

#### D. Intellectual Disability

A condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—

11. "specific learning disabilities" means a heterogeneous group of conditions wherein there is a

deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;

**12.** "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

#### E. Mental Behaviour

"Mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by sub-normality of intelligence.

- F. Disability caused due to Chronic neurological conditions, such as—
- **13.** "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are dam- aged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
- **14. "Parkinson's disease"** means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

#### G. Blood Disorder

- **15.** "haemophilia" means an inheri1table disease, usually affecting only male but trans- mitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding;
- **16. "Thalassemia"** means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin;
- **17.** "Sickle cell disease" means a haemolytic disorder characterised by chronic anaemia, painful events, and various complications due to associated tissue and organ damage; "haemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.
- H. Multiple Disabilities (more than one of the above specified disabilities)

Multiple disabilities including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

Any other category as may be notified by the Central Government.

# RESERVATION FOR CHILDREN/ WIDOWS OF PERSONNEL OF THE ARMED FORCES (CW)

Five percent (5%) of seats are reserved for Candidates under this category, program-wise in all colleges.

Candidates desirous of taking admission under the CW quota of the University must have appeared in CUET 2022.

All such Candidates have to upload the Educational Concession certificate issued by **any of the following authorities** on the proper letterhead:

- a. Secretary, Kendriya Sainik Board,
- b. Secretary, Rajya Zila Sainik
- c. Officer-in-Charge, Record Office.
- d. 1st Class Stipendiary
- e. Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.

Candidates desirous of taking admission under the Kashmiri Migrants quota must appear in CUET 2022.

Candidates desirous of taking admission under the Sikkim nomination scheme must appear in CUET 2022.

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion.





Out of the interest earned from endowment funds in the name of Shri Sultan Chand Dropadi Devi (instituted by Shri Sultan Chand Dropadi Devi Education Foundation), six scholarships of Rs. 4000/- each is awarded to the students securing highest marks in each semester of the three year B. Com (Hons) is awarded.

#### FROM STATE GOVERNMENTS TO SC/ST/OBC /MINORITIES STUDENTS

Department for Welfare of SC/ST/OBC / Minorities, Govt. of NCT Delhi for hostel facilities provided by the Department.

#### FEE CONCESSION

The College gives fee concession to needy, deserving and meritorious students. Application on prescribed forms is to be submitted to the Accounts Section. The dates shall be notified on college website. The College also provides exemption of Tuition Fee and Admission Fee to all SC/ST students, whose parents are not liable to pay income tax on their income on submission of a certificate from employer/competent authority for the same.

#### STUDENTS AID FUND (SAF)

Students belonging to Muslims, Sikhs, Christian, Buddhist, Jain & Zorastrians (Parsis) Communities who have secured not less than 50% marks or equivalent grade in the previous final examination & the annual income of whose parents/guardian from all sources does not exceed Rs. 2,00,000.

### 3. Post Matric Scholarship for students with disabilities (Department of Empowerment of Person with disabilities)

Students with more than 40% disability and having a valid certificate of disability as prescribed under rules issued by the competent authority and whose parent's income from all sources does not exceed Rs. 2.5 lakhs.

#### Our College

Built on a plot of 7.7 acres in Dwarka (Sector 3), campus of the College is a state of the art building. It is a multi-storey building (basement + 7 floors) with a holistic concept of a green building. Rain water harvesting system and water recycling plant are already in place. #### LECTURE HALLS: INTERACTIVE TEACHING-LEARNING

The College has twelve well laid-out lecture halls that have a seating capacity of 70 each, 36 lecture rooms having a capacity of 40-60 and 2 seminar rooms with a capacity of 100-150 each. The desks are well spaced out and the halls are airy, well-lit and have fine acoustics. Each hall also has the latest audio visual teaching aid.









#### LABORATORIES: ENHANCING SKILLS

The College has three computer laboratories with over 140 computers of the latest configuration and internet facility through the Delhi University optical fiber connection. The laboratories are fully equipped with the latest multimedia equipment including LCD projectors and will also have facilities for Video Editing, Image Editing, Animation, Audio-Editing and Authoring Tools. There are four Physics laboratories and two Electronic laboratories which have state-of-the-art equipment to conduct experiments. These laboratories are equipped with 35 CROs, 55 Function Generators, 37 Micro-processor Kits, 48 Digital Storage Oscilloscopes (Tektronix), Arbitrary Function Generators (Tektronix), 57 Computers, 22 Spectrometers, besides other equipment including: Hall effect Michelson set-up, Interferometer, Laser Kits, Optical fiber kits etc.

To conduct experiments in Life Sciences, there are two Museums containing various specimens and models and two laboratories each of Botany and Zoology, well equipped with latest instruments that include Microscopes having 15000 x magnifications. For Chemistry there are three laboratories of which, one is an Analytical Technique Laboratory equipped with instruments like Flame Photometer, UV-Visible Spectrophotometer.

#### RESEARCH FACILITIES: PROMOTING INNOVATION

The College has various Research Laboratories that provides facilities to the faculty to work on research projects. Besides, there is a DBT Star College Program lab too. The college has also created an endowment fund of Rs. 3 Crore. out of its interest. The research grant between Rs. 1,00,000 to Rs. 3,00,000 is also provided to the faculty to promote research culture in the college.



#### COMPUTER CENTRE (ICT): SIMPLIFYING TECHNOLOGY

The Campus has a centrally Air Conditioned Computer Centre on the second floor of the C block, with a capacity of about 200 users to promote network based knowledge and learning. The ICT infrastructure consists of a server, desktops and a gigabit fiber backbone which provides 24x7 dedicated Internet connectivity through WLAN (Wi-Fi) and LAN.

#### **AUDITORIUM**

A state of the art Auditorium with a seating capacity of about 400 is centrally air- conditioned and is fully equipped with audio- visual facilities. The stage has wooden flooring to facilitate activities like dances, drama and concerts.



#### LIBRARY RESOURCE AND INFORMATION CENTRE:

The college has excellent central library facility sprawling across three floors with centralized air conditioning facility. It has a total floor area of 2,550 sq. meters, with a provision for a separate reading section for the faculty and spacious reading hall to accommodate over 200 students. The library is fully computerized with all its function and operations being performed through a dedicated network of 21 computer systems using library software. The library organizes separate User Orientation Program every year for the new batch in its reading hall on the day of Orientation day of the college. Students are given detailed information and instructions on the use of library resources.

**COLLECTION:** The library has a rich and active collection of text-books and reference books which is extensively utilized by the students. It has up-to-date bibliographic database of books and journals. The library has total collection of **49,188 volumes** of text-books and reference books. It subscribes to **30 journals & magazines** of national and international repute in all the relevant subject areas. Besides this, the library subscribes to **13** national newspapers. It has 613 bound volumes of journals and 850 CDs in its collection. The entire collection is heavily used by the students and faculty with a footfall of approx. 35000 visitors, resulting in 25000 transactions of volumes of books in the preceding year. Around 82 students of the weaker-section were also issued books under **book-bank facility**.

**SERVICES AND FACILITIES:** The library provides book-bank facility to students belonging to SC/ST/OBC categories and other economically poor and meritorious students of the college. Through the University dedicated fiber-optic link and other resource sharing network, the library has access to many important databases, thousands of e-journals and lakhs of e-books. The entire college campus including the library are Wi-Fi enabled to provide 24X7 seamless access to information remotely from anywhere in the campus. The library provides internet browsing, database search and print out facility. To promote use of books and e- resources, the library also conducts workshops and seminars. Every registered member of the library is provided with User ID and Password for remote access to e-books and journals. The Library provides specialized reading services to visually impaired students using camera scanner and assistive software.

LIBRARY PRIVILEGES: Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non- transferable. Every student is entitled to borrow four library books for a period of 10 days. Books retained beyond the prescribed due date is charged a late fine of Re. 1/- per day for the first five days of delay and subsequently Rs. 3/- per day for remaining period of delay.

**WORKING HOURS:** The working hour of the library is from 9:00 AM to 5:00 PM on all working days. It also remains open till 8:00 pm an all regular working day towards the end of every semester from one month prior to till last day of examination. During this period the library also remains open on Saturdays.





#### INDOOR SPORTS COMPLEX

The college has indoor facility of squash, badminton, table tennis, carom, chess and gymnasium. In outdoors, there is an archery range. The other outdoor facilities are in the process of being created.

#### **CAFETERIA**

The College has an air conditioned cafeteria which is equipped with very good furniture and has a good ambience. The Seating capacity is around 100. Separate space is earmarked for staff members. A variety of food items at affordable rates are available in the cafeteria.



#### GIRL'S & BOY'S COMMON ROOM

The college has a Girl's Common Room (Room # 311) and Boy's Common Room (Room #316) equipped with study tables, chairs, lounges, beds. A sanitary napkin vending machine is also provided in the girl's common room.







#### LANGUAGE LAB

The college has made a state of art Language Laboratory functional from the session 2020-21. It is equipped with latest desktops with interactive and dynamic software for language learning. It has a capacity to accommodate forty learners in one batch. The learner learns language through audio visual materials. Moreover it has a huge volume of computer based exercises and activities which a learner can access to practice and attain perfection. The lab could be used specially by the students who need to improve their communication skills in English. However the lab is equipped to teach not only English but also other languages such as French, German Spanish.

#### **RULES & REGULATIONS**

#### **ATTENDANCE**

i. Every student admitted to the College is required to attend lectures, tutorials and practicals as per the college time table. No student will be permitted to appear in the University examinations unless he/she has attended at least two thirds of the lectures/ tutorials/ practicals/ presentations held in all subjects taken together in each semester. For further details, please refer Ordinance VII (2), University of Delhi.

ii. Attendance will be taken from day one of the new session. Students are expected to check the status of their attendance record which will be displayed on the students" notice board/ college website from time to time.

iii. If a student is unable to attend classes because of medical reasons, he/ she must submit a medical certificate as well as fitness certificate to the College Office not later than a week of rejoining College after illness. Medical certificates submitted late will not be accepted by the College.

iv. A student, whose name is struck off from the College rolls on account of non-payment of fees or disciplinary action and later re-admitted, will not be given the benefit of attendance during that period.

**Migration:** The College does not permit any outward migration from the college. The Principal may at his discretion, permit inward migration in second year only.

**Removal from the College:** The Principal is empowered to remove the name of a student from the college rolls if, in the opinion of the Principal, he/she (i) is grossly irregular in attendance or (ii) is not amenable to the college discipline or (iii) is guilty of gross negligence in studies or (iv) is not found fit for the course chosen by him/her or (v) has not paid College dues in time.

**Re-Admission:** A student, whose name is removed from the college rolls for non-payment of fees or for any other reason, may be permitted re-admission at the discretion of the Principal on written request by the student. Such readmission shall be on payment of re-admission fees, arrears of tuition fees and fines, after the permission is granted.

**Notice Board / Website:** Students should make it a habit to read the notice board/website regularly to check notices for schedule of classes, examinations, holidays, activities and other information of relevance. Ignorance of any notice will not be accepted as a plea or an excuse for any delay in any matter.

**Identity Card:** After admission to the college, every student will be issued an Identity Card, which he/she should always carry and present it as and when asked for. Failure to do so will render a student liable to disciplinary action. The card must be returned when a student leaves the college. Loss of Identity Card should be reported to the office immediately. Duplicate Identity Card will be issued on payment of Rs 50/-.

**Library Card:** Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable.

**Visitors:** Students are not permitted to receive or entertain visitors in the college. In case of extreme urgency they must seek prior permission from the Principal or in his absence from the Vice Principal / Administrative Officer.

**Residential Address:** In case of change in residential address, the same must be intimated in writing under the signature of parents/guardians to the college Office without delay.

**Internal Assessment:** Internal Assessment is governed by the Ordinance VIII E of the University of Delhi, as amended and notified by University of Delhi from time to time.

**Passing and Promotion Criteria:** Passing and Promotion Criteria is governed by Ordinance IX of University of Delhi, as amended and notified by the University from time to time. The relevant provisions of the amended Ordinance IX as on date are given in the following pages.

**Ragging:** Ragging in any form is strictly prohibited. Any student found involved in ragging will be punished under Ordinance XV-C of the University of Delhi (see Annexures). Besides action shall also be initiated as per directives issued by the Hon'ble Supreme Court of India.

**Discipline:** Students are required to maintain discipline in the college premises. Violation of the same will be dealt with as per the Ordinance XV-B of the University of Delhi (see Ordinance).

**Meeting hours with the Principal:** The parents can meet the Principal on any Tuesday or Thursday between 10.00 a.m to 11.00 a.m. without an appointment or else on other days with prior appointment.

The parents of a student who is short of attendance are required to meet the College authorities as and when intimated.

#### **ANTI-RAGGING DIRECTIVES**

#### DIRECTIVES OF THE HON'BLE SUPREME COURT OF INDIA ON ANTI-RAGGING

Reference: Directives of the Supreme Court of India dated May 16, 2007 in SLP No(s) 24295 of 2006 University of Kerala Vs Council, Principal's, Colleges, Kerala & Ors (with SLP(C) No. 24296-99/2004 & WP. (Crl) No.173/2006 and SLP(C) No. 14356/2005) and Civil Appeal No. 887 of 2009 dated May 8, 2009.

The Hon'ble Supreme Court of India admitted and heard the above referred SLPs in relation to the menace of ragging in Technical Institutions/Universities/ Colleges in the Country.

In this connection a committee headed by Dr. R.K. Raghavan, Former Director of CBI, for giving specific recommendations on effective prevention of ragging in educational institutions was constituted by the apex court. Accordingly, the Committee had carried out a very detailed study on the various factors contributing for ragging and collected the public opinion. Further, the committee had submitted a detailed report with suitable recommendations and measures required to effectively curb the menace. The recommendations of the Committee were duly accepted and the following directives have been issued to all the educational institutes for necessary implementation by the Hon'ble Court. The Hon'ble Court issued further orders on the 2nd and 3rd report of the Raghavan Committee also.

The salient features of the report / order are summarized below:

#### I. Factors listed by the Committee

- a) Primary responsibility for curbing ragging rests with academic institutions themselves.
- b) Ragging adversely impacts the standards of higher education.
- c) Incentives should be available to institutions for curbing the menace and there should be disincentives for failure to do so.
- d) Enrolment in academic pursuits or a campus life should not immunize any adult citizen from penal provisions of the laws of the land.
- e) Ragging needs to be perceived as failure to inculcate human values from the schooling stage.
- f) Behavioral patterns among students, particularly potential 'raggers', need to be identified.
- g) Measures against ragging must deter its recurrence.
- h) Concerted action is required at the level of the school, higher educational institution, district administration, university, State and Central Governments to make any curb effective.
- i) Media and Civil Society should be involved in this exercise.

#### II. Recommendations approved by the Supreme Court

- 1. The punishment to be met out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
- 2. Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied with the institutional arrangement for action, a First Information Report must be filed without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority or negligence or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the institutional authority.
- 3. If any victim or his parent/guardian of ragging intends to file FIR directly with the police, that will not absolve the institutional authority from the requirement of filing the FIR.
- 4. In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he /she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
- 5. It shall be the collective responsibility of the authorities and functionaries of the concerned institution and their role shall also be open to scrutiny for the purpose of finding out whether they have taken a effective steps for preventing ragging and in case of their failure, action can be taken; for example, denial of any grant-in-aid or assistance from the State Governments.



- 6. Anti-ragging committees and squads shall be forthwith formed by the institutions and it shall be the job of the committee or the squad, as the case may be, to see that the Committee's recommendations, more particularly those noted above, are observed without exception and if it is noticed that there is any deviation, the same shall be forthwith brought to the notice of this Court.
- 7. The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the anti-ragging committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.
- 8. It is necessary that parents/guardians of fresher's assume responsibility for promptly bringing to the notice of the Principal any instance of ragging.

#### **ORDINANCE XV-B**

#### MAINTENANCE OF DISCIPLINE AMONG STUDENTS OF THE UNIVERSITY

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
  - Physical assault, or threat to use physical force, against any member of the teaching and non- teaching staff of any Institution/Department and against any student within the University of Delhi
  - Carrying of, use of or threat to use of any weapons
  - Any violation of the provisions of the Civil Rights Protection Act, 1976.
  - Violation of the status, dignity and honor of students belonging to the scheduled castes and tribes.
  - Any practice-whether verbal or otherwise derogatory of women.
  - Any attempt at bribing or corruption in any manner.
  - · Willful destruction of institutional property.
  - Creating ill-will or intolerance on religious or communal grounds.
  - Causing disruption in any manner of the academic functioning of the University system.
  - · Prohibition of Ragging as per Ordinance XV-C
- 4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice- Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students
  - •be expelled; or
  - •be, for a stated period rusticated; or
  - •be not, for a stated period, admitted to a course or courses of study in a College, Department or
  - •Institution of the University; or
  - •be fined with a sum of rupees that may be specified; or
  - •be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or that the result of the student or students concerned in the Examination or Examinations in which he /she or they have appeared be cancelled.
- 5. Institutions, halls, and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to such of the teachers in their colleges, Institutions or Departments as they may specify for these purposes.
- 6. Without prejudice to the powers of the Vice Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.
- 7. At the time of admission, every student shall be required to sign a declaration that on admission he/ she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University

#### **IMPORTANT ORDINANCES**

#### **ORDINANCE XV-C**

#### PROHIBITION AND PUNISHMENT FOR RAGGING

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which.
  - Involve physical assault or threat to use of physical force.
  - Violate the status, dignity and honor of women students.
  - Violate the status, dignity and honor of students belonging to the scheduled castes and tribe.
  - Expose students to ridicule and contempt and affect their self-esteem.
  - Entail verbal abuse and aggression, indecent gestures and obscene behavior.
- 4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging,
- 5. Not withstanding anything in Clause (4) above, the Proctor may also suo-moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/ she may so advise the Vice- Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrences of ragging incidents described in Clause 3(a), (b) and (c), the Vice- Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a College, departmental examination for one or more year or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case any students who have obtained degrees or diplomas of Delhi University are found guilty; under this Ordinance, appropriate action under Statute 15 for withdrawal of degrees or diploma conferred by the University will be taken.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice incitement of ragging will also amount to ragging.

13. All Institutions within the Delhi University system shall be obligated to carry out instructions/ directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

#### Note:

Order of the Vice-Chancellor in pursuance of Ordinance XV-C: Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order, Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi, Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

Amendments to Ordinance VII of the Ordinances of the University and to all other relevant Ordinances of the University regarding attendance rules for the 3-year semester based undergraduate programmes (Page No. 328 & 349 of the University Calendar Volume I (2004) (E.C.28.05.2015).

## **ORDINANCE - VII (2)**

- 1. A candidate for the Semester I/III/V Examination shall not be deemed to have satisfied the required conditions of attendance unless s/he has attended, in all the subjects taken together, not less than two thirds of the lectures/practical/presentations/tutorials required to be attended. Provided that a student of the Semester I/III/V who does not fulfill the required conditions of attendance, as above, but has attended, in all the subjects taken together, not less than 40 per cent of lectures/practical/presentations during the respective semester, may at the discretion of the Principal of the College concerned, appear for the ensuing semester examination; but such a candidate shall be required to make up the deficiency at lectures and practical's, in the next semester of the same academic year.
  - Provided that a student of the II/IV/VI semester who does not fulfill the required conditions of attendance as above, but has attended in all the subjects taken together, not less than 40 per cent of the lectures/practical/ presentation/tutorials, held during the respective semester, may at the discretion of the Principal of the College concerned, be allowed to appear at the ensuing examination provided that she/he makes up the deficiency of the said attendance by combining the attendance of the previous semester in the ensuing semester.
  - Provided further that the Principal of the College concerned may permit a student to appear in an examination notwithstanding that the student has not fulfilled the attendance requirement, if in the opinion of the Principal, such student shall make up the deficiency in the succeeding academic year. Provided further that a student of the VI semester shall be allowed to appear at the VI Semester Examination, if by combining the attendance of the three academic years, the candidate has put in two-thirds of attendance, in all the subjects taken together, held during the respective years.

#### 2. In the case of a student who:

- is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defense work and allied duties; or
- is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Principal/ Head of the institution concerned; or
- is selected to participate in sports or other curricular activities; or
- represents the college in inter-college tournaments organized by the Delhi University Sports Council (DUSC); or a student who represents Delhi State in National Tournaments organized by Nation Sports Federation; or a student who represent the University in Tournaments organized by Association of Indian Universities; or a student who represents India in International Tournaments organized by International Federation/Associations and FISU, (selection through AIU); or a student who represents India in Olympics/Common Wealth Games/Youth Games/World Championship organized by International Olympic Committee; or in national or international fixtures in games and sports approved by the Competent Authority; or
- is required to represent the University at the Inter- University Youth Festival; or is required to participate in periodical training in the Territorial Army or a student who is deputed by the College to take part in Inter-College sports or fixtures, debates, seminars, symposia or social work projects or a student who is required curricular activities held in other Universities or such other activities approved by the Vice-Chancellor for this purpose.
- In calculating the total number of lectures etc. delivered in the College, or in the University, as the case may be, for his/her course of study in each academic year, the number of lectures etc., in each subject delivered, during the period of absence, and as recommended/forwarded by the concerned teacher/DPE and approved by the Principal/Head for the above purposes shall deemed to have been attended by the student.

- 3. The Principal of a College may consider, on the basis of the Medical Certificates produced, exceptionally hard cases of students who had fallen seriously ill or had met with an accident during the year disabling them from attending classes for a certain period, with a view to determining whether the lectures etc. delivered during the said period, or a part thereof, could be excluded for purposes of calculation of attendance of the year and decide each case on its own merits.
- 4. Colleges shall be required to notify the attendance position of each of its students for each month on the notice board of the College, and clearly indicate the lectures/practical held subject wise and the numbers attended by each student.
- 5. A College shall notify on the notice board the final attendance position of each of its students within five days of the dispersal of the classes in the last session of the academic year. Not later than five days, thereafter, a student may, by an application to the Principal of the college, claim benefit of exclusion of lectures under sub-clause (a) above on grounds to be specified and accompanied by the relevant documents. All such applications submitted within time shall be considered and disposed of by the Principal of the College at least 3 days prior to the commencement of the examination, in which the student is intending to appear.
- 6. The benefit of exclusion of lectures contemplated in category (c) above, shall in no case exceed 1/3 of the total number of lectures / practicals / presentations / tutorials.
- 7. In the case of a married woman student who is granted maternity leave, in calculating the total number of lectures delivered in the College or in the University, as the case may be, for her course of study in each semester, the number of lectures in each subject delivered during the period of her maternity leave shall not be taken into account.
- 8. No person shall be deemed to have satisfied the required conditions in respect of his instructions, unless in addition to the requirements regarding attendance and other conditions, he has appeared and satisfied by his performance the Principal of his college in such tests, written and/or oral, as may be held by him in his discretion. The Principal of the College shall have, and shall be deemed always to have had, the power to detain a student in the same class in which he has been studying, or not to send him up for the University Examination, in case he did not appear at the tests aforesaid or his performance was not satisfactory. The Principal of a College/Head of the Institution shall have power to strike off the name of a student who is grossly irregular in attendance inspite of warning, or when the absence of the student is for such a long period that he cannot put in requisite percentage of attendance.



### ORDINANCE - XV- D

# THE SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013 (MINISTRY OF LAW AND JUSTICE)

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected therewith incidental there to. WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment; AND WHEREAS the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the Elimination of all forms of discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India. And whereas it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace. For details, please see the website

## **ORDINANCE - VIII- E**

#### INTERNAL ASSESSMENT

- 1. Internal Assessment:
  - i. The scheme for Internal Assessment shall be followed in the regular stream only, with exclusions as per the Appendix to the Ordinance, and shall be applicable to the students admitted from the academic session 2003-04 onwards (i.e. to begin with for the first year students) in both undergraduate and postgraduate degree courses. This scheme of Internal Assessment shall not be applicable to the School of Correspondence Course and Continuing Education, Non- Collegiate Women's Education Board and Non-Formal Education Cell (formerly External Candidates Cell). The specific Ordinances pertaining to schemes of examinations of various courses shall stand amended, mutatis mutandis, to the extent of internal assessment as laid down in this Ordinance, subject to exclusions referred to above.
  - ii. Internal Assessment marks shall be shown separately in the Marks Sheet issued by the University and these marks shall be added to the annual/ semester examination marks for determining the division of the student.
- 2. 25% of the maximum marks in each paper in undergraduate courses shall be assigned for Internal Assessment and the remaining 75% marks for the annual/semester University Examination; the time duration and other modalities of the annual/semester Examination with respect to this 75% component shall remain as per existing schemes of examination for various undergraduate courses.

i.

- a. For the Semester Examination Scheme, there shall be 10% weightage assigned to Class Test Quiz(s) to be conducted by each College, for all subjects in B.A., B. Com, and B.Sc. courses and all papers of the Main Subject in Honours courses.
- b. The University reserves the right to scrutinize some or all the scripts of any paper in any Course in a College during the period of retention of papers, which duration shall be till the declaration of results by the University, a copy of the question paper shall be sent to the Examination Branch of the University and the College shall maintain a proper record of the question papers of the House Examination.

ii.

- a. Each student shall be assessed on the basis of written assignments/tutorials as well as on the basis of project reports/term papers/seminars. There shall be 10% weightage for such written assignments; and project reports/presentations/term papers/seminars. Each student shall be given at least one written assignment per paper in each term, subject to a maximum of 12 written assignments per year for all the papers taken together.
- b. Where the maximum marks in a paper are less than 100, for example 50 marks, the nature of written assignments/tutorial work shall stand adjusted pari passu.periods).
- c. There shall be 5% weightage for regularity in attending lectures (including interactive and tutorials, and the credit for regularity in each paper, based on attendance, shall be as follows:

More than 67% but less than 70% - 1 mark, 70% or more but less than 75% - 2 marks, 75% or more but less than 80%- 3 marks, 80% or but less than 85%- 4 marks, 85% and above- 5 marks

[Medical certificates shall be excluded while calculating credit towards marks to be awarded for regularity, though such certificates shall continue to be taken into account for the purpose of calculating eligibility to appear for examinations as per the existing provisions of Ordinance VII.2.9.(a)(ii).]

- d. There shall be a Moderation Committee for Internal Assessment in each College, discipline-wise, which shall comprise of the senior most teacher in the department, the teacher-in-charge of the department and the previous teacher-in-charge of the department: provided that if, for any reason, the membership of the Committee falls below 3, the Principal of the college shall nominate suitable members from among the teachers of that department/college to fill the vacancies.
- 3. With the introduction of Internal Assessment, the maximum marks for the University Examination in each paper shall stand reduced accordingly.
- 4. The promotion criteria shall be as per the existing Ordinances for University Examinations, as applicable to respective courses. In addition, the same criteria shall apply to the total of the University Examination and the Internal Assessment, taken together.
  - i. There shall be a Monitoring Committee for Internal Assessment at the University level consisting of the Dean of Colleges as the Chairperson along with three other Deans one of whom shall be a member of the Executive Council, and the Controller of Examinations as Member-Secretary. The Committee shall monitor the receipt of Internal Assessment marks from various colleges and ensure timely compliance. If a College fails to submit the Internal Assessment marks in time, the University shall not declare the result for such a course in that College. The responsibility for non-declaration of the result of any course in the college in such circumstances will be solely that of the college.
  - ii. There shall be a Monitoring Committee for Internal Assessment in every College, which shall be chaired by the Principal of the College and will be made up of the Vice-Principal (and in case there is no Vice-Principal, the Bursar), Secretary Staff Council, and two senior faculty members to be nominated by the Principal. This Committee shall be responsible for the entire process of Internal Assessment in the College, including redressal of grievances, if any.
  - i. In the case of students who repeat one or more paper(s), or all papers of Part I or Part II or Part III, the Internal Assessment marks shall be carried forward.
  - ii. In the following special cases, in lieu of Internal Assessment, students shall be awarded marks (for the previous years' papers) in the same proportion as the marks obtained in that paper in the University Examination: (a) Students who migrate from other Universities to the University of Delhi in the IInd Year; (b) Students who fail in the Part I Examination of Honours Courses and join Pass/General Courses in the IInd year; and (c) Students who transfer from 1st year Pass/General Courses to Honours Courses in the 2nd year. (iii) Students who migrate from non-formal streams in the University of Delhi (i.e. School of Correspondence Courses and Continuing Education, Non-Collegiate Women's Education Board and Non-Formal Education Cell, formerly External Candidates Cell) to the Regular stream and vice versa, shall carry as such the marks obtained in the preceding year(s).
- 7. Tutorials shall be held regularly for the post-graduate courses of the University by the concerned Department in cooperation with Colleges; and at least 25% marks shall be assigned for Internal Assessment in each paper of the post-graduate courses. The Internal Assessment in the post-graduate courses may be based on regularity and attendance; class tests and house examination; and written assignments, projects/term papers/seminars/ fieldwork. Post-graduate courses where the weightage of Internal Assessment is 25 per cent or more, Departments may continue with the existing schemes.

- 8. In the case of a student who is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defence work and allied duties, or in the case of a student who is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Head of the institution concerned, or a student who is selected to participate in sports or other activities organized by the Inter-University Board or in national or international fixtures in games and sports approved by the Vice-Chancellor, or a student who is required to represent the University at the Inter-University Youth Festival, or a student who is required to participate in periodical training in the Territorial Army, or a student who is deputed by the College to take part in Inter-College sports, fixtures, debates, seminars, symposia or social work projects, or a student who is required to represent the College concerned in debates and other extra-curricular activities held in other Universities or such other activities approved by the Vice-Chancellor, the following provision will apply:
  - i. A student in the categories listed above, will have to fulfill the requirement of written assignments and projects/term papers/ seminars/field-work with the flexibility, however, that he/she may, if necessary, be allowed additional time for submission of written assignments.
  - ii. A student in the categories listed above, who is unable to write the House Examination on account of his/her participation in such aforesaid activities may be assessed by the College through an alternative mode in lieu of the House Examination. This may be done only in exceptional circumstances.
  - iii. A student in the categories listed above, will get the benefit of attendance for Internal Assessment for the classes missed as per the existing provisions of Ordinance VII.2.(9)(a)(i).
- i. The University reserves the right to review, and if necessary moderate the marks in Internal Assessment in any paper/ papers in any College/Department.
  - ii. The respective University Moderation Committees in each subject shall moderate, if necessary, the Internal Assessment marks across Colleges.

## ORDINANCE - IX - CLAUSE 12

THE RELEVANT PROVISIONS OF CLAUSE 12 OF ORDINANCE IX OF UNIVERSITY OF DELHI VIDE NOTIFICATION NO. CNC II/093/2017-18/49 DATED 8TH MAY, 2017 REGARDING **CLASSIFICATIONOF RESULTS ARE AS FOLLOWS:** 

12. Passing and Promotion Rules for all the Under-Graduate Courses under Choice Based Credit System (CBCS) shall be as under:

12 (i)

- A student who appears in an odd semester examination or who was eligible to appear in the odd semester a. examinations but remains absent in any or all the papers of the said semester, shall move on to the next even semester irrespective of his/her result in the said examinations.
- Passing Rules: The results shall be prepared on the basis of the formula prescribed at Table "A" with the b. computation of grade cut off.
- **Promotion Rules:** A student shall be eligible for promotion from 1<sup>st</sup> year to 2<sup>nd</sup> year/III semester provided c. he/she has passed 50% papers of I and II semester taken together and similarly for promotion from 2nd year to 3<sup>rd</sup> year/V semester.
- d. The students shall be declared fail as per the formula prescribed in Table 'A'. However, they shall have the option to retain the marks in the paper in which they want to retain.
- Eligibility for award of degree: A student shall be declared eligible for degree provided he/she e. passed all the papers of 1st year, 2nd year and 3rd year of a course as per clause 12(3) of Ordinance IX.

#### **Division Criteria**

A student shall be categorized on the basis of the combined result of Semester I to VI Examinations as follows: (based on the Conversion Formula for final Percentage)

60% or more (all papers should be passed)

- First Division

- 50% or more but less than 60% (all papers should be passed)
- Second Division
- Less than 50% and declared passed (all papers should be passed) Third Division
- A student who wants to reappear for improvement of marks in a paper prescribed for Sem I/III/V may do so only in the semester examinations to be held in November-December. A student who wants to re-appear for improvement in a paper prescribed in semester II/IV/VI may do so only in the examinations to be held in May/June.

#### 12(2) Reappearance for Improvement

- a. A student may re-appear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (e.g., a student re-appearing in paper prescribed for Semester examination may do so along with subsequent semester III examination and not along with papers for semester V).
- b. A student who has cleared examinations of third academic year (V and VI semester) may reappear in any paper of V or VI semester only once, at the immediate subsequent examinations on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period. (Note: the candidate of this category will not be allowed to join any post graduate courses
- c. In the case of reappearance in paper, the result will be prepared on the basis of candidate's current performance in the examinations.
- d. In the case of a candidate, who opts to reappear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to reappear shall be taken into account while determining her/his result of the examinations held currently.
- e. Re-appearance in practical/internal assessment shall not be allowed.
- f. All papers of Core, Elective, AECC and SEC shall be for 100 marks each and 25 marks shall be for internal assessment.
- g. Examination for practical wherever applicable shall be based on continuous evaluation.
- h. Duration of end semester theory examinations of core and elective subjects shall be of three hours
- i. The entire evaluation process for AECC and Skill Enhancement Courses (SEC) shall be undertaken by each college where the AECC and SEC are being taught and the teacher responsible for the conduct of learning of the AECC and SEC shall be responsible for the evaluation.
- j. There shall be no internal assessment in practical papers.
- k. There shall be no supplementary examinations.

#### 12(3) Letter grades and grade points

a. (a) A student who becomes eligible for the degree as per Ordinance IX, 12(1). Such a student shall be categorized on the basis of the combined result of semester I to semester VI examinations under CBCS on a 10 point grading system with the following Letter Grades as given below:

**Issue of Transcripts:** Based on the grades earned, a Grade Certificate shall be issued to all the registered students by the University after every semester and a consolidated transcript indicating the performance in all semesters. The Grade Certificate will display the course details (code, title of the paper, number of credits, grade secured) along with SGPA of each semester and CGPA earned based on overall six semesters.

The percentage shall not be displayed on the Grade Certification/Transcript. Only the formula approved for the conversion of CGPA into percentage will be displayed on the Grade Certificate/Transcript.

The results for the all the Undergraduate courses under the CBCS shall be based on a 10 point grading system with Letter Grades as per the formula prescribed by the University Grants Commission with minor changes in the computation of the grade cut offs as at Table 'A' below:

- (i) In those undergraduate courses under the CBCS, where the total number of students is upto 30, the results in Grades shall be prepared on the basis of the actual performance of the student in the percentage scale and not on the basis of the formula approved for computation of grades.
- (ii) The formula for calculating the final percentage of marks will be as follows: CGPA based on overall six semesters X 9.5
