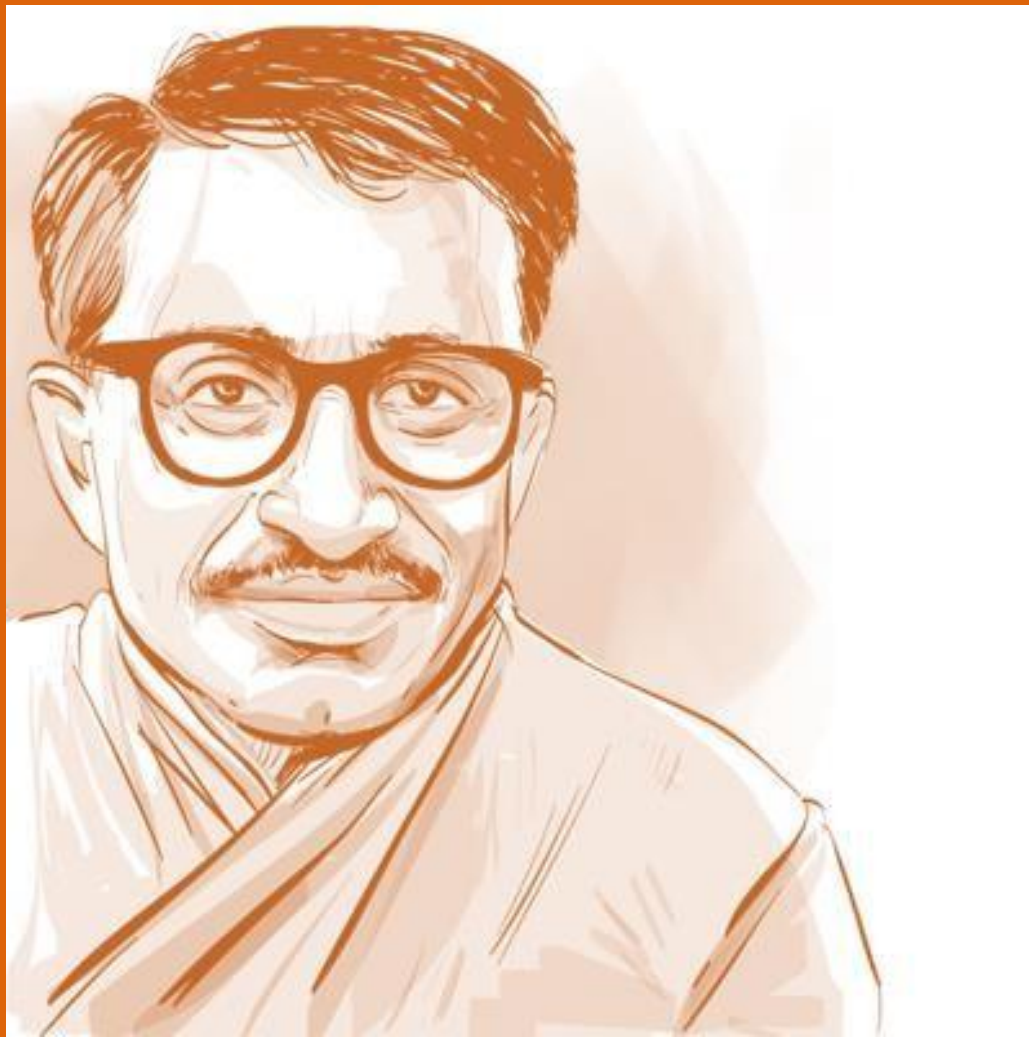

The college achieved the distinction of being ranked 13th in Science, 18th in Commerce, 12th in Management and 38th in Arts colleges in India by the India Today-MDRA Best Colleges Ranking 2025.

AWARD WINNING CAMPUS BUILDING

The present campus of the college was awarded Vishwakarma Award 2017, for its state of art building. All the classrooms, lecture theatres, library, computer center, cafeteria and most of the laboratories are fully air-conditioned. The campus has rain water harvesting, solar power generation and sewage treatment plant with water recycling plant facility.

DBT STAR COLLEGE

In 2018, DBT sanctioned a sum of Rs. 1.04 cr. for three years under the Star College Scheme. In 2021, the college has been awarded Star College status by Govt. of India for another three years. A total sum of Rs.1.65 cr. has been sanctioned for strengthening infrastructure, research, and development activities.

RESULT

The pass percentage of the college students remains consistently high i.e. 94%-97%.

STUDENT MENTORING

Each faculty member mentors ~15-20 students through regular contact program where the student can individually discuss academic or college related issues with the mentor for guidance.

The college has been successfully running the DDUC NPTEL Chapter since April 3, 2019.

SUBJECT SOCIETIES

Every department has its own subject society to organize activities related to their subject and college has its science foundation to organize various interdisciplinary activities.

STUDENT ACTIVITY BOARD

It is responsible for creating a campus vibe in order to foster social, cultural, recreational, and academic development of students. It aims to provide a platform for students to learn by organizing multiple and diverse activities. Students improve interpersonal skills, pursue innate interests and foster talent.

HOSTEL FACILITY

The college hostel comprises of fully-furnished AC rooms with attached washroom, available on double sharing basis for students. The institute has separate hostel for boys and girls. Each hostel accommodates 90 students.

WEB -ENABLED CAMPUS

Free Wi-Fi facility is made available to the students.

DELHI METRO CONNECTIVITY

The college is well connected to the nearest metro stations: Dwarka Mor (1.8 Km) and Dwarka Sec. 12 (2 Km).

LIBRARY

The College has a sprawling centrally air-conditioned library, spread over three floors. There is a dedicated and spacious reading hall to accommodate over 220 students. It boasts of an up-to-date bibliographic database of 52560 books, more than 41 reputed journals and provides access to many important databases, thousands of e-journals and lakhs of e-books.

COMPUTER CENTER

Students from all departments can take benefit of Computer Center equipped with state-of-the-art workstations, which can accommodate nearly 130 students.

An eligible candidate desirous of seeking admission to the Undergraduate Program(s) of the University of Delhi for the academic session 2025-26 must read the contents of **DU Bulletin of Information (BOI) 2025-26**, as well as the notifications, updates and information published on the website of the University of Delhi on regular basis and very carefully. The University of Delhi is liable to change/modify its admission policies and processes anytime without giving any prior notification. The latest and updated information will be available on the website of the University of Delhi - www.admission.uod.ac.in.

The Candidate is also advised to check his/her dashboard, and emails received through registered email id regularly and carefully.

The candidates desirous of seeking admission to University of Delhi are required to apply to University of Delhi's **Common Seat Allocation System (UG)-2025**.

The Ordinances, Rules and Regulations of the University of Delhi, available on the University website, would be binding on all candidates admitted in University of Delhi.

Any change so made shall be updated on the UG Admission website (www.admission.uod.ac.in) and it shall become effective from the date it is posted on the admission website. COLLEGE IS STRICTLY A NO-SMOKING AND ANTI-RAGGING CAMPUS

IMPORTANT POINTS

1. For **regular** college admissions, the candidate **must be a citizen of India or Overseas Citizen of India (OCI)**.
2. The candidate must have **studied and passed Class XII examination** of any Board / University in India, or any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU). The candidate must have studied and passed Class XII examination or its equivalent from a single recognized board.
3. For admission to University of Delhi, it is **mandatory for the candidate to appear in CUET(UG) – 2025** in those subjects in which s(he) is appearing/has passed Class XII. In case the subject studied at Class XII is not mentioned in the CUET (UG) - 2025, the candidate must appear in the Language/Domain Specific subject that is similar/closely related to the subject s(he) has studied at Class XII (for example, if a candidate has studied Biochemistry in Class XII, s(he) must appear in Biology in CUET (UG) - 2025).
4. For establishing similarity of CUET (UG) subjects with subjects taken in Class XII, at least 50% of the syllabus should match. The University reserves the right for establishing the similarity. The decision of the University in this regard shall be final and binding.
5. Admission to all Undergraduate Programs (Regular) academic year 2025-26 at the University of Delhi is **based ONLY on the scores obtained in CUET 2025** (except for admissions to the School of Open Learning (SOL), Non- Collegiate Women Education Board NCWEB, and Foreign Nationals).
6. Allocation and admission will be based only on the combination of Language, Domain Specific subjects and/or General Test in which a candidate has appeared in CUET (UG) – 2025 as per the respective **Program-Specific Eligibility**.
7. The candidate is advised to check that s(he) satisfies all eligibility criteria for the Program(s) for which s(he) is appearing in CUET (UG) - 2025. **Admission is subject to the candidate fulfilling the eligibility requirements** prescribed for applying to the concerned program of study. In case a candidate does not meet any eligibility criteria prescribed for applying to the concerned program and appears in the entrance test, it is at the candidate's own risk and cost. If at any stage, it is found that eligibility requirements are not fulfilled, the admission, if granted, shall be cancelled ipso facto.
8. Candidates desirous of seeking admission to University of Delhi will also have to apply to University of Delhi's **Common Seat Allocation System (UG)-2025**, the details of which are notified through CSAS(UG)-2025 etc. separately on the website of University of Delhi.
9. As per ordinance-I of University of Delhi, there is **no minimum age bar** for admission to the undergraduate programs in the University and its colleges except in the programs where the respective regulatory bodies, such as Medical Council of India (MCI), All India Council of Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.
10. **Gap year** will not be a bar for purpose of admission to undergraduate programs. However, such candidates must have appeared in CUET-2025 for admissions in the academic year 2025-26.

11. Appropriate proration in CUET (UG) - 2025 scores will be done wherever required (including supernumerary quota).
12. **Non-compliance with any of the requirements for admission includes non-submission of relevant documents and/or non-payment of Fee within the prescribed date and time. In that case, the applicants will lose their right to admission.**
13. **The name of the candidate claiming reservation must match with the Candidate's name as it appears on their corresponding School Board qualifying certificates and in CUET (UG)-2025. Similarly, the parents' names must also match in the certificates.**
14. As per A.C. Resolution 40 dated 24 / 04 / 1997 of University of Delhi, no student of the University is permitted to pursue two regular degree programs simultaneously either from the University of Delhi or from other university. However, he / she may pursue part-time diplomas / certificates programs offered by the University Departments / Centers / Colleges, if eligible. Candidates must check the website for all updates.

***Dual Degree (one Regular and other ODL)**

However, the University has allowed pursuing of two-degree programmes simultaneously within the University, one in Regular Mode as offered in the colleges/ departments of the University and the other in Open and Distance Learning Mode as offered in School of Open Learning, Campus of Open Learning vide Academic Council Resolution No. 14 dated 12.07.2024 and Executive Council Resolution No. 5 (5-39) dated 27.07.2024

13. If at any stage, original documents relating to a candidate's admission are found to be fake/ non-genuine or fabricated or in any other manner defective, the concerned candidate will not be admitted and if already admitted, admission will be cancelled without any prior notice in this regard. No fee shall be refunded in such cases. If the same is found after completing the course, the candidate's degree will be cancelled and appropriate legal action will be taken against him/her.

However, this structure shall not be applicable to those students who are enrolled in Single Core Discipline Programmes (conventionally known as ‘Honours’ Programme i.e. programmes where students get Honours degree in three years).



1. **Entry level eligibility:** The general feeder category for entry into Level 5 is the Secondary School Leaving Certificate obtained after successfully completing Grade 12. A programme of study leading to entry into the first year of the Bachelor's degree is open to those students who have met the entrance requirements, including specified levels of attainment at the secondary level of education mentioned in the programme admission regulations. Admission to the Bachelor degree programme of study is based on the evaluation of documentary evidence (including the academic record) of the applicant's ability to undertake and complete a Bachelor's degree programme which is specified in the UGC Guidelines for Multiple Entry and Exit Scheme in Academic Programmes Offered in Higher Education.
2. **Number of hours of a credit course:** It shall be defined by its component of lecture, tutorial and practical.
3. Every student has to study "Environmental Science and Sustainable Development" courses I and II of two credits each in the first year (I/II semester) and the second year (III/IV semester), respectively. The AEC pool will also consist of credit courses in languages listed in the Eighth Schedule of the Constitution of India, as updated from time to time. The University of Delhi shall extend necessary support to those Colleges (where faculty is not available) which may require it in course of teaching learning in these languages.
4. **Design of degrees:** Students shall be able to design their own degrees according to their mission and aspiration for a future befitting to their ability and attainment, rather than following the conventional pathway.
5. A student who pursues three years undergraduate degree programme in a specific discipline as a Core course [for example, B. A. (Honours) English, B. Com (Honours), B. Sc. (Honours) Physics and such other Programmes] will earn at least 80 credits in that discipline (from 18 DSCs and at least 2 DSEs of that discipline) and shall be awarded Honours degree in that discipline, if he/she exits after completion of VI semester.
6. A student who pursues three years undergraduate degree programme in more than one discipline as core courses of study (for example B.A. in Social Sciences/ Humanities, B.Sc. in Life Sciences, B.Sc. in Physical Sciences, B.Sc. in Mathematical Sciences, Bachelor in Commerce Studies and such other programmes) he/she shall be awarded Bachelor's degree in that field of multidisciplinary course of study, if he/she exits after completion of VI semester.
7. If a student wishes to pursue four years Honours Degree with research, he/she shall compulsorily opt for a Research Methodology course in either VI Semester or VII Semester as GE.
8. **Dissertation/Academic Project/Entrepreneurship** in the 4th year shall commence from VII semester and conclude in VIII semester. Detailed outcomes of each track chosen out of these three options shall be notified and assessment at the end of VII and VIII semesters shall be done accordingly.
9. **Dissertation** may be written in the Major or Minor or Interdisciplinary (combination of Major and Minor) discipline.
10. If a student mentioned at (6) above continues or re-enters the fourth year for pursuing an Honours degree in that field of multidisciplinary study, he/she has to choose only one of the disciplines he/she had studied as core courses of study in the previous six semesters and earn credits from the 2DSCs and 6DSEs of that chosen discipline in the VII and VIII semesters and write dissertation or opt for Academic Project or Entrepreneurship.

11. If a student mentioned at (5) above, continues or re-enters to study the VII and VIII semesters in the same discipline, and writes dissertation mentioned at (9) above, but no Minor discipline is made out (i.e., credits earned in the GE of any one discipline is less than 28 credits), then he/she shall be awarded 'Honours with Research' with Major in that discipline on successful completion of VIII Semester.
12. A student mentioned at (6) above, shall be awarded 'Honours' degree in that field of multidisciplinary study on successful completion of VIII semester. For example, B.A. (Honours) Social Sciences/ Humanities, B.Sc. (Honours) Life Sciences, B.Sc. (Honours) Physical Sciences, B.Sc. (Honours) Mathematical Sciences and Bachelor in Commerce Studies (Honours). Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2)(b) and III(3)(b), respectively. For instance, a student who pursues four years B.A. (Honours) in Social Sciences/ Humanities with History, Political Science and Hindi as core courses, shall get Major in History, on successful completion of VIII semester, if he/she earns minimum 80 credits in History from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History. Such a student shall get a Minor in Political Science/Hindi, if he/she earns minimum 28 credits from 6 DSCs and one DSE of Political Science/Hindi.
13. Only a student mentioned at (5) above who opts to write a dissertation in the Major/Minor subject in VII and VIII semesters in the fourth year, shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Research) in Discipline'. For instance, a student who pursues B.Sc. (Honours) in Physics and writes a dissertation on a topic relating to Physics or the Minor in VII and VIII semesters, shall be awarded 'Bachelor of Science (Honours with Research) Physics. Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2)(a) and III(3)(a), respectively.
14. A student who opts for 'Academic Project' or 'Entrepreneurship' in VII and VIII semesters, instead of writing dissertations, and has earned 28 credits in the relevant GE, SECs, AECs & IAPC, shall be awarded Minor in Academic Project or Entrepreneurship, as the case may be. 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major) & Academic Project/ Entrepreneurship (Minor)'. If he/she is unable to earn the requisite 28 credits, he/she shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major)'.
15. A student who pursues four-year undergraduate degree programme shall be awarded after completion of the VIII semester an appropriate degree.
16. **Exit Options:** The minimum credit to be earned by a student per semester is 18 credits and the maximum is 26 credits. However, students are advised to earn 22 credits per semester. This provision is meant to provide students the comfort of the flexibility of semester-wise academic load and to learn at his/her own pace. However, the mandatory number of credits have to be secured for the purpose of award of Undergraduate Certificate/ Undergraduate Diploma/ Appropriate Bachelor's Degree in the field of Study/Discipline, to a student who chooses to exit at the end of even semesters.
17. The course code, number of credits, components of lecture, tutorial and practical, pre-requisites to be fulfilled for choosing that course and the department offering the course shall be spelt out for each course. A student should fulfil the pre-requisites of a course to be able to opt it for study.

MINIMUM ELIGIBILITY CRITERIA

(As per DU Bulletin of Information Undergraduate Admissions 2025)

COMMON MINIMUM ELIGIBILITY*

The candidate must have passed the Class XII or its equivalent examination from a single recognized board.

For the purpose of ascertaining the Minimum Eligibility, the marksheet/ degree of only one board will be considered. (For example, if a candidate has appeared in CBSE Board Examination with five subjects except for Mathematics and later appears and passes Mathematics from another board such as the National Institute of Open Schooling (NIOS), the minimum eligibility shall be ascertained from his/her mark sheet issued by CBSE only).

PROGRAM SPECIFIC ELIGIBILITY

Candidate must refer to the Program-Specific Eligibility to choose the subjects in which s(he) should appear in CUET (UG) – 2025.

It is mandatory for the candidates to appear in CUET(UG)-2025 in those subjects in which s(he) is appearing/ has passed Class XII. RESERVATION OF SEATS FOR SCHEDULED CASTE (SC) SCHEDULED TRIBE (ST) CANDIDATES

22.5% of the total numbers of seats is reserved for Candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).

The Candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission. The Caste certificate should clearly state:

- (a) Name of his/her caste/tribe
- (b) Whether candidate belongs to SC or ST
- (c) District and the State or Union Territory of Candidate's usual place of residence, and
- (d) the appropriate Govt. of India Schedule under which his / her caste / tribe is approved as SC or ST.

Candidate will have to produce the valid original SC or ST caste/tribe certificate at the time of admission.

The following are empowered to issue the requisite SC / ST certificate:

1. District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.
2. Chief Presidency Magistrate / Chief Presidency Magistrate / Presidency Magistrate.
3. Revenue Officer not below the rank of Tehsildar.
4. Sub- Divisional Officer of the area where the Candidate and/ or his family normally resides.
5. Administrator / Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

Candidates to note that the SC / ST Certificate **from any other person / authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste / tribe must be listed in the appropriate Govt. of India Schedule.**

It is a statutory obligation on the part of Colleges to fill all seats reserved for Scheduled Caste / Scheduled Tribe Candidates.

Colleges shall not refuse admission to any SC / ST Candidate on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.

RESERVATION POLICY FOR ECONOMICALLY WEAKER SECTIONS (EWS)

As per the University of Delhi notifications (Reference No. Aca. I / Reservation of EWSs / 2019/ 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission of candidates belonging to EWS category.

The Certificate should have been issued after 31st March, 2025.

RESERVATION OF SEATS FOR OTHER BACKWARD CLASSES (OBC) NON CREAMY LAYER (CENTRAL LIST)

27% seats are reserved for the Candidates belonging to Other Backward Classes (OBC - Non-Creamy Layer, Central List).

At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website http://ncbc.nic.in/backward_classes/index.html). The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).

The OBC Candidates who belong to the 'Non-Creamy Layer' and **whose caste appears in the Central List of the OBCs only**, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the Candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res- I) dated 31 March 2016).

OBC-NCL Central List Certificate should have been issued after 31st March, 2025.

It is a statutory obligation on the part of Colleges to fill all the seats reserved for OBC Candidates.

RESERVATION OF SEATS FOR PERSONS WITH BENCHMARK DISABILITIES (PwBD)

- A. **Locomotor Disability:** Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—
1. **"Leprosy cured person"** means a person who has been cured of leprosy but is suffering from—
 - i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifestation of deformity;

ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;

iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;

2. **"Cerebral Palsy"** means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
3. **"Dwarfism"** means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimetres) or less;
4. **"Muscular Dystrophy"** means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue
5. **"Acid Attack Victims"** means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance

B. Visual impairment

6. **"Blindness"** means a condition where a person has any of the following conditions, after best correction
 - i. total absence of sight; or
 - ii. visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
 - iii. limitation of the field of vision subtending an angle of less than 10
7. **"Low-Vision"** means a condition where a person has any of the following conditions, namely:
 - i. visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
 - ii. limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

C. Hearing Impairment

8. **"Deaf"** means persons having 70 DB hearing loss in speech frequencies in both ears;
9. **"Hard of Hearing"** means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
10. **"Speech and Language Disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes

D. Intellectual Disability

1. A condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—
11. **"Specific Learning Disabilities"** means a heterogeneous group of conditions wherein there is a

deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;

12. **"Autism Spectrum Disorder"** means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

E. Mental Illness

"Mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by sub-normality of intelligence.

F. Disability caused due to Chronic neurological conditions, such as—

13. **"Multiple Sclerosis"** means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
14. **"Parkinson's Disease"** means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

G. Blood Disorder

15. **"Haemophilia"** means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding;
16. **"Thalassemia"** means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin;
17. **"Sickle Cell Disease"** means a haemolytic disorder characterised by chronic anaemia, painful events, and various complications due to associated tissue and organ damage; "haemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.

H. Multiple Disabilities (more than one of the above specified disabilities)

Multiple disabilities including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

I. Any other category as may be notified by the Central Government.

RESERVATION UNDER ORPHAN QUOTA

Candidates desirous of taking admission under the supernumerary Quota for Orphans must appear in CUET (UG)- 2025.

The University of Delhi will be admitting **two candidates (one male and one female) in each program of study**, both at the Undergraduate and Postgraduate level. These two seats will be supernumerary. The Council of the University further resolved that the expenditure incurred for admission and continuance of study of such students in the University or its Colleges shall be met from the University Welfare Fund or College Students' Welfare Fund, as the case may be, for admissions in the University or in the College.

RESERVATION OF KASHMIRI MIGRANTS (KM)

Up to 5% seats are reserved program-wise in all colleges for the wards of Kashmiri Migrants. All the wards of Kashmiri Migrants will have to upload a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/ Relief Commissioner.

Candidates desirous of taking admission under the Kashmiri Migrants quota must appear in CUET 2025.

RESERVATION FOR CHILDREN/WIDOWS OF PERSONNEL OF THE ARMED FORCES (CW)

Five percent (5%) of seats are reserved for Candidates under this category, program-wise in all colleges.

All such Candidates have to upload the Educational Concession Certificate (ECC*) issued by **any of the following authorities** on the proper letterhead:

- a. Secretary, Kendriya Sainik Board,
- b. Secretary, Rajya Zila Sainik
- c. Officer-in-Charge, Record Office.
- d. 1st Class Stipendiary
- e. Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

*The University may ask for supporting documents along with ECC.

No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.

*The University may ask for supporting documents along with ECC. For details refer to CSAS (UG) 2025 to be published at the website of the University of Delhi.

The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion.

WARD QUOTA OF EMPLOYEES OF UoD (WQ)

Candidates desirous of taking admission under the Ward Quota of Employees of University of Delhi must appear in CUET 2025.

Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020 and subsequent amendments thereof.

Candidates must be in possession of a valid Employment Certificate issued by DU officials at the time of registration. Only the Employment certificate uploaded at the time of registration will be considered. I-cards, Aadhar Card and/or any other document will not be accepted.

Admissions under ward quota for each college will be determined in three Program Clusters namely viz. Humanities, Commerce and Sciences. The allocation will also depend upon the number of Programs offered in a College/Department. Allocation of Ward Quota will be based on merit scores of candidates in program clusters and the order of preferences given by the candidates. The seats under ward quota allocated for teaching and nonteaching will not be interchangeable. However, allocations may be considered within the Program Clusters to maximize the benefit. Appropriate proration in CUET scores may be done to ascertain cluster-based merit.

EXTRA CURRICULAR ACTIVITIES (ECA) AND SPORTS QUOTA

Candidates desirous of taking admission under the supernumerary quota for ECA and/or Sports must appear in CUET 2025.



For admissions to ECA and Sports supernumerary seats, a weightage of 25% will be given to CUET score and 75% to certificates/trials/perfor

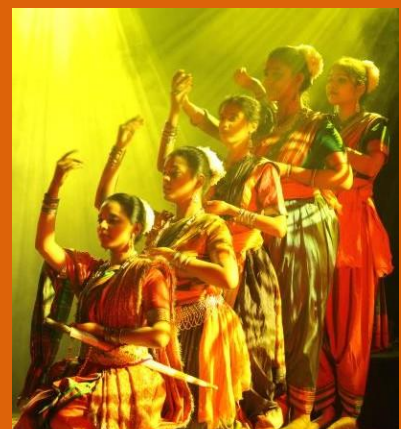

FROM THE UNIVERSITY

- i. University of Delhi holds a competitive examination in the month of October each year for the award of All India Entrance Scholarships of Rs. 250 per month. Any student with at least 55% marks in the aggregate may apply as notified by the University in the prescribed forms available from the College Office.
- ii. Financial Assistance out of Vice Chancellors' Student Fund is given to poor deserving students, who have passed Annual Examination of current year from University of Delhi and belong to BPL/APL families (Rs. 3000/-).
- iii. Under Graduate Science Meritorious Award is given to students who secure highest marks in B. Sc. (Hons) Physics, Chemistry, Botany and Zoology.
- iv. Various other Scholarships are uploaded on the website of the University. [Guidelines](#) and [Application Form](#) are given under the link: <https://www.du.ac.in/index.php?page=opportunities-scholarships>.
- v. Vice-Chancellor's Gold Medal is awarded each year to physically challenged students from the Arts, Science and Commerce streams who secure the highest marks amongst students studying in these streams, with not less than 60% marks, at the undergraduate (Final Year Passed) examination.

STATE GOVERNMENT AWARD

The Govt. of NCT of Delhi gives three awards of Rs. 10,000/- each in Science, Commerce, and Humanities to students securing the highest marks in their respective disciplines among colleges funded by it.



- **PT. VIDYADHAR TRIPATHI MEMORIAL AWARD**

Student who scores highest marks in B. Com (Hons) every year (combined result of I & II Sem. University Examination) is awarded a cash prize of Rs. 1000/- (out of the interest income from the Endowment Fund instituted by his niece Late Prof. Vanita Tripathi), a Shield and a certificate.

- **SHRI GHASI RAM MITTAL MEMORIAL AWARD**

Out of the interest derived from Shri Ghasi Ram Mittal Memorial Scholarship Endowment Fund, scholarships of Rs. 4000/- each are given to the students who secure the highest marks but not less than 70% marks in the combined result (I & II Sem. University Examination) in the first attempt in each of the following courses: B. Sc. (Hons) in Computer Science, Electronics, Mathematics, Physics, Chemistry, Botany, Zoology, B. A. (Hons) English, B. A. and BMS.

- **SHRI SULTAN CHAND MEMORIAL SCHOLARSHIP**

Out of the interest derived from Shri Sultan Chand Endowment Fund (instituted by Shri Sultan Chand Trust), a scholarship of Rs. 3500/- is awarded every year to a student of B. Com (Hons) who secures the second highest percentage of marks, being above 70% as aggregate in II year University Examination.

- **SHRI SULTAN CHAND DROPADI DEVI MEMORIAL SCHOLARSHIP**

Out of the interest earned from Endowment Fund in the name of Shri Sultan Chand Dropadi Devi (instituted by Shri Sultan Chand Dropadi Devi Education Foundation), six scholarships of Rs. 4000/- are awarded to the students who secure highest marks in each semester during three years of their B. Com (H) degree.

FROM STATE GOVERNMENTS TO SC/ ST/OBC /MINORITIES STUDENTS

- a) SC/ST/OBC/Minorities students are awarded scholarships by the States to which they belong;
- b) SC/ST/OBC/Minorities students of Delhi applying for post matric and/or meritorious scholarship provided by Department for Welfare of SC/ST/OBC/Minorities, Govt. of NCT Delhi, are advised to contact the office immediately after their admission. The continuance of any free ship, scholarship or grants of other privileges depends on satisfactory academic progress, regular attendance, discipline and good conduct; SC/ ST/ OBC/ Minorities students are advised to contact. Department for Welfare of SC /ST /OBC / Minorities, Govt. of NCT Delhi for hostel facilities provided by the Department.

FEE CONCESSION

The College gives fee concession to needy, deserving and meritorious students. Application on prescribed forms is to be submitted to the Accounts Office of the College. The date for the same shall be notified on the college website. The College also provides exemption of Tuition Fee and Admission Fee to all SC/ST students, whose parents are not liable to pay income tax on their income, on submission of a certificate from employer/competent authority for the same.

STUDENTS AID FUND (SAF)

The College operates this fund with the objective of rendering financial assistance to needy and deserving students of the College. Assistance is usually given in the form of textbooks etc. Students in need of financial aid can apply when invited through circulars on the notice board or through the college website.

COLLEGE SCHOLARSHIPS

The college has instituted a scheme of awarding Scholarships of **₹10,000/- per annum** to needy students.

Condition:

- Attendance should be more than equal to 75%.
- The student should not have availed any other scholarship from State Government, Central Government, any other statutory body during the year 2025-26.

Eligibility Criteria:

A student can apply for a scholarship under one of the following categories-

(i) CATEGORY A (based on family income):

Parent/ Family income from all sources should not exceed ₹5 lakhs per annum.

- Certificate/ Form-16 from the employer in case of salaried employees.
- Certificate issued by MP/ MLA/ Councilor/ SDM etc. for the year 2024-25 issued after 31st March, 2025 in case of self-employed persons (Certificate/ declaration issued by Notary will not be accepted in any manner).

(ii) CATEGORY B (based on merit):

Secured a minimum 80% overall aggregate in class 12th examination. Second-year & third-year students should have secured 8 or more CGPA combined in all the semester-end examinations.

(iii) CATEGORY C (Sports):

The student must have participated in an International Sports Event.

Note: College shall notify, whenever applications to the scholarship are open.

NATIONAL SCHOLARSHIPS*

1. Central Sector Scheme of Scholarship for College and University Students (Department of Higher Education)

Students who are above 80 percentile of the successful candidates in the relevant stream of respective Board of Examination in class XII or equivalent and passing regular courses (not correspondence or distance mode) in colleges.

2. Post Matric Scholarship for students belonging to the Minority Communities (Ministry of Minority Affairs)

Students belonging to Muslims, Sikhs, Christian, Buddhist, Jain & Zorastrians (Parsis) Communities who have secured not less than 50% marks or equivalent grade in the previous final examination & the annual income of whose parents/guardian from all sources does not exceed Rs. 2,00,000.

3. Post Matric Scholarship for students with disabilities (Department of Empowerment of Person with disabilities)

Students with more than 40% disability and having a valid certificate of disability as prescribed under rules issued by the competent authority and whose parent's income from all sources does not exceed Rs. 2.5 lakhs.

CAREER COUNSELING AND PLACEMENT CELL

During the academic year 2024-25, we enabled placements in renowned companies, giving our students a strong start to their professional careers. The 2024-25 placement season saw participation from 39 reputed companies, including Accenture, RSA, WTW, DE Shaw, EY, PWC, Wipro, Maruti Suzuki, CodeYoung, among others. These organizations spanned various industries such as Finance, Consulting, IT, Manufacturing, and FMCG. A total of 40% of students secured offer letters, with the highest package reaching INR 24.8 LPA, an average package of INR 6.55 LPA, and a median CTC of 6 LPA.

The Placement Cell of Deen Dayal Upadhyaya College successfully organized the fifth edition of its annual Hybrid Job and Internship Fair on February 25th (Offline Mode) and February 27th (Online Mode). With participation from over 60 companies and substantial student registrations, this year's fair was the largest and most impactful to date.

The offline segment, held on campus, saw active engagement from 12+ companies and a footfall of 150+ students, offering face-to-face interactions, interviews, and corporate presentations. The online segment significantly broadened the reach of the event, featuring over 50 companies and enabling students from across India to apply for internships remotely.

The fair proved to be a resounding success, fostering industry connections, career opportunities, and professional growth for students across disciplines.

To further support and develop our students, the Placement Cell also conducted a range of seminars, webinars, and workshops focused on Skill Training, MBA, CFA, Actuarial Sciences, Data Analytics, as well as preparation for Group Discussions and Personal Interviews.

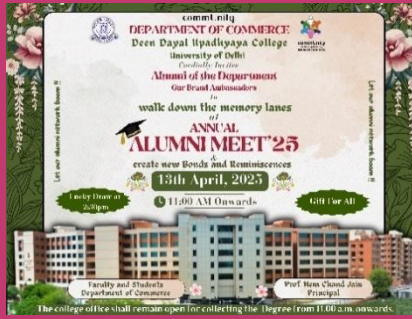

Highlights of our College Campus

Built on a plot of 7.7 acres in Dwarka (Sector 3), the campus is state-of-the-art. It is a multi-story building (basement and 7 floors) with a holistic concept of a green building. A rainwater harvesting system and a water recycling plant are already in place. The campus has the following facilities available in its complex:

LECTURE HALLS: Facilitating Excellence in Teaching and Learning

The College features twelve well-designed lecture halls, each accommodating up to 70 students, along with 36 classrooms that seat between 40 and 60 students, and two seminar rooms with capacities ranging from 100 to 150. All learning spaces are spacious, well-ventilated, and well lit, with excellent acoustics. Each hall is equipped with state-of-the-art audio-visual teaching aids to support interactive learning.



LABORATORIES: Where Learning Meets Application



The **Computer Science Department** has three state-of-the-art labs with over 170 modern computers. One lab, featuring 62 Intel i7 12th Gen desktops, is dedicated to multimedia programming and processing. All labs are equipped with smart digital boards, multimedia projectors, and enterprise-class laser printers. A 10 Gbps network backbone with high-end switches and servers supports both wired and wireless 1 Gbps internet, supplemented by the National Knowledge Network for extensive free educational resources. Each workstation has centralized UPS backup. The department offers a full range of up-to-date open-source and legacy software, including Office 365, with expert technical staff always available for support.

The **Department of Electronics** has two well-equipped laboratories for analog and digital experiments, with 30 new computers (with latest specifications and software) for simulation.

We have 48 oscilloscopes (33 DSO + 15 MSO), 58 power supplies, 40 function generators, an arbitrary function generator, oscilloscope trainer kits, microprocessor/microcontroller kits, embedded trainer kits, and test equipment including communication trainer kits for AM/FM, PAM, PWM, PPM, etc. For power electronics, we have a DC series motor, DC shunt motor, induction motor, and speed control motor with chopper and SCR.



The **Department of Physics** has four well-equipped laboratories for physics experiments:

1. Electronics Lab for physics experiments
2. Thermal Lab
3. Electrical and Material Science Lab
4. Optics Lab

The department also has 30 computers (with the latest specifications and updated software). It has 19 digital storage oscilloscopes, 48 power supplies, 33 function generators, 68 digital multimeters, an arbitrary function generator, an optical fiber kit, and microprocessor kits.



To conduct experiments in **Life Sciences**, there are two museums containing various specimens and models, and two laboratories each for **Botany** and **Zoology**, all well-equipped with the latest instruments. These include laminar flow hoods, deep freezers, autoclaves, trinocular and high-resolution microscopes, to name a few.

For **Chemistry**, there are three laboratories, one of which is an Analytical Techniques Laboratory equipped with instruments such as a flame photometer and a UV-Visible spectrophotometer.

The college has a state-of-the-art **Language Laboratory** with modern desktops and interactive software for language learning. It can accommodate forty learners per batch and uses audiovisual materials to enhance learning. The lab offers a wide range of computer-based exercises to help students build proficiency, especially in English communication. It also supports learning other languages like French, German, and Spanish.

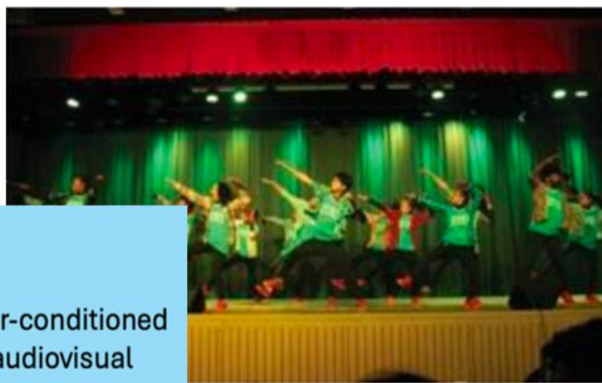
COMPUTER CENTRE (ICT): Simplifying Technology



Deen Dayal Upadhyaya College has a centrally air-conditioned High-**Performance Computing Facility Centre** with a capacity for about 120 users to promote network-based knowledge and learning. The ICT infrastructure consists of high-end servers, workstations, and desktops with the latest technology, along with a 10-gigabit fiber backbone that provides dedicated internet connectivity through WLAN (Wi-Fi) and LAN. It facilitates students and faculty in accessing a world-class teaching and learning system.

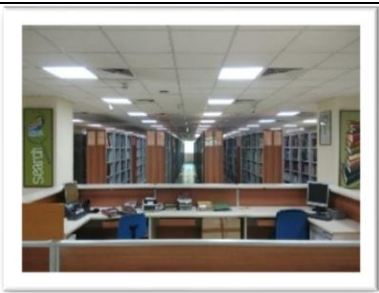

LIBRARY RESOURCE AND INFORMATION CENTRE:

The college has an excellent central library facility sprawling across three floors with centralized air conditioning facility. It has a total floor area of 2,550 sq. meters, with provision for a separate reading section for the faculty and a spacious reading hall to accommodate over 300 students. The library is fully computerized with all its functions and operations being performed through a dedicated network of 14 computer systems using web-based library software. The library organizes separate User Orientation Program every year for the new batch in its reading hall on the day of Orientation Day of the college. Students are given detailed information and instructions on the use of library resources.

COLLECTION: The library has a rich and active collection of textbooks and reference books which is extensively utilized by the students. It has an up-to-date bibliographic database of books and journals which can be searched using Library Web OPAC. The library has a total collection of **52,560 volumes** of textbooks and reference books. It subscribes to **42 journals & magazines** of national and international repute in all the relevant subject areas. Besides this, the library subscribes to **16** national newspapers. It has **613** bound volumes of journals and 860 CDs in its collection. The entire collection is heavily used by the students and faculty, having a footfall of approx. **41,000** visitors, resulting in **33,000** books’ transactions in the preceding year.

SERVICES AND FACILITIES: The library provides book-bank facility to students belonging to SC/ST/OBC categories and other economically poor and meritorious students. Through the University dedicated fiber-optic link and other resource sharing networks, the library has access to many important databases, thousands of e-journals and lakhs of e-books. The entire college campus including the library is Wi-Fi enabled to provide 24X7 seamless access to information remotely from anywhere in the campus. The library provides internet browsing, database search and print-out facilities through a dedicated computer-hub, comprising of 20 desktop systems. To promote the use of books and e-resources, the library also conducts workshops and seminars. Every registered member of the library is provided with User ID and Password for remote access to e-books, e-journals and online databases.



LIBRARY PRIVILEGES: Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable. Every student is entitled to borrow **four library books for a period of 10 days**. Library books which are retained beyond the prescribed due date are charged a **late fine of Re. 1 per day for the first five days of delay** and subsequently Rs. 3 per day for the remaining period of delay.

WORKING HOURS: The **working hours of the library** are from **9:00 AM to 5:00 PM** on all working days, **Monday to Friday**.

INDOOR SPORTS COMPLEX

The college has indoor facilities for squash, badminton, table tennis, carrom, chess, and a gymnasium. Outdoors, there is an archery range. Other outdoor facilities are in the process of being developed.

CAFETERIA

The college has an air-conditioned cafeteria equipped with high-quality furniture and a pleasant ambience. The seating capacity is around 100, with a separate area designated for staff members. A variety of food items are available at affordable rates.



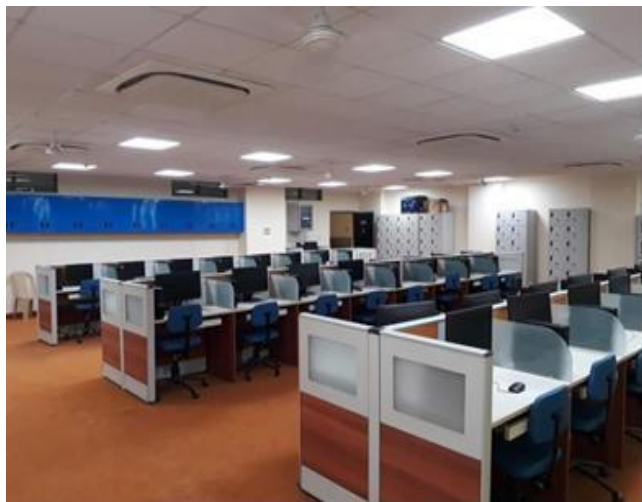
GIRL'S & BOY'S COMMON ROOM

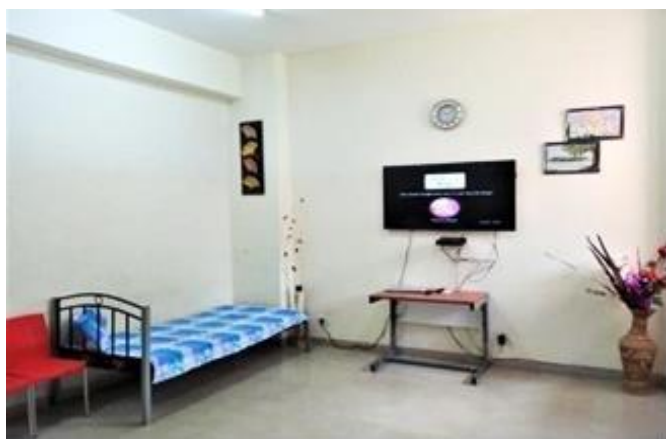

The institute has separate hostels for Boys and Girls, and provides excellent accommodation to 180 students. The hostels have twin sharing rooms which are well furnished, and have attached bathrooms with hot water supply during winters. All rooms are air-conditioned and furnished with a bed, mattress, study table, book rack, chair, cupboard/shelf for each student. The hostel rooms are also well-ventilated. Round the clock security is provided. There are separate Students' Mess for boys and girls along with a cafeteria facility. Recreation Rooms with TV in boy's and girl's hostel and sports facilities are also available.

- ✓ The hostel has the total 45 furnished rooms. The rooms are at sharing basis among two students'. Every room has attached washrooms and a common washroom on each floor.
- ✓ The hostel has a separate mess where residents can take their meals. It is managed by the residents under the supervision of the Warden. Wholesome meals are served to the residents in the mess. The menu is decided by the residents' council. Meals are served in the dining hall.
- ✓ A common recreation room equipped with a television and DTH connection and air-conditioner is on the ground floor where the residents may sit and enjoy their leisure time. News-papers and magazines are also available in the Recreation Room.
- ✓ The college/Hostel has squash, badminton, table tennis, carom, chess and gymnasium as an indoor facility.
- ✓ First-Aid box is available in the hostel. In case of a medical emergency, resident is taken to the nearest hospital and the local guardian is duly informed. The local guardian is required to take charge thereafter and the entire responsibility for the treatment and expenses will be borne by the parents/local guardian. The college will not be responsible in any way for the further course of treatment. Residents are strongly advised not to use self-prescribed medicine in case of illness. The hostel may engage a qualified health counsellor on visiting basis to take care of the mental health issues of the residents.
- ✓ The College has Punjab National Bank (PNB) Branch located inside the main building within the college premises.
- ✓ In House washing machine is available for the residents
- ✓ The Hostel has created a mini library for preparation of competitive examination. Residents can borrow the books from the mini library.

ORDINANCE VIII-F ASSESSMENT PATTERN

CNC-II/093/1(22)/2022-23/10th February, 2023 as updated on 21.03.2023 vide [EC Resolution No. 60-1/(60-1-13) dated 03.02.2023]

Assessment pattern of Courses based on Under Graduate Curriculum Framework – 2022 to be implemented from the Academic Year 2022-2023.

1. The assessment pattern that shall be adopted for the purpose of assessment of courses that have been approved by the Competent Authorities under the UGCF 2022 shall be as follows:
 - (a) In any course where 01 credit is attributed to 'Tutorial', an objective assessment process has to be developed as a credit earned by a student in a course will eventually lead to its deposition in the Academic Bank of Credit of such student. Therefore, it is imperative that each credit earned by a student is adequately assessed and recorded accordingly.
 - (b) In view of the above, the components of Tutorial have been listed so that at least some of these activities (listed at point no. 3 below) may be picked up by a student, in consultation with the teacher, as per rules devised for this purpose. The activities conducted shall be assessed through continuous assessment.
- i). Some of the activities that may be done as component of tutorials are as follows:
 - Literature review
 - Book review
 - Movie review
 - Project activity (group)
 - Research cum presentation
 - Creative Writing/Paper writing
 - Group discussion
 - Problem Solving exercises
 - Any creative production (may be done in a group)
 - Innovative Project
 - Any other scholastic work related to application of conceptual understanding of subject.
- ii) Further, out of forty marks allocated for Continuous Assessment of tutorial, five marks shall be for attendance, which shall be distributed as follows:

2. (i) Internal Assessment (IA) shall consist of marks secured in class tests, assignments/ presentations and attendance. For instance, for an Internal Assessment of 25 marks, Class tests shall comprise of 10 marks, Assignments/Presentations shall comprise of 10 marks and attendance shall be for 5 marks. Similarly, for IA of 30 marks, 6 marks shall be for attendance, 12 marks for class test and 12 marks for Assignments/Presentations.

(ii) **Six marks for attendance shall be distributed as follows:**

3. (i) To make Internal Assessment and Continuous Assessment fair and reasonable, it is necessary to strengthen the Monitoring Committee for Internal Assessment in every College, constituted as per clause 5(ii) of Ordinance VIII-E of the Ordinances of the University. This Committee shall be responsible for the entire process of Internal Assessment in the College, including redressal of grievances, if any. The same Committee shall also look into the process of Continuous Assessment and redress grievances, if any.

(ii) A student who is discontent with the decision taken by the Monitoring Committee for Internal Assessment of the College, with respect to the grievance submitted by him/her relating to Internal Assessment/Continuous Assessment, may file an appeal before an appellate body consisting of the Principal of the College, the Teacher-in- charge of the department/senior faculty member, the concerned teacher who has assessed the aggrieved student and shall be chaired by the Nominee of Dean of Colleges or Director South Delhi Campus, under whose jurisdiction the concerned College falls.

4. The theory examination and internal assessment shall be a cumulative assessment of the teaching-learning done in the theory as well as tutorial classes.

5. The assessment pattern for courses of different credit distributions is provided in Table – 1.

For the implementation of cumulative improvement of marks of a course/ paper, EC (1275) 23rd MAY 2025 Resolution No. 7-34/ provided the clarification as under:

a. (i) A student who has passed in a course/paper in an earlier semester, but wishes to improve the marks of both the theory (written exam marks) and Internal Assessment (IA) but excluding the attendance component of the IA, may be allowed to **carry forward their previous attendance marks of IA** and improve upon the rest of the two components i.e. Class Test and Assignment by re-registering for the course/paper and **learning through self-study mode**.

(ii) To ‘Re-register’ for a course/paper means to formally inform the College authority by a student of his/her intent to improve a course/paper. College may create a proforma /Google Form to seek such information from the students and may charge a very nominal fee (maximum Rs. 100/-) to systematize the process.

Further, it is reiterated that as per Ordinance IX (2), **improvement of marks** obtained in a course/paper can be made in the immediately succeeding odd/even semester only.

However, if a student has got an ‘**Essential Repeat**’ in a course/paper in the relevant semester, he/she may be allowed to appear for that paper and improve the components of that paper till the time he/she passes that course/paper. For instance, if a student fails in a course of semester I, he/she has to repeat in semester III, but if he/she again fails in that course/paper in semester III, then he/she shall be allowed to appear again in semester V.

10. The final percentage of marks (%) for the students graduating from 2022- 2023 shall be calculated as Grand CGPA (Cumulative Grade Point Average) multiplied by a factor of 10.

1. The entire evaluation process for Ability Enhancement Course (AEC), Skill Enhancement Course (SEC) & Value Addition Course (VAC) papers shall be undertaken by each college where the AEC/SEC/VAC are being taught and the teacher responsible for the conduct of learning of the AEC/SEC/VAC shall be responsible for the evaluation.

The Examination of the Ability Enhancement Course (AEC), Skill Enhancement Course (SEC) & Value Addition Course (VAC) papers studied under the Cluster Colleges, shall take place at the College of admission/enrollment. The answer-scripts of these papers shall be evaluated at the Cluster College and the awards will be provided to the College of admission/enrollment for further upload on the Samarth Portal.

2. There shall be no REVALUATION in respect of Ability Enhancement Course (AEC), Skill Enhancement Course (SEC) & Value Addition Course (VAC) papers as these papers are evaluated by the teachers who taught the said papers. However, Examination Wing may allow rechecking in these papers as per prescribed procedure and payment of requisite fee.
3. The General Elective Courses offered by the department will be taught by teachers of the same department. A student admitted in a particular programme offered by a department can opt for General Elective Courses offered by other department, for example, a student admitted under B.A. (Hons) History / B. A. (Programme) with History as one discipline cannot opt for any General Elective Courses offered by Department of History.
4. A student who appears in an odd-semester examinations or who was eligible to appear in the odd semester examinations but remains absent in any or all the papers of the said semester, shall move on to the next even semester irrespective of his/her result in the said examinations provided examination form for both the odd and even semester examination is duly submitted and requisite fee paid by the candidate.
5. Student who do not fulfill the promotion criteria mentioned above shall be declared fail in the promotion examination of the academic year concerned. However, they shall have the option to retain the marks in the papers in which they want to retain.
6. A student who wants to re-appear for improvement in marks in a paper prescribed for semester I/III/V/VII may do so only in the semester examinations to be held in November/December. A student who wants to re-appear for improvement in a paper prescribed in semester II/IV/VI/VIII may do so only in the examinations to be held in May/June.
7. A student may re-appear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the appear/s concerned. This can be done in the immediate subsequent semester examination only (for example, a student re-appearing in paper prescribed for semester I examination may do so along with subsequent semester III examination and not along with papers for semester V).
8. A candidate who has cleared examinations of Part-3 (Semester- V & VI) /Part-4 (Semester- VII & VIII) may re-appear in any paper of V/VII or VI/VIII semester only once, at the immediate subsequent examinations on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period.

Note: The candidate of this category will not be allowed to join any post-graduate courses.

9. In the case of re-appearance in paper, the result will be prepared on the basis of the candidate's current performance in the examinations.
10. The awards of the Practical/Tutorial/Internal Assessment shall be uploaded on the Samarth Portal as per the marks distribution table below and duration of end semester theory examinations of subjects shall be as per the following table:-

13 PASSING & PROMOTION CRITERIA AND RULES Under NEP, Admissions 2022 & 2023 ONLY

- a. A Student shall be eligible for promotion from Part-1 to Part-2 of the Course provided S/he has passed at least 50% papers of Semester-I and Semester-II taken together.
- b. Similarly, a student (irrespective of the Part-1 results) shall be eligible for promotion from Part-2 to Part-3 of the course provided s/he has passed 50% papers of Semester III and IV taken together.
- c. Similarly, a student (irrespective of the Part-1 and Part- 2 results) shall be eligible for promotion from Part-3 to Part-4 of the course provided s/he has passed 50% papers of Semester V and VI taken together.
- d. Students who do not fulfill the promotion criteria a, b, and c above shall be declared fail in the Part Concerned. However , they shall have the option to retain the marks in the papers in which they have secured Pass marks as per applicable rules.

PASSING & PROMOTION CRITERIA AND RULES Under NEP, Admissions 2024 & ONWARDS

The previous rule as above has been substituted by the new rule passed in EC (1270) by Resolution No.13-27 Appendix 99:

The student should acquire at least 28 credits out of the total credits of both the semesters for promotion to next year. However, Students representing the University of Delhi in Sports/Extra-Curricular Activities/ NCC/NSS etc. may be exempted from this requirement subject of the prior approval of the competent authority.

Another notification has been issued for progression of students to Semester VII (Notification No.- Acad.-I/NEP/UGCF/2025/194 dated 01st May 2025), which is as under:

The students enrolled under the UGCF 2022 shall be progressing to Semester VII in 4th Year of the respective Academic programmes being pursued by them with effect from the Academic Session 2025-2026. In this connection, it is highlighted that the progression of a student enrolled under UGCF 2022 from Semester VI to Semester VII is universal, subject to the promotion rules as applicable from time to time, and not restrictive in any manner whatsoever.

- 14 **Issue of Marksheet/Grade Certificate/Transcript:** Based on the grades earned, a Grade Certificate shall be issued to all the registered students by the University after every semester and a consolidated Marksheet/Grade Certificate indicating the performance in all semesters. The Grade Certificate will display the course details (code, title of the paper, number of credits, grade secured) along with SGPA of each semester and CGPA earned based on each academic year.
- 15 Letter Grades calculation shall be as per formula provided for all the undergraduate courses as provided in the Ordinance IX except that the formula for calculating the final percentage of marks will be as follows:-

Special Moderation For A Single Left-Over Paper and Span Period For Completion of Degree Under NEP vide EC (1269) Resolution No. 57 (57-1) Dated 08-03-2024

Resolved that the provisions for special moderation of 10 marks in respect of students who have a single remaining paper to complete the course be accepted.

Note:

1. There is a provision of span period for completion of degree programmes in the University within which students must complete their degree programs. With the implementation of the NEP UGCF-2022, there is now some relief available for students who are unable to complete the degree course within the specified span period. In such instances, they are eligible to receive a certificate or diploma, as applicable, even if they fail to complete the full degree program. Furthermore, here, **a span period of 7 years is provided for degree completion.**
2. In case a student who have passed all course requirements except for a single paper, due to the adverse circumstances faced by him/her, the entire duration of time spent in pursuing the course is wasted. In such cases, the University may consider granting **special moderation for a single left-over paper** to the extent of a maximum of 10 marks.
3. This special moderation may be in addition to any moderation already applied to that paper. This provision may exclusively be made applicable for students who have passed all course requirements except for a single paper, preventing them from completing the Degree, subject to the satisfaction of the University after careful consideration of the reasons submitted by the student. This special relief may be extended even to students who have exhausted all their opportunities for special chance examinations as granted/as may be granted by the University.



Pursuing of Dual-Degree programmes simultaneously

NOTIFICATION No. Acad.I/Dual Degree/2024/491 dated 3.10.2024

In accordance with the Academic Council Resolution No. 14 dated 12.07.2024 and Executive Council Resolution No. 5 (5-39) dated 27.07.2024, the University has decided to allow pursuing of two-degree programmes simultaneously **within the University**, one in Regular Mode as offered in the colleges/ departments of the University and the other in Open and Distance Learning Mode as offered in School of Open Learning, Campus of Open Learning.

The Modalities & terms and conditions for pursuing two-degree programmes simultaneously are as under:

1. A student enrolled or in the process of enrolling in a degree programme of the University, who desires to pursue two academic degree programmes simultaneously (one in regular mode and the other in Open and Distance Learning (ODL) Mode offered in School of Open Learning, Campus of Open Learning, University of Delhi) shall inform the University through the Head of the Department or Principal of the College, as the case may be. However, students cannot pursue two similar academic programmes simultaneously, such as B.Com (Hons.) and B.Com (Pass) even though one of them is intended to be pursued in ODL.
2. Students so permitted to pursue two academic degree programmes simultaneously shall fulfil all the academic requirements (for example, attendance, Internal Assessment, continuous assessments, submission of assignments, presentations, examination, promotion requirements etc.) of the two academic programmes independently.
3. In order to avoid studying mandatory identical courses twice while simultaneously pursuing two different degree programmes, a student is required to study the compulsory courses for the programme enrolled first (regular or ODL) and substitute such compulsory courses for the programme enrolled later, with appropriate courses.

For example, a student who has enrolled for a regular programme first has to complete the mandatory courses in the regular programme only and vice versa.

Accordingly, Undergraduate programmes such as 'Environmental Science'(EVS) of Ability Enhancement Course (AEC)/ Generic Elective (Language) for B.A. Programmes [where one or both the core discipline(s) is/ are not language(s)]/ etc. shall have to be compulsorily studied by such student for the degree programme enrolled first. The mandatory courses which figures in the other programme pursued in the second-degree programme shall be substituted accordingly, such as

- (i) An undergraduate student who is permitted to pursue simultaneous degree programmes shall study the requisite set of Ability Enhancement Course (ADC) (i.e. AEC language and EVS) as part of the regular Undergraduate programme (UG). In the case of the other degree programme pursued in ODL mode, such student can either opt to study another AEC language or choose a Skill Enhancement course (SEC)/ Value Addition Course (VAC).
- (ii) Similarly, in case a student pursues two different B.A. programmes, instead of Generic Elective (Language), courses from the open Generic Elective (GE) pool may be offered to avoid duplication of courses.
- (iii) Students who are permitted to pursue two academic degrees simultaneously has to take, instead of AEC (Languages), one Skill Enhancement Course or Value Addition Course, as the case may be.

Research theme/ topic for dissertations/ academic projects/ entrepreneurship to be written/ done in the fourth year of the UG programme should be different for the two different degree programmes.

4. A student shall not be permitted to get major or minor in a discipline by combining the credits earned in two separate degree programmes.

RULES & REGULATIONS

FROM THE COLLEGE

The Ordinances, Rules and Regulations of the University of Delhi, available on the University of Delhi website, would be binding on all candidates admitted in Deen Dayal Upadhyaya College, University of Delhi.

In addition, Rules and Regulations of the college as published in college Prospectus and/or notified from time to time through notice board, college website, college mail etc shall also be binding to all the students admitted in our college.

Institutional/ College Email-ID: Once a student is admitted, he/she is issued an institutional email id for all official communication by / to the college. Students should check this email IDs and read the mails regularly. Further, all the Google Forms for filling the options of GE, SEC, VAC, DSE etc. are to be filled using this email id. Students may contact ICT on the 2nd Floor, if email id not working and / or mail to sysadmin@ddu.du.ac.in .

Notice Board / Website: Students are advised to check the Notice Board/ Website for all the notices regarding the Time Table, examinations, holidays, activities etc. Ignorance of any notice will not be accepted as a plea or an excuse for any delay in any matter.

Identity Card: After admission to the college, every student will be issued an Identity Card, which he/she should always carry and present it as and when asked for. Students are strictly advised to not to lend their Identity Cards to anyone else. Non-compliance will render a student liable to disciplinary action.

The card must be returned when a student leaves the college. Loss of Identity Card should be reported to the office immediately. Duplicate Identity Card will be issued on submission of a copy of an Online FIR and a payment of Rs 50/-.

Library Card: Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non- transferable.

Visitors: Students are not permitted to receive or entertain visitors in the college. In case of extreme urgency, they must seek prior permission from the Principal or in his absence from the Vice Principal / Administrative Officer.

Residential Address: In case of change in residential address, the same must be intimated in writing under the signature of parents/guardians to the college Office without delay.

Meeting hours with the Principal: The parents can meet the Principal on any Tuesday or Thursday between 10.00 a.m. to 11.00 a.m. without an appointment or else on other days with prior appointment. The parents of a student who is short of attendance are required to meet the College authorities as and when intimated.

Removal from the College: The Principal is empowered to remove the name of a student from the college rolls if, in the opinion of the Principal, he/she (i) is grossly irregular in attendance or (ii) is not amenable to the college discipline or (iii) is guilty of gross negligence in studies or (iv) is not found fit for the course chosen by him/ her or (v) has not paid College dues in time.

Re-Admission: A student, whose name is removed from the college rolls for non-payment of fees or for any other reason, may be permitted re-admission at the discretion of the Principal on written request by the student. Such readmission shall be on payment of re-admission fees, arrears of tuition fees and fines, after the permission is granted.

RULES & REGULATIONS

FROM THE COLLEGE AND RELEVANT UNIVERSITY ORDINANCE

ATTENDANCE

- 1) Every student admitted to the College is required to attend lectures, tutorials and practicals as per the college time table.
- 2) Attendance will be taken from day one of the new session. Students are expected to check the status of their attendance record which will be displayed on the college website from time to time.
- 3) If a student is unable to attend classes because of medical reasons, he/ she must submit a medical certificate as well as fitness certificate to the College Office not later than a week of rejoining College after illness. Medical certificates submitted late will not be accepted by the College.
- 4) A student, whose name is struck off from the College rolls on account of non-payment of fees or disciplinary action and later re-admitted, will not be given the benefit of attendance during that period.
- 5) In addition, the following relevant provisions of **Ordinance VII (12)** regarding attendance shall be applicable to all the students:
 - i). A candidate for the Semester I/III/V Examination shall not be deemed to have satisfied the required conditions of attendance unless s/he has attended, in all the subjects taken together, not less than two thirds of the lectures/practical/presentations/tutorials required to be attended.
 - ii). Provided that a student of the Semester I/III/V who does not fulfil the required conditions of attendance, as above, but has attended, in all the subjects taken together, not less than 40 per cent of lectures/practical/presentations during the respective semester, may at the discretion of the Principal of the College concerned, appear for the ensuing semester examination; but such a candidate shall be required to make up the deficiency at lectures and practicals, in the next semester of the same academic year
 - iii). Provided that a student of the II/IV/VI semester who does not fulfill the required conditions of attendance as above, but has attended in all the subjects taken together, not less than 40 per cent of the lectures/practical/ presentation/tutorials, held during the respective semester, may at the discretion of the Principal of the College concerned, be allowed to appear at the ensuing examination provided that she/he makes up the deficiency of the said attendance by combining the attendance of the previous semester in the ensuing semester.
 - iv). Provided further that the Principal of the College concerned may permit a student to appear in an examination notwithstanding that the student has not fulfilled the attendance requirement, if in the opinion of the Principal, such student shall make up the deficiency in the succeeding academic year.
 - v). Provided further that a student of the VI semester shall be allowed to appear at the VI Semester Examination, if by combining the attendance of the three academic years, the candidate has put in two-thirds of attendance, in all the subjects taken together, held during the respective years.

Migration: The College does not permit any outward migration from the college. The Principal may at his discretion, permit inward migration in second year only.

Relevant provisions of Ordinance IV - Migration & Re-admission

3. (a) Inter College migration within the University of Delhi in the III Semester of B. A, B. Com, B.Sc., B.A.(H), B. Com (H), B.Sc. (H) Courses under the semester mode may be allowed subject to availability of seats and consent of Principals of both the colleges.

(b) Inter College migration will not be allowed at the post-graduate level.

(c) The last date for migration will be 31st August (Date may be extended as per special Notification)

4. Applications for migration from one college of the University to another shall only be entertained by the Principal if forwarded by the Principal of the college from which migration is sought, and the necessary alteration in the enrolment entries shall only be made in the University Register by the Registrar after obtaining the consent in writing of both Principals.

Re-admission

5. (a) A student of the University having failed to pass any examination of the University will be registered as an Ex-student for re-appearing in the said examination subject to the conditions laid down under the Regulations of the University relating to Conditions of Admission to University Examinations.

Provided that a student, having failed to pass any practical examination(s) of the University through Continuous Evaluation System will be eligible to seek re-admission, only for the purpose of re-appearing in the said practical examination(s) through Continuous Evaluation System) vide Notification No. Aca.I/084-085/093-Ord IV/2022/Date 21.11.2022

(b) A student of the University who was not allowed to appear in the examinations due to shortage of attendance will be re-admitted to the class he studied last in his College/Department, within the prescribed period of registration.

(c) If a student's name is struck off the rolls of his College, he may be re-admitted to the same class at the discretion of his Principal in the same academic year or within the period of registration, if re-admission is sought in any subsequent year. No enrolment fee shall be charged in such a case and a remark in the University Register shall be deemed as equivalent to fresh enrolment.

The term "his college" means the College last attended by the Student.

Change of Subjects

6. No change in the optional or elective subjects or subsidiary subjects in any semester of the Post-graduate or Under-graduate courses is permitted.

However, in case a student is unable to pass the paper after multiple attempts he/she may be permitted to change the optional or elective subjects or subsidiary subjects in any semester of Post-graduate or Under-graduate course, register for new elective course, fulfil all the academic requirements, including attendance, internal assessments and continuous assessment and thus earn the requisite credits **vide Notification** No. Acad. I/084-085/093-Ord.IV/2024/563/26.11.2024)

Discipline: Students are required to maintain discipline in the college premises. Violation of the same will be dealt with as per the Ordinance XV-B of the University of Delhi.

Ordinance XV-B. Maintenance of Discipline among Students of the University

1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify on their behalf.
3. Without prejudice to the generality of power to enforce discipline under the Ordinance, the following shall amount to acts of gross indiscipline:
 - (a) physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/ Department and against any student within the University of Delhi;
 - (b) carrying of, use of, or threat to use of any weapons;
 - (c) any violation of the provisions of the Civil Rights Protection Act, 1976;
 - (d) violation of the status, dignity and honour of students belonging to the scheduled castes and tribes;
 - (e) any practice-whether verbal or otherwise-derogatory of women;
 - (f) any attempt at bribing or corruption in any manner;
 - (g) wilful destruction of institutional property;
 - (h) creating ill-will or intolerance on religious or communal grounds;
 - (i) causing disruption in any manner of the academic functioning of the University system;
 - (j) ragging as per Ordinance XV-C
4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students-
 - (a) be expelled; or
 - (b) be, for a stated period rusticated; or
 - (c) be not for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or
 - (d) be fined with a sum of rupees that may be specified; or
 - (e) be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or
 - (f) that the result of the student or students concerned in the Examination or Examinations in which he/she or they have appeared be cancelled.
5. The Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads of Teaching Departments in the University, the Principal, School of Correspondence Courses and Continuing Education and Librarian shall have the authority to exercise all such disciplinary powers over students in their respective Colleges, Institutions, Faculties and Teaching Departments, in the University as may be necessary for the proper conduct of the Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to, such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
6. Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.

7. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the Rules that have been framed thereunder by the University.

Ragging: Ragging in any form is strictly prohibited. Any student found involved in ragging will be punished under Ordinance XV-C of the University of Delhi. Besides action shall also be initiated as per directives issued by the Hon'ble Supreme Court of India.

Ordinance XV -C. Prohibition of and Punishment for Ragging

1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which-
 - (a) involve physical assault or threat to use of physical force.
 - (b) violate the status, dignity and honor of women students;
 - (c) violate the status, dignity and honor of students belonging to the scheduled castes and tribes.
 - (d) expose students to ridicule and contempt and affect their self-esteem.
 - (e) entail verbal abuse and aggression, indecent gestures and obscene behavior.
4. The Principal of a College, the Head of the Department or an Institution, the authorities of college, of University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
5. Notwithstanding anything in Clause (4) above, the Proctor may also suo moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of raging incidents described in Clause 3 (a), (b) and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
10. The Vice-Chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.

11. In case any students who have obtained degrees of Delhi University are found guilty under this Ordinance appropriate action under Statute 15 for withdrawal of degrees conferred by the University shall be initiated.
12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.
13. All institutions within the Delhi University system shall be obligated to carry out instructions/directions issued under this Ordinance, and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

Note:

Order of the Vice-Chancellor in pursuance of Ordinance XV-C : Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order, Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi, Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

Directives issued by the Hon'ble Supreme Court of India on Anti Ragging

Reference: Directives of the Supreme Court of India dated May 16, 2007 in SLP No(s) 24295 of 2006 University of Kerala Vs Council, Principal's, Colleges, Kerala & Ors (with SLP(C) No. 24296-99/2004 & WP. (CrI) No.173/2006 and SLP(C) No. 14356/2005) and Civil Appeal No. 887 of 2009 dated May 8, 2009.

The Hon'ble Supreme Court of India admitted and heard the above referred SLPs in relation to the menace of ragging in Technical Institutions/Universities/ Colleges in the Country.

In this connection a committee headed by Dr. R.K. Raghavan, Former Director of CBI, for giving specific recommendations on effective prevention of ragging in educational institutions was constituted by the apex court. Accordingly, the Committee had carried out a very detailed study on the various factors contributing for ragging and collected the public opinion. Further, the committee had submitted a detailed report with suitable recommendations and measures required to effectively curb the menace. The recommendations of the Committee were duly accepted and the following directives have been issued to all the educational institutes for necessary implementation by the Hon'ble Court. The Hon'ble Court issued further orders on the 2nd and 3rd report of the Raghavan Committee also.

The salient features of the report / order are summarized below:

I. Factors listed by the Committee

- a) Primary responsibility for curbing ragging rests with academic institutions themselves.
- b) Ragging adversely impacts the standards of higher education.
- c) Incentives should be available to institutions for curbing the menace and there should be disincentives for failure to do so.
- d) Enrolment in academic pursuits or a campus life should not immunize any adult citizen from penal provisions of the laws of the land.
- e) Ragging needs to be perceived as failure to inculcate human values from the schooling stage.
- f) Behavioral patterns among students, particularly potential 'raggers', need to be identified.
- g) Measures against ragging must deter its recurrence.
- h) Concerted action is required at the level of the school, higher educational institution, district administration, university, State and Central Governments to make any curb effective.
- i) Media and Civil Society should be involved in this exercise.

II. Recommendations approved by the Supreme Court

1. The punishment to be met out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
2. Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied with the institutional arrangement for action, a First Information Report must be filed without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority or negligence or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the institutional authority.
3. If any victim or his parent/guardian of ragging intends to file FIR directly with the police, that will not absolve the institutional authority from the requirement of filing the FIR.
4. In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he /she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
5. It shall be the collective responsibility of the authorities and functionaries of the concerned institution and their role shall also be open to scrutiny for the purpose of finding out whether they have taken effective steps for preventing ragging and in case of their failure, action can be taken; for example, denial of any grant-in-aid or assistance from the State Governments.
6. Anti-ragging committees and squads shall be forthwith formed by the institutions and it shall be the job of the committee or the squad, as the case may be, to see that the Committee's recommendations, more particularly those noted above, are observed without exception and if it is noticed that there is any deviation, the same shall be forthwith brought to the notice of this Court.
7. The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the anti-ragging committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.
8. It is necessary that parents/guardians of fresher's assume responsibility for promptly bringing to the notice of the Principal any instance of ragging.
