Subject: Revised Guidelines for Ward Quota Admissions

Dear Sir/Madam

The admission to the wards of employees of University and its Colleges, both teaching and non-teaching, must be done as per Academic Council resolution 9a and 9b dated 27.11.2020 and subsequent amendments thereof. (Refer section 5.56 of the Undergraduate Bulletin of Information 2021-22)

For this purpose, the Admission Branch had issued Steps and Guidelines for admission of wards of the employees on 11.10.2021 wherein it was proposed to Colleges to upload the list of applicants who have applied for admission under ward quota. 25.10.2021 was proposed for commencement of admissions.


However, it was observed that some more clarification to streamline the process of the UG ward quota is required. Accordingly, a mail was sent to all the Colleges on 24.10.2021 informing the postponement of the Ward Quota admissions.

The matter was discussed in detail with the Competent Authority of University of Delhi and accordingly a Notification was issued by the Academic Branch, vide Aca-I/Ward Quota/2021/888 dated 28.10.2021 mentioning the modalities for implementation of ward quota (Annexure-1).

Following must therefore be followed for Ward Quota Admissions:

- 1. The list uploaded by the Colleges on 22.10.2021 regarding ward quota admissions will be treated null and void with immediate effect. Colleges will withdraw all the lists immediately from their websites.**
- 2. Colleges to prepare a fresh list of candidates following the modalities stated in the Notification Aca-I/Ward Quota/2021/888 dated 28.10.2021. While preparing the fresh list, applicants who have approached the college till 10.11.2021 may be considered.**
- 3. Fresh list of shortlisted candidates to be uploaded on College website and mailed to the Admission Branch by 13.11.2021. The lists must be sent to office@admission.du.ac.in and dean@admission.du.ac.in .**
- 4. For the First round of Ward Quota admissions, names of up to 8 Teaching and 8 non-teaching to be mailed at office@admission.du.ac.in and dean@admission.du.ac.in . The same must be uploaded on the College website and approved on the Dashboard by 13.11.2021.**
- 5. Verification and other processes will commence from 16.11.2021.**
