Preference for opting Generic Elective Course in Semester IV for Students.

Some Important Clauses from CBCS Guidelines:

1. A student admitted in a particular department can opt for General Elective Courses offered by other department, for example, a student admitted under B.A. (Hons.) English programme cannot opt for General Elective Courses offered by Department of English.
2. The students admitted under BMS/BFIA programme can opt for General Elective papers offered by specialization different from the one in which they are admitted.
3. The Student of B.Sc. (Hons.) Botany & B.Sc. (Hons.) Zoology must opt one or two General Elective papers offered by Department of Chemistry so that their eligibility for admission in P.G. Courses in various Institutions is not hampered.
4. The students of B.Sc. (Hons.)/B.A. (Hons.)/B.Com. (Hons.) in order to be eligible for Post-graduate in another discipline may opt for the General Elective of a particular subject in each semester to earn 24 credits in the concerned discipline.

All students of Semester IV are required to exercise his/her choice for General Elective Course out of the list mention below in the appended students list proforma to be studied by them in semester IV respectively. Choices once made will not be changed later on.
