- 17) **University Approval of Appointment of Dr. Hem Chand Jain as Vice-Principal and Principal-Acting:** The letter No. CS-I/(111)/Act-Principal/DDU/2021/957 Dated 01.04.2021 received from Assistant Registrar (Colleges) University of Delhi conveying therein the approval of the Hon'ble Vice-Chancellor of the University regarding appointment of Dr. Hem Chand Jain as Vice-Principal as well as Principal-Acting w.e.f. 1.1.2019 till the appointment of regular Principal takes place in terms of Clause 4(4) and 7(3) of the Ordinance XVIII of the Ordinances of University of Delhi was reported and recorded. 
- 18) The House nominated **Professor Monica Singhania as Management Nominee for IQAC.**
- 19) Consequent upon being elected as Chairman Governing Body, Brig. Kapil Dev Malhotra withdrew his name from all the committees constituted by the Governing Body in its meeting held on 9.1.2021. The House authorised the Chairman to reconstitute all these committees.
- 20) The teaching and non-teaching members raised the issue of Non-payment of Salary. It was informed by the member secretary that all the dues of the FY-2020-21 have been paid including arrears to majority of Staff members. Further, for the FY-2021-22 the college has received GIA for 1st quarter out of which salary for the month of March and April 2021 have been paid fully and for the month May 2021 partial salary has been paid to the staff members. As on date the college is not in a position to pay salary for the month June 2021 onwards and other expenses from July onwards. The House resolved to request the Government of NCT of Delhi to release adequate grants to the college so that salary can be paid to staff.
- 21) The teaching and non-teaching members raised the issue of Non-payment of T.A. for the month of May, 2021 to a number of staff members. After prolonged discussion, the house resolved to follow clarification regarding admissibility of Transport Allowance during nationwide lockdown due to Covid-19 pandemic issued by Department of Expenditure, Ministry of Finance, Govt. of India vide OM No. 21/3/2020-E.II (B) dated 01.12.2020, wherein it has been stated that the employees, who could not attend office and worked from home in a whole Calendar month, are not eligible to draw Transport Allowance for that month as these employees had not incurred any expenditure for commuting office.
