

Even the India Today Survey-2018 has ranked our college 11<sup>th</sup> in the Science Stream and 17<sup>th</sup> in the Commerce Stream pan India.

Over the next three years you will have ample opportunity to explore your potential and achieve excellence in your chosen area of specialization. The 26 Societies - Debate, Dramatics, Music, Environment, NSS - to name a few, will help you in community development and building soft skills. Those pursuing science will have enough options from Robotics to Data Science and nano-chemistry to DNA finger printing for practical learning through the support received from DBT Star College Scheme. You will have the option to go in for internship programs to industry or Scientific Organizations so as to develop higher levels of skills. You may also help school students by conducting workshops for them in your college to give them a similar exposure.

We would like to sensitize all our students towards social and environmental issues. As our social responsibility we have been following the Government's policy for Swacha Bharat Mission wherein our students have adopted villages and slums to work on summer internship projects. The objective of these internships is to improve the outlook of the residents towards hygiene and cleanliness. Through 'Ek Bharat Shreshtha Bharat' Abhiyan students get an opportunity to interact with people of diverse cultures during the exchange programs.

We have a green campus with rain water harvesting, sewage treatment plant, solar power generation of more than 500 KW per day and solar water heater. All this coupled with world class infrastructure provides an excellent teaching learning environment in the College. Make the best use of all these facilities and go ahead full throttle.

My good wishes for your bright future and a wonderful experience of your stay in the college.



Deen Dayal Upadhyaya College made its beginning in a school building at Karampura in 1990. The staff and students kept struggling for the want of space and appropriate infrastructure. Despite all odds the College created a niche for itself in the University and the city of Delhi. Having focus on both academic and co-curricular activities, the College achieved the unique distinction of being ranked 13th in India in the NIRF survey conducted by MHRD for the session 2017-2018 for the colleges section. For the past five years consecutively, the College is being ranked 8th/9th in Delhi and between 35 to 42 in India by Nielsen survey conducted by the India Today Group. But this year our College has been ranked 11<sup>th</sup> in Science Stream and 17<sup>th</sup> in Commerce Stream pan India. In Delhi, in Science Stream it has been ranked at 6<sup>th</sup> position.

"Star College Scheme" has been initiated by Department of Biotechnology (DBT), Govt of India to support colleges and University departments offering undergraduate education to improve science teaching. The programme aims to improve the skills of teachers by organising faculty training,

improved curriculum and emphasis on practical training to students by providing access to specialised infrastructure and consumables. In 2018, DBT under Star College Scheme has sanctioned a sum of Rs 1.04 crores for three years for strengthening of Life Science and Biotechnology Education and Training at undergraduate level for five departments of our college i.e. Botany, Zoology, Chemistry, Electronics and Mathematics. In order to organize Faculty Development Programs for teachers on cutting edge technologies, the College has signed aggrements with ICT Academy, a non-profit Government supported organization, i3indya Technologies and Zyego, a wellness company.

We began the session 2016 at our new campus at Dwarka in a state of the art building. All our class rooms, most of the laboratories, faculty rooms, library, cafeteria and offices are

air conditioned. We have both boys' as well as girls' hostels, each having a capacity of 90 students. With 100 percent power back up, the campus is fully Wi-Fi enabled. It has many features of a green building such as rain water harvesting, sewage treatment plant, water recycling plant, solar power, solar heater etc. It has enough space for parking of more than 600 cars.

The College also has a sprawling centrally air conditioned library running through three floors. А computer centre, well furnished auditorium, Seminar two rooms. departmental research laboratories, gymnasium and facility for indoor squash court and badminton court are some additional facilities. All the lecture theaters and lecture rooms are also air conditioned.

We have always believed in the proverb, "Institutions are built by human beings and not by brick and mortar". Keeping this in mind we shall continue to strive for making DDUC the best educational institution in the country.

Further cut-off lists may be declared by the University of Delhi, depending on vacant seats in the colleges.

#### IMPORTANT POINTS FOR ADMISSION

- The admissions to various colleges of the University of Delhi are based on merit/entrance criteria. Applicants seeking admission to UG merit based programmes/courses and entrance test based programme/courses must register on a centralized admission web portal on the University of Delhi website http://www.du.ac.in
- The timing for the verification of the documents and approval of admission in the colleges will be from 9:30 AM to 1:30 PM. Once the college approves admission, the candidate is permitted to make online admission fee payment till 12:00 noon of the next day of the given admission list deadline.
- > If the seats remain vacant after fifth cut-off, the further cut-off list (s) may be declared.
- Candidates seeking admission on the basis of Sports and/or Extra Curricular Activities are required to register on UG Admission Portal of University of Delhi.
- (i) The applicants have to upload only self attested highest sports certificate/achievement certificate issued from May 01, 2015 to April 30, 2018 in each sport/game/ECA activity they wish to apply.
- (ii) The admission under sports quota will be based on (a) With sports trial (weightage for trials is 60% & certificate is 40%) and (b) super category direct admission without sports trial.
- (iii) For ECA admission trial will be held at two levels: (i) Preliminary trials (i) Final trials. In the final trials weightage of 75% will be given to trials and 25% to certificates.
- Candidates seeking admission under the category of wards/widows of armed forces personnel(CW), Jammu and Kashmir migrants should register themselves with University of Delhi through UG admission portal of University of Delhi. CW Category candidates have a separate admission schedule. Please refer Bulletin of Information 2018-19 of University of Delhi.
- The foreign nationals seeking admission in the University / its colleges shall have to apply online through Foreign Students' Registry portal http://fsr.du.ac.in
- ➤ Gap year(s) would be no bar for the purpose of admission to the undergraduate courses.
- The admission in any programme/course shall not be granted on predicted scores issued by various boards/schools.
- If any board declares the percentage marks of individual subjects along with the grades, then marks shall be taken into consideration.
- As per A.C. Resolution 40, dated 24/04/1997, no student of the University shall be permitted to pursue two degree courses simultaneously either from the University of Delhi or from other University except the part-time diplomas /certificate course of the University of Delhi.
- As per Ordinance I of the University, there is no minimum age bar for admission to the undergraduate and postgraduate courses in the University and its colleges except in the courses where the respective regulatory bodies (such as MCI, AICTE etc.) have prescribed the minimum age requirement in their regulations.

- i. All subjects to be included in the calculation of 'Best Four' must have at least 70% theory component of exam. In case, the subject to be considered does not have 70% theory component and 30% practical component, then the marks of theory and practical only shall be converted to 70% and 30%, respectively on pro rata basis. These new marks will then be considered for calculation of 'Best Four'. The theory marks should not include marks of internal assessment or viva-voce examination.
- ii. The Applicant should have passed theory and practical separately, except the applicant who has passed the qualifying examination from Council for Indian School Certificate Examination, New Delhi.
- iii. In case a candidate has studied both elective and core in a language, then core language subject will be treated as language, while elective language can be considered as academic/elective subject.

#### ADMISSION PROCEDURE

- 1. The admissions to various colleges of the University of Delhi are based on merit/entrance criteria. The candidate seeking admission to the Undergraduate Courses- UG merit based and UG entrance test based programme courses must have registered online on the UG admission portal: https://ug.du. ac.in/app/.
- 2. The candidate who meets the requisite cut-off\* will login to the UG admission portal (https://ug.du. ac.in/app/) and select college/course where he/she wishes to take admission.
- 3. He/she shall take the print out of the admission form and together with the list of documents/ certificates shall report to the college for verification of documents according to admission schedule.
- 4. The candidate who qualifies, is required to produce the following documents in original with two sets of self-attested photocopies **along with the print out of the admission form at the time of admission**:
- i. Certificate of Secondary School Examination/ Matric (X class) as proof of Date of Birth.
- ii. Marks sheet of class XII.
- iii. Class XII Provisional Certificate / Original Certificate.
- iv. Character Certificate from the school/college last attended (recent).
- v. SC/ST/PwD/CW/KM Certificate (in the name of the candidate) issued by the competent authority. The name of the candidate taking admission to the college must be the same as on the certificate.
- vi. OBC Certificate (in the name of the Candidate) issued by Competent Authority and a Non -Creamy Layer status certificate for the financial year 2017-18, issued after 31<sup>st</sup> March, 2018.
- vii. Transfer Certificate from school / college as well as Migration Certificate from Board / University are required from those students who have passed senior secondary exam from outside Delhi.
- viii. Two recent self-attested passport size photographs.
- ix. Proof of last examination in Hindi Language passed, if available.
- 5. The college will retain the certificates of approved candidate. However, the college will return the documents in case student withdraws/cancels the admission or student wishes to appear in counselling of any other university/ institute.
- 6. Selected candidate will make the online Admission Fee payment by logging-on to the UG admission portal. The approved candidate is permitted to make online admission fee payment till 12 noon of the next day of the given admission list deadline.
- 7. The Admission in a college is completed only after realization of the fee payment on the UG admission portal within the prescribed time-limit. In case a student cancels the admission from the college, the fee will be adjusted or refunded by University of Delhi online through its UG admission portal.
- 8. The colleges shall admit all the candidates who meet the announced cut-off criteria. The policy will not be "first come, first served."
- 9. A candidate can take admission only in one course in one college at any given time.
- 10. The candidates who could not take admission in a given cut-off list can be considered for admission in the immediate next cut-off list only on the last date of admission, subject to availability of seats.

Compliance with the above requirements does not necessarily ensure admission to the College. All admissions are provisional and subject to approval of University of Delhi on submission of University Enrolment form.

Any candidate seeking admission on false attestation /forged certificate in respect of age, caste, subject and/or percentage of marks etc. will be debarred from attending any course in the university or its colleges for next five years and in addition, a criminal case under relevant section of IPC (viz 470, 471, 474 etc.) will be instituted against him/ her to subject him/her to requisite criminal proceeding.

The cut-off percentage of marks will be notified on the college notice board/ college website/ university website as per the schedule announced by the University of Delhi.

#### NOTE :

1. Students of all Honours Courses including BMS opting Generic Paper having practical for semester I and/or semester II will have to deposit an additional amount of Rs. 200/- as and when demanded by the college.

The student (1<sup>st</sup> year) is required to deposit the fees online through UG admission portal of University of Delhi. In case a student cancels
the admission from the college, the fee will be adjusted or refunded by University of Delhi online through its UG admission portal.

- 3. Fee once paid is refundable only as per University rules.
- 4. Security money is refundable on an application made by the student, within a period of one year of his /her leaving the College and after deducting the cost of breakage, loss of books and other outstanding dues, if any, as per rules.
- 5. As per the decision of the University of Delhi, the College shall charge an amount of Rs 6,000/- per year from every foreign student seeking admission in all courses except B. Sc. (Hons) Computer Science for which the charge from all countries (other than SAARC nationals) will be Rs 2,10,000/-.

Total Fee for PwD candidates is Rs. 1,730/- for admission to first year of all courses.

#### 1. Scheduled Caste(SC)/Tribe(ST)

As per University rules, 22.5% of the total number of seats in each course are reserved for the candidates belonging to SC/ST (15% for SC and 7.5% for ST interchangeable, if necessary). Relaxation to the extent of 5% in the minimum marks will be given to these candidates. However, if the seats remain vacant, the minimum eligibility will be pass percentage in the qualifying school/degree examination. The seats reserved for the SC/ST shall be filled by the SC/ST candidates only. If still, any seat remains unfilled, the same shall be left vacant.

#### 2. Other Backward Classes (OBC)

- a) 27% of the total seats in each course are reserved for the OBC candidates. The OBC candidates shall be given a relaxation of 10% of the minimum eligibility marks of the said course and in the admission entrance test of 10% of the minimum eligibility marks prescribed for the General Category candidates.
- b) All those OBC candidates who meet the minimum eligibility marks in the qualifying examination and the minimum eligibility marks (if any) in the entrance test shall be eligible for admission in the order of their merit, keeping in view the availability of seats reserved for them.
- c) Only those OBC candidates who belong to the 'Non-Creamy Layer' and whose castes appear in the Central List of the OBCs notified by the Ministry of Social Justice & Empowerment on the recommendations of the National Commission for Backward Classes available at the website of the Commission (http://ncbc.nic.in/backwardclasses/index.html) shall be eligible to be considered for admission under the OBC category.
- d) If the seats meant for OBC remain vacant after arriving at the minimum eligibility, the same may be converted and filled up by other eligible applicants, a subject to approval of University of Delhi.

#### 3. Persons with Disabilities (PwD)

As per the provisions of Rights of Persons with Disabilities Act, 2016, not less then five percent (5%) seats are reserved for Persons with Benchmark Disabilities. The person with "benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. Please refer Bulletin of Information 2018-19 of University of Delhi for specified categories of disabilities. These seats are supernumerary. The relaxation in minimum eligibility conditions, if any, will be as per University of Delhi rules.

#### 4. Wards / Widows of the Armed Forces Personnel (CW)

As per University rules, 5% of the total number of seats in each of the courses have been reserved for Wards / Widows of Officers and Men of the Armed Forces Including Para Military Personnel. Admission may be offered to them in the following order of preference:

- i. Widows/Wards of Defence personnel killed in action;
- ii. Wards of Defence Personnel disabled in action and Boarded out from service with disability attributable to military service;
- iii. Widows/Wards of Defence Personnel who died in peace time with death attributable to military service;
- iv. Wards of Defence Personnel disabled in peace time with disability attributable to the military service; &
- v. Wards of serving Ex-servicemen personnel including personnel of police forces who are in receipt of Gallantry Awards.

These seats are supernumerary. The candidates belonging to this category shall report as per schedule given in section 2.8 of Bulletin of Information 2018-19.

#### 5. Foreign Nationals

As per University rules, 5% seats in first year of each course in colleges are reserved for Foreign Nationals. These seats are supernumerary. The foreign nationals seeking admission in the University / its colleges shall have to apply online through Foreign Students' Registry portal http://fsr.du.ac.in and can contact Deputy Dean (Foreign Students' Registry), Conference Centre, University of Delhi-110007 for further details. Email: fsr\_du@yahoo.com. Phone No. +91-11-27666756 No foreign students will be admitted directly by the Department/Colleges.

#### 6. Reservation of Kashmiri Migrants (KM)

Upto 5% seats are reserved programme-wise in all colleges for Wards of Kashmiri Migrants. These seats are supernumerary. A concession of maximum 10% in the last cut-off marks fixed for unreserved category applicants shall be extended to the Kashmiri Migrants. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the Colleges as per admission schedule.

Candidates belonging to category 4&5 will be admitted in the college on submission of the provisional admission slip issued by University of Delhi.

#### **ONLINE RETAILING : AN INDUSTRY ORIENTATION FOR UNDER GRADUATE STUDENTS**

In today's competitive environment more and more people are approaching to the corporate sector. With the introduction of internet and technology, e-retailing has become an indispensable part of corporate sector. This course, under the ageis of IQAC, offers exposure to undergraduates in various domains of e-retailing. Infact, after this, they can further upgrade and sharpen their skills in any domain of e-retailing technology market to move up the corporate ladder. The course will train the students in industry relevant skills. The course is divided in five modules: Operation Management of online Retailing, Web-Set Up for On-Line Retailing, Financial Accounting of online Retailing using Tally, Digital Marketing and Information Management using Sales Force and CMDM.

The Operation Management module focuses on data visualization which will help students on data analysis, and to present clean , focused and impactful information in a more professional way . Web-Setup module focuses building Online Retailing Application and Recommender Systems for Online Store. The financial accounting module focuses on invoicing and accounting skills.Digital marketing helps to build a brand name on the internet while the information management module meets the corporate demand for analyzing sales and marketing efforts through training in salesforce. So all, in all it is a total package to make the students ready to choose their entry level career with much more confidence.

#### **CWEB** In 1943, by a Delhi University Act, Non-Collegiate Women's Education Board was established, where in women students were enabled to take some of the examination of the University with special coaching but without attending regular classes. This gave shape to the Non-Collegiate Women's Education Board (NCWEB). The Board began functioning in September, 1944 with 3 students. At present, the enrolment is more than 24,000. Only women students residing in the National Capital Territory of Delhi can enroll themselves.

The college started its NCWEB chapter, in July, 2017 by admitting 450 students in two courses, B.A. and B.Com. The classes are held on Saturdays and during academic breaks which leaves students with ample time to work or pursue other goals. The students are not only given exposure of academic life but also co-curricular activities. This year two important workshops were organised: Gender Sensitization through an NGO Breakthrough and the other on Confidence Building and Memory Techniques. RUNG 2018, the cultural Festival was organized on January 27, 2018 in which the students showcased their artistic capabilities.

## AWARDS & SCHOLARSHIPS

- (ii) Financial Assistance out of VC Student fund is given to poor deserving students, who have passed Annual Examination of Current year from University of Delhi and belong to BPL/APL families (Rs. 3000/-).
- (iii) Under Graduate Science Meritorious Award is given to students who secure highest marks in B.Sc.(H) Physics, Chemistry, Botany and Zoology.

#### STATE GOVERNMENT AWARD

The Govt. of Delhi gives three awards of Rs.10,000/- each in Science, Commerce and Humanities to students securing highest marks in their respective discipline among colleges of Govt. of NCT of Delhi.

#### PT. VIDYADHAR TRIPATHI MEMORIAL AWARD

Student who scores highest marks in B. Com (Hons) every year will be awarded a cash prize of Rs. 1000/-, a shield and a certificate out of the interest income on the endowment fund instituted by his niece Dr. Vanita Tripathi.

#### SHRI GHASI RAM MITTAL MEMORIAL AWARD

Out of the interest derived from Shri Ghasi Ram Mittal Memorial Scholarship Endowment fund (sponsored by his son Sh. Ram Kumar Gupta), scholarships of Rs. 4000/- each are given to the students who secure the highest marks but not less than 70% marks in the combined result (I & II Sem. University Examination) in the first attempt in the following courses:B. Sc. (Hons) in Computer Science, Electronics, Mathematics, Physics, Chemistry, Botany, Zoology, B. A. (Hons) English, B. A. & BMS.

#### SHRI SULTAN CHAND MEMORIAL SCHOLARSHIP

Out of the interest derived from Shri Sultan Chand endowment fund (instituted by Shri Sultan Chand Trust), a scholarship of Rs 3,500/- is awarded every year to a student of B. Com (Hons) who secures the second highest percentage of marks, being above 70% as aggregate in II year University examination in the College.

#### SHRI SULTAN CHAND DROPADI DEVI MEMORIAL SCHOLARSHIP

Out of the interest earned from endowment funds in the name of Shri Sultan Chand Dropadi Devi (instituted by Shri Sultan Chand Dropadi Devi Education Foundation), six scholarships of Rs 4000/- each to the students securing highest marks in each semester of the three year B. Com (Hons) will be awarded.

#### FROM STATE GOVERNMENTS TO SC / ST / OBC / MINORITIES STUDENTS

- a) SC/ST/OBC/Minorities students are awarded scholarships by the States to which they belong;
- b) SC/ST/OBC/Minorities students of Delhi applying for (i) post matric and/or (ii) meritorious scholarship provided by Department for Welfare of SC / ST / OBC / Minorities, Govt. of NCT Delhi, are advised to contact the office immediately after the admission. The continuance of any feeship, scholarship or grants of other privileges depends on satisfactory academic progress, regular attendance, discipline and good conduct;
- c) SC / ST / OBC / Minorities students are advised to contact Department for Welfare of SC / ST / OBC / Minorities, Govt. of NCT Delhi for hostel facilities provided by the Department.

#### **FEE CONCESSION**

The College awards fee concession to needy, deserving and meritorious students. Application on prescribed forms is to be submitted to the Accounts Section. The dates will be notified on college website. The College also provides exemption of Tuition Fee and Admission Fee to all SC/ST students, whose parents are not liable to pay income tax on their income on submission of a certificate from employer / competent authority for the same.

#### STUDENTS AID FUND (SAF)

The College operates this fund with the objective of rendering financial assistance to needy and deserving students of the College. Assistance is usually given in the form of textbooks etc. Students in need of financial aid can apply when invited through circulars on the notice board.

#### **COLLEGE SCHOLARSHIP**

A scholarship of Rs. 10,000/- per annum is instituted by the college and is given to students on following considerations:

- a) Merit-cum-Means: The students whose parent's family income is below the taxable limit, subject to no backlog of papers.
- b) Students who are high achievers in academics, having secured position within first three in the University Examination of the previous year (by combining marks of odd and even semesters).
- c) Outstanding sports persons, who have participated in International Events.

## Rules & Regulations

#### Cancellation/ Withdrawal of Admission

Any student interested in getting his/her admission cancelled on or before 16<sup>th</sup> August, 2018 is required to fill a performa available from the College Office and submit it to the Coordinator Admission Committee. After this date, a student may withdraw from the College by making an application to the Principal intimating the date of withdrawal. He/She will be required to pay all the fees and other charges which may fall due for the period.

- **C.** Full fee including examination fee will be refunded when admission is made inadvertently due to error / omission / commission on the part of the college and is cancelled afterwards.
- **D.** No Fee will be refunded in case of cancellation of admission due to concealment/ falsification of facts, submission of false/ fake certificate(s), providing misleading information by the student or for any error/ mistake on the part of the student.

#### Compulsory Test in Hindi

Students enrol for degree courses, who have not studied and passed Hindi upto 8<sup>th</sup> Class are required to pass the Compulsory Test in Hindi (CTH) conducted by University of Delhi in order to be eligible for award of degree. Such students are required to contact be college office immediately after the commencement of classes.

#### Attendance

- 1. Every student admitted to the College is required to attend lectures, tutorials, presentations and practical as per the college time table. No student will be permitted to appear in the University examinations unless he/she has attended at least two thirds of the lectures/tutorials/practicals/presantations held in all subjects taken together in each semester. For further details, please refer Ordinance VII (2), University of Delhi.
- 2. Attendance will be taken from day one of the new session. Students are expected to check the status of their attendance record which will be displayed on the students' notice board/college website from time to time.
- 3. If a student is unable to attend classes because of medical reasons, he/she must submit a medical certificate as well as fitness certificate to the College Office not later than a week of rejoining College after illness. Medical certificates submitted late will not be accepted by the College.
- 4. A student, whose name is struck off from the College rolls on account of non-payment of fees or disciplinary action and later re-admitted, will not be given the benefit of attendance during that period.

Re-admission in the College is not a matter of right.

#### **RULES & REGULATIONS**

**Migration :** The college does not permit any outward migration from the college. The Principal may at his discretion, permit inward migration in second year only.

**Removal from the College :** The Principal is empowered to remove the name of a student from the college rolls if, in the opinion of the Principal, he/she (i) is grossly irregular in attendance or (ii) is not amenable to the college discipline or (iii) is guilty of gross negligence in studies or (iv) is not found fit for the course chosen by him/ her or (v) has not paid College dues in time.

**Re-Admission :** A student, whose name is removed from the college rolls for non-payment of fees or for any other reason, may be permitted re-admission at the discretion of the Principal on written request by the student. Such re-admission shall be on payment of re-admission fees, arrears of tuition fees and fines, after the permission is granted.

**Notice Board** / **Website :** Students should make it a habit to read the notice board/website regularly to check notices for schedule of classes, examinations, holidays, activities and other information of relevance. Ignorance of any notice will not be accepted as a plea or an excuse for any delay in any matter.

**Identity Card :** After admission to the college, every student will be issued an Identity Card, which he/ she should always carry and present it as and when asked for. Failure to do so will render a student liable to disciplinary action. The card must be returned when a student leaves the college. Loss of Identity Card should be reported to the office immediately. Duplicate Identity Card will be issued on payment of Rs 50/-.

**Library Card :** Students need to furnish their fee receipt and the college Identity Card to become a member of the library. The library offers yearly membership, which is renewed subject to annual clearance. The library card is non-transferable.

**Visitors :** Students are not permitted to receive or entertain visitors in the college. In case of extreme urgency they must seek prior permission from the Principal or in his absence from the Vice Principal / Administrative Officer.

**Residential Address :** In case of change in residential address, the same must be intimated in writing under the signature of parents/guardians to the college Office without delay.

**Internal Assessment :** Internal Assessment is governed by the Ordinance VIII E of the University of Delhi (see Annexures), as amended and notified by University of Delhi from time to time.

**Passing and Promotion Criteria :** Passing and Promotion Criteria is governed by Ordinance IX of University of Delhi, as amended and notified by the University from time to time. The relevant provisions of the amended Ordinance IX as on date are given in Annexures.

Rain water harvesting system and water recycling plant are already in place. The roof tops are to be used for generation of solar power. The College is planning to install a waste treatment plant for addressing the issues of bio-waste disposal.

#### **ABORATORIES:** Enhancing Skills

The College has three computer laboratories with over 140 computers of the latest configuration and internet facility through the Delhi University optical fiber connection. The laboratories are being fully equipped with the latest multimedia equipment including LCD projectors and will also have facilities for Video-Editing, Image Editing, Animation, Audio-Editing and Authoring Tools. There are four Physics laboratories and two Electronic laboratories which have state-of- the-art equipments to conduct experiments. These laboratories are equipped with 35 CRO's, 55 Function Generators, 37 Micro-processor Kits, 48 Digital Storage Oscilloscopes (Tektronix), 3 Arbitrary Function Generators (Tektronix), 57 Computers, 22 Spectrometers, besides other equipments including: Hall effect set-up, Michelson Interferometer, Laser Kits, Optical fiber kits etc. To conduct

experiments in Life Sciences, there are two Museums containing various specimens and models and two laboratories each of Botany and Zoology, well equipped with latest instruments that include Microscopes having 15000 x magnifications. For Chemistry there are three laboratories of which, one is an Analytical Technique Laboratory equipped with instruments like Flame Photometer, UV-Visible Spectrophotometer, Scanning Visible Spectrophotometer.

#### **ECTURE HALLS:** Empowering with Knowledge

The College has twelve well laid-out lecture halls that have a seating capacity of 70 each, 36 lecture rooms having a capacity of 40-60 and 2 seminar rooms with a capacity of 100-150 each. The desks are well spaced out and the halls are airy, well-lit and have fine acoustics.

Each hall also has the latest audio visual teaching aids.

#### OMPUTER CENTRE: Simplifying Technology

The Campus has a centrally Air Conditioned Computer Centre on the second floor of the C block, with a capacity of

about 200 users to promote network based knowledge and learning. The ICT infrastructure consists of a server, desktops and a gigabit fiber backbone which provides 24x7 dedicated Internet connectivity through WLAN (Wi-Fi) and LAN. It facilitates students and faculty to access a world class teaching and learning system.

#### **ESEARCH ROOM:** Promoting Innovation

E ach science department of the College has a Research Laboratory that provides facilities to the faculty to work on research projects. Besides, there is a DBT star college program lab too. The college has also created an endowment fund of Rs. 3 Cr. Out of its interest, research grant from Rs. 1 Lakh to Rs. 3 Lakhs is provided to the faculty to promote research culture in the college.

#### **IBRARY:** Resource and Information Centre

The college has an excellent fully air-conditioned central library facility spread over three floors. It has a total floor area of 2,550 sq. meters, with a provision for a separate reading section for the faculty and spacious reading hall to accommodate over 200 students. The library is fully computerized, comprising of 40 PCs with Internet access and all its function and operations are done through a dedicated network of computer system using library software.

The library has a rich and active collection of text-books and reference books which is extensively utilized by the students. One floor with a seating capacity of around 85 persons is meant exclusively for reference book consultation and internet based Library services. It has an up-to-date bibliographic database of books and journals. The library has a total collection of 43573 volumes of text-books and reference books. It subscribes to 68 journals & magazines of national and international repute in all the relevant subject areas. Besides this, the library subscribes to 15 national newspapers. It has 613 bound volumes of journals and 834 CDs in its collection. The library also provides book-bank facility to students belonging to SC/ST/OBC categories and other economically poor and meritorious students of the college. Through the University dedicated fiber-optic link, the library has access to as many as 50,000 subscribed e-journals and more than 2 Lakh e-books. The entire college campus including the library and the hostels are Wi-Fi enabled to provide 24X7 seamless access to information remotely from anywhere in the campus.



#### **COLLEGE INFRASTRUCTURE**

#### **OSTELS:** *Home Away from Home* DUC is the dream destination of students' pursuing Science, Commerce, Management, and English, and other Social Science stream. Having an opportunity of admission in DDUC is a great privilege and feeling of pride. As a number of students come from outside Delhi, On-Campus residence facility is a privilege for the students.

DDUC provides hostel facilities for students in its newly constructed building. The institute has separate hostels for Boys and Girls, and provides excellent accommodation to 180 students. The hostels have twin sharing rooms which are well furnished, and have attached bathrooms with hot water supply during winters. All rooms are furnished with a bed, mattress, study table, book rack, chair, cupboard/shelf for each student. The hostel rooms are well ventilated. Round the clock security is provided. There are separate Students' Messes (intended to be air- conditioned) for boys and girls along with the cafeteria facility. Recreation Rooms with TV in boys and girls hostels and sports facilities is available. There are nine residential flats for the staff.

#### CUEST HOUSE

A well furnished Guest House is available in the campus. Accommodation in the Guest House will be available to the parents/guardians of students and visiting faculty on payment basis, depending on availability.

#### AFETERIA & INDOOR SPORTS COMPLEX



### **STUDENT ACTIVITIES**

#### **ECO-CLUB**

The main purpose of the Eco club is to make students aware about environmental issues. A number of activities such as excursions to National Parks, Lectures, Cleanliness drive, quiz etc. are organized to motivate students to think that if we cannot sustain environment we cannot sustain ourselves. #### NATIONAL SERVICE SCHEME (NSS)

NSS is primarily dedicated to chanelize the energies and capabilities of youth towards community service, upliftment of society and hence nation building. Every volunteer devotes some time teaching children in nearby slums.

They also participated in the Promotion and Awareness of the Health Scheme of the Government of NCT, Delhi to provide free tests and surgeries to needy people. #### DIRECTIVES OF THE HON'BLE SUPREME COURT OF INDIA ON ANTI-RAGGING

Ref. : Directives of the Supreme Court of India dated May 16, 2007 in SLP No(s) 24295 of 2006 University of Kerala Vs Council, Principal's, Colleges, Kerala & Ors (with SLP(C) No. 24296-99/2004 & WP. (Crl) No. 173/2006 and SLP(C) No. 14356/2005) and Civil Appeal No. 887 of 2009 dated May 8, 2009.

The Hon'ble Supreme Court of India admitted and heard the above referred SLPs in relation to the menace of ragging in Technical Institutions/Universities/ Colleges in the Country.

In this connection a committee headed by Dr. R.K. Raghavan, Former Director of CBI, for giving specific recommendations on effective prevention of ragging in educational institutions was constituted by the apex court.

Accordingly, the Committee had carried out a very detailed study on the various factors contributing for ragging and collected the public opinion. Further, the committee had submitted a detailed report with suitable recommendations and measures required to effectively curb the menace. The recommendations of the Committee were duly accepted and the following directives have been issued to all the educational institutes for necessary implementation by The Hon'ble Court. The Hon'ble Court issued further orders on the 2nd and 3rd report of the Raghavan Committee also. The salient features of the report / order are summarized below :

#### I. Factors listed by the Committee

- a) Primary responsibility for curbing ragging rests with academic institutions themselves.
- b) Ragging adversely impacts the standards of higher education.
- c) Incentives should be available to institutions for curbing the menace and there should be disincentives for failure to do so.
- d) Enrolment in academic pursuits or a campus life should not immunize any adult citizen from penal provisions of the laws of the land.
- e) Ragging needs to be perceived as failure to inculcate human values from the schooling stage.
- f) Behavioural patterns among students, particularly potential 'raggers', need to be identified.
- g) Measures against ragging must deter its recurrence.
- h) Concerted action is required at the level of the school, higher educational institution, district administration, university, State and Central Governments to make any curb effective.
- i) Media and Civil Society should be involved in this exercise.

#### II. Recommendations approved by the Supreme Court

- 1. The punishment to be met out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
- 2. Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied with the institutional arrangement for action, a First Information Report must be filed without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority or negligence or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the institutional authority. If any victim or his parent/guardian of ragging intends to file FIR directly with the police, that will not absolve the institutional authority from the requirement of filing the FIR.
- 3. In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he / she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
- 4. It shall be the collective responsibility of the authorities and functionaries of the concerned institution and their role shall also be open to scrutiny for the purpose of finding out whether they have takena effective steps for preventing ragging and in case of their failure, action can be taken; for example, denial of any grant-in-aid or assistance from the State Governments.
- 5. Anti-ragging committees and squads shall be forthwith formed by the institutions and it shall be the job of the committee or the squad, as the case may be, to see that the Committee's recommendations, more particularly those noted above, are observed without exception and if it is noticed that there is any deviation, the same shall be forthwith brought to the notice of this Court.
- 6. The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the anti-ragging committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.
- 7. It is necessary that parents/guardians of freshers assume responsibility for promptly bringing to the notice of the Principal any instance of ragging.

#### COLLEGE COMPLIANCE WITH THE DIRECTIVES OF THE HON'BLE SUPREME COURT OF INDIA

#### xviii) Undertaking from Students and Parents

Each student of the Institute and his/her parents and/or Guardian are hereby required to submit a combined undertaking at the time of registration, in the prescribed format as attached to this Order, which is mandatory for registration.

#### **ORDINANCE XV-B**

#### Maintenance of Discipline among Students of the University

- 1. All powers relating to discipline and disciplinary action are vested in the Vice- Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
- a. Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/Department and against any student within the University of Delhi
- b. Carrying of, use of or threat to use of any weapons
- c. Any violation of the provisions of the Civil Rights Protection Act, 1976
- d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
- e. Any practice-whether verbal or otherwise derogatory of women
- f. Any attempt at bribing or corruption in any manner
- g. Willful destruction of institutional property
- h. Creating ill-will or intolerance on religious or communal grounds
- i. Causing disruption in any manner of the academic functioning of the University system;
- j. Ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students -
- a. be expelled; or
- b. be, for a stated period rusticated ; or
- c. be not, for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or

- d. be fined with a sum of rupees that may be specified; or
- e. be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or
- f. the result of the student or students concerned in the Examination or Examinations in which he, she or they have appeared be cancelled.
- 5. The Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads of Teaching Departments in the University, the Principal, School of Open Learning and Librarians shall have the authority to exercise all such disciplinary powers over students in their respective colleges, institutions, faculties and teaching departments in the University as may be necessary for the proper conduct of the Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
- 6. Without prejudice to the powers of the Vice Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.
- 7. At the time of admission, every student shall be required to sign a declaration that on admission he/ she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University.

#### **ORDINANCE - XV-C**

#### Prohibition and Punishment for Ragging

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice or ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which.
- a. Involve physical assault or threat to use of physical force.
- b. Violate the status, dignity and honour of women students.
- c. Violate the status, dignity and honour of students belonging to the scheduled castes and tribes.
- d. Expose students to ridicule and contempt and affect their self-esteem.
- e. Entail verbal abuse and aggression, indecent gestures and obscene behavior.
- 4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging,
- 5. Notwithstanding anything in Clause (4) above, the Proctor may also suomoto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/ she may so advise the Vice- Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrences of ragging incidents described in Clause 3(a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a College, departmental examination for one or more year or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.

- 11. In case any students who have obtained degrees or diplomas of Delhi University are found guilty; under this Ordinance, appropriate action under Statute 15 for withdrawal of degrees or diploma conferred by the University will be taken.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice incitement of ragging will also amount to ragging.
- 13. All Institutions within the Delhi University system shall be obligated to carry out instructions/ directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.
- **Note:** Order of the Vice-Chancellor in pursuance of Ordinance XV-C : Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order, Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi, Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.

#### **ORDINANCE VIII-E**\*

#### Internal Assessment

- (1) (i) The scheme for Internal Assessment shall be followed in the regular stream only, with exclusions as per the Appendix to the Ordinance, and shall be applicable to the students admitted from the academic session 2003-04 onwards (i.e. to begin with for the first year students) in both undergraduate and postgraduate degree courses. This scheme of Internal Assessment shall not be applicable to the School of Correspondence Course and Continuing Education, Non-Collegiate Women's Education Board and Non-Formal Education Cell (formerly External Candidates Cell). The specific Ordinances pertaining to schemes of examinations of various courses shall stand amended, mutatis mutandis, to the extent of internal assessment as laid down in this Ordinance, subject to exclusions referred to above.
- (ii) Internal Assessment marks shall be shown separately in the Marks Sheet issued by the University and these marks shall be added to the annual/ semester examination marks for determining the division of the student.
- (2) 25% of the maximum marks in each paper in undergraduate courses shall be assigned for Internal Assessment and the remaining 75% marks for the annual/semester University Examination; the time duration and other modalities of the annual/semester Examination with respect to this 75% component shall remain as per existing schemes of examination for various undergraduate courses.
- (i) (a) For the Semester Examination Scheme, there shall be 10% weightage assigned to Class Test (s) Quiz (s) to be conducted by each College, for all subjects in B.A., B.Com. and B.Sc. courses and all papers of the Main Subject in Honours courses.
- (c) The University reserves the right to scrutinize some or all the scripts of any paper in any course in a College during the period of retention of papers, Which duration shall be till declaration of results by the University, a copy of the question paper shall be sent to the Examination Branch of the University and the College shall maintain a proper record of the question papers of the House Examination.
- (ii) (a) Each student shall be assessed on the basis of written assignments/tutorials as well as on the basis of project reports/term papers/seminars. There shall be 10% weightage for such written assignment; and project reports / presentations/term papers/seminars. Each student shall be given at least one written assignment per paper in each term, subject to a maximum of 12 written assignments per year for all the papers taken together.
- (b) Where the maximum marks in a paper are less than 100, for example50 marks, the nature of written assignments/ tutorial work shall stand adjusted pari passu.

(iii) There shall be 5% weightage for regularity in attending lectures (including interactive periods) and tutorials, and the credit for regularity in each paper, based on attendance, shall be as follows :
More than 67% but less than 70% - 1 mark 75% or more but less than 80% - 3 marks
80% or more but less than 85% - 4 marks

85% and above - 5 marks

[Medical certificates shall be excluded while calculating credit towards marks to be awarded for regularity, though such certificates shall continue to be taken into account for the purpose of calculating eligibility to appear for examinations as per the existing provisions of Ordinance VII.2.9.(a) (ii).]

(iv) There shall be a Moderation Committee for Internal Assessment in each College, discipline-wise, which shall comprise of the senior most teacher in the department, the teacher-in-charge of the department and the previous teacher-in-charge of the department: provided that if, for any reason, the membership of the Committee falls below 3, the Principal of the College shall nominate suitable members from among the teachers of that department/ College to fill the vacancies.

Ragging is strictly prohibited in College

- (3) With the introduction of Internal Assessment, the maximum marks for the University Examination in each paper shall stand reduced accordingly.
- (4) The promotion crieteria shall be as per the existing Ordinances for University Examinations, as applicable to respective courses. In addition, the same criteria shall apply to the total of the University Examination and the Internal Assessment, taken together.
- (5) (i) There shall be a Monitoring Committee for Internal Assessment at the University level consisting of the Dean of Colleges as the Chairperson along with three other Deans one of whom shall be a member of the Executive Council, and the Controller of Examinations as Member-Secretary. The Committee shall monitor the receipt of Internal Assessment marks from various colleges and ensure timely compliance. If a College fails to submit the Internal Assessment marks in time, the University shall not declare the result for such a course in that College. The responsibility for non- declaration of the result of any course in the College in such circumstances will be solely that of the College.
- (ii) There shall be a Monitoring Committee for Internal Assessment in every College, which shall be chaired by the Principal of the College and will be made up of the Vice-Principal (and in case there is no Vice-Principal, the Bursar), Secretary Staff Council, and two senior faculty members to be nominated by the Principal. This Committee shall be responsible for the entire process of Internal Assessment in the College, including redressal of grievances, if any.
- (6) (i) In the case of students who repeat one or more paper(s), or all papers of any part or semester, the Internal Assessment marks shall be carried forward.
- (ii) In the following special cases, in lieu of Internal Assessment, students shall be awarded marks (for the previous years. papers) in the same proportion as the marks obtained in that paper in the University Examination:
- (a) Students who migrate from other Universities to the University of Delhi in the 2nd Year/Third Semester.
- (b) Students who fail in the Part I Examination of Honours Courses and join Pass/General Courses in the 2nd year; and
- (c) Students who transfer from 1st year Pass/General Courses to Honours Courses in the second year.
- (iii) Students who migrate from non-formal streams in the University of Delhi (i.e. School of Correspondence Courses and Continuing Education, Non Collegiate Women's Education Board and Non-Formal Education Cell, formerly External Candidates Cell) to the Regular stream and vice versa, shall carry as such the marks obtained in the preceding year(s).
- (7) Tutorials shall be held regularly for the post-graduate courses of the University by the concerned Department in cooperation with Colleges; and atleast25% marks shall be assigned for Internal Assessment in each paper of the post-graduate courses. The Internal Assessment in the post graduate courses may be based on regularity and attendance; class tests and house examination; and written assignments, projects/term papers/ seminars/ fieldwork. Post-graduate courses where the weightage of Internal Assessment is 25 per cent or more, Departments may continue with the existing schemes.
- (8) In the case of a student who is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defence work and allied duties, or in the case of a student who is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Head of the institution concerned, or a student who is selected to participate in sports or other activities organized by the Inter-University Board or in national or international fixtures in games and sports approved by the Vice-Chancellor, or a student who is required to represent the University at the Inter-University Youth Festival, or a student who is required to participate in periodical training in the Territorial Army, or a student who is deputed by the College to take part in Inter-College sports, fixtures, debates, seminars, symposia or social work projects, or a student who is required to represent the College concerned in debates and other extracurricular activities held in other Universities or such other activities approved by the Vice-Chancellor, the following provision will apply:
- (i) A student in the categories listed above, will have to fulfil the requirement of written assignments and projects/ term papers / seminars / field-work with the fiexibility, however, that he/she may, if necessary, be allowed additional time for submission of written assignments.
- (ii) A student in the categories listed above, who is unable to write the House Examination/Class Test (s) / Quiz(s) on account of his/her participation in such aforesaid activities, may be assessed by the College through an alternative mode. This may be done only in exceptional circumstances.

- (iii) A student in the categories listed above, will get the benefit of attendance for Internal Assessment for the classes missed as per the existing provisions of Ordinance VII.2.(9)(a)(i).
- (9) (i) The University reserves the right to review, and if necessary moderate the marks in Internal Assessment in any paper/ papers in any College/ Department.
- (ii) The respective University Moderation Committees in each subject shall moderate, if necessary, the Internal Assessment marks across Colleges.

## THE RELEVANT PROVISIONS OF ORDINANCE IX OF UNIVERSITY OF DELHI VIDE NOTIFICATION NO. CNC II/093/2017-18/49 DATED 8TH MAY,2017 REGARDING CLASSIFICATION OF RESULTS ARE AS FOLLOWS:

#### Passing and Promotion Rules for all the Under-Graduate Courses under Choice Based Credit System (CBCS)

**shall be as under :** (i) A student who appears in an odd semester examinations or who was eligible to appear in the odd semester examinations but remains absent in any or all the papers of the said semester, shall move on to the next even semester irrespective of his/her result in the said examinations.

(ii) **Passing Rules :** The results shall be prepared on the basis of the formula prescribed at Table 'A' with the computation of grade cut off.

(iii) **Promotion Rules :** A student shall be eligible for promotion from  $1^{st}$  year to  $2^{nd}$  year/III semester provided he/she has passed 50% papers of I and II semester taken together and similarly for promotion from  $2^{nd}$  year to  $3^{rd}$  year/V semester.

(iv) The students shall be declared fail as per the formula prescribed at Table 'A'. However, they shall have the option to retain the marks in the paper in which they want to retain.

(v) Eligibility for award of degree : A student shall be declared eligible for degree provided he/she passed all the papers of 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year of a course.

(vi) A student who wants to reappear for improvement of marks in a paper prescribed for SemI/III/V may do so only in the semester examinations to be held in November-December. A student who wants to re-appear for improvement in a paper prescribed in semester II/IV/VI may do so only in the examinations to be held in May/June.

#### Reappearance for Improvement

i. A student may re-appear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (e.g., a student re-appearing in paper prescribed for Semester I examination may do so along with subsequent semester III examination and not along with papers for semester V).

- ii. A student who has cleared examinations of third academic year (V and VI semester) may reappear in any paper of V or VI semester only once, at the immediate subsequent examinations on foregoing in writing her/his previous performance in the paper/s concerned, within the prescribed span period. (Note: the candidate of this category will not be allowed to join any post graduate courses)
- iii. In the case of reappearance in paper, the result will be prepared on the basis of candidate's current
- 111. In the case of reappearance in paper, the result will be prepared on the basis of candidate's current performance in the examinations.
- iv. In the case of a candidate, who opts to reappear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to reappear shall be taken into account while determining her/his result of the examinations held currently.
- v. Re-appearance in practical/internal assessment shall not be allowed.
- vi. All papers of Core, Elective, AECC and SEC shall be for 100 marks each and 25 marks shall be for internal assessment.
- vii. Examination for practical wherever applicable shall be based on continuous evaluation.
- viii. Duration of end semester theory examinations of core and elective subjects shall be three hours.
- ix. There shall be no internal assessment in practical papers.
- x. There shall be no supplementary examinations.

#### Letter grades and grade points

The results for the all the Undergraduate courses under the CBCS shall be based on a 10 point grading system with Letter Grades as per the formula as at **Table 'A'** below:

**Issue of Transcripts:** Based on the grades earned, a Grade Certificate shall be issued to all the registered students by the University after every semester and a consolidated transcript indicating the performance in all semesters. The Grade Certificate will display the course details (code, title of the paper, number of credits, grade secured)along with SGPA of each semester and CGPA earned based on overall six semesters.
