




1. Name of the Society: The name of the society shall be "Deen Dayal Upadhyaya College Alumni Association".


3. AIMS & OBJECTIVES


- 3.1 To promote and foster mutually beneficial interaction between the Alumni and the present students of the institute and between the Alumni themselves.

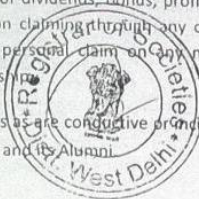
To publish books on educational, cultural & social subjects, organize discussions & seminars to impart knowledge & understanding amongst the people.
